Roll Call

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, January 25, 2010 at 6:06 p.m. President Mark GiaQuinta called the meeting to order with the Pledge of Allegiance led by members of the Kekionga Steel Drumz band. Kekionga Steel Drumz Band President GiaQuinta invited Kekionga Band Teacher Mike Horan to speak with Board members about the Kekionga Steel Drumz Band. Mr. Horan shared information about the release of the band's first CD and a fundraiser dinner and concert at Kekionga on Saturday, February 6.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Four Star School Award **RECOMMENDATION**: It is recommended that the Board recognize Croninger and Irwin Elementary Schools students and staff for receiving the state Four Star School award.

RELATED INFORMATION: Croninger and Irwin Elementary Schools were part of an elite group of schools receiving the state's Four Star School award for 2008-09. This award is the highest state distinction and is based on student achievement on ISTEP+ assessments and overall attendance rates. Only ten percent of all eligible public schools in the state received this award. This is the fourth consecutive year Croninger has earned the designation and the second year for Irwin. To be designated as a Four Star School, a school must be fully accredited, meet Adequate Yearly Progress (AYP) for 2008 and perform in the top 25 percent of all the schools in each of the following four areas:

- student attendance rates.
- mathematics proficiency scores,
- English/language arts proficiency scores and
- the percent of students passing both English/language arts and mathematics.

At Croninger, the teachers and staff make it their mission each day to reach every child's individual learning needs. This is an ongoing process and a collaborative team effort that produces high quality results. Teachers work very hard and in close cooperation with parents who support the school. At Irwin, staff members looked at their own data, and helped the students understand the data so they could take responsibility for their own success. They work closely with parents and students to make sure they know where they stand and where they need to go to be successful.

National Staff Development Council Exemplary Model School

RECOMMENDATION: It is recommended that the Board recognize the staff at Study Elementary School for being named an Exemplary Model School by the National Staff Development Council.

RELATED INFORMATION: Study Elementary was highlighted at the National Staff Development Council's (NSDC) Annual Conference in St. Louis, Missouri as an Exemplary Model School for using collaborative professional learning to facilitate cultural change, resulting in increased student academic achievement. Study Elementary is also featured in the NSDC video, "Building a Case for Collaborative Professional Learning" which was shown at the conference's opening general session as an exemplar in meeting the goals set forth by the National Staff Development Council. As an urban Title I school of diversity, Study is noted for facilitating academic growth within all diverse groups.

Study was selected as a model for successfully using embedded professional development to make positive change which fulfills the NSDC mission of, "Ensuring effective embedded professional development, every day, for every teaching professional to increase every student's achievement."

The principal and staff of Study Elementary School are committed to "doing what ever it takes" to increase student achievement. This includes the creating of meaningful partnerships with all families and numerous community organizations.

2010 American Football Hall of Fame

RECOMMENDATION: It is recommended that the Board recognize the Assistant Principal at Northrop High School for being inducted into the 2010 American Football Hall of Fame.

RELATED INFORMATION: Northrop High School Assistant Principal Dan Nolan was inducted into the American Football Hall of Fame in its inaugural ceremony honoring a "League of Extraordinary People" from all levels of American football earlier this month. Mr. Nolan was the only honoree in the college player category. His name had been submitted by coaches from the Fort Wayne area, and winners were chosen by an American Football committee. He is a graduate of South Side High School, where he was named an All-State football player, was a member of the 1967 state basketball finalist team and later was inducted into the South Side Athletic Hall of Fame. He went on to

play football and basketball at Butler University, where he graduated in 1972 and later was named to its football and basketball Halls of Fame. After playing semi-professional ball with the Indianapolis Caps, Mr. Nolan returned to Fort Wayne and coached football at South Side for 23 years. While coaching at South Side, he organized the Youth Metro Football League and served as its Commissioner for two seasons. As Assistant Principal at Northrop, Mr. Nolan continues to assist student athletes in furthering their playing career at the collegiate level.

RELATED INFORMATION: The current school site is significantly below the state minimum acreage recommendation. Funds are within budget. Dr. Robinson presented the following recommendation concerning the Project SEED:

Project SEED

RECOMMENDATION: It is recommended that the Board approve a partnership with Project SEED for 2009-2012 for the amount of \$316,500.

RELATED INFORMATION: Project SEED is a nationally recognized program whose goal is to improve student motivation and confidence while preparing students for success in advanced math classes.

Project SEED will provide:

- A staff of mathematicians, scientists, and engineers specially trained to teach advanced mathematics in elementary classrooms;
- Three years of classroom-based professional development strategies that promote student involvement and achievement; and
- Intensive training for 18 key teachers in elementary classrooms and introductory training for up to 600 teachers.

This program will be funded through the American Recovery & Reinvestment Act Title I stimulus funds.

Northrop 2010 Field Trip to Germany

Dr. Robinson presented the following recommendation concerning the Northrop 2010 Field Trip to Germany:

RECOMMENDATION: It is recommended that the Board approve the field trip proposal for Northrop High School students to visit our sister-city Gera, Germany in June, 2010.

RELATED INFORMATION: Northrop High School has enjoyed a sister-school relationship with the Goethe Gymnasium in the sister-city of Fort Wayne, Gera Germany for 18 years. In June 2010, 8-15 German language students would like to reciprocate the latest visit from Gera students. They would be accompanied by their German teacher, Mr. Kris Kallmeyer, a veteran of six previous exchanges, and several chaperoning parents.

Plans are to leave Indiana following graduation and return three weeks later. During the trip, students will stay in Gera with host families of students attending the Goethe Gymnasium. While there, students will attend classes and make excursions to Dresden, Eisennach, Leipzig, Weimar, and Buchenwald. There will be two overnight excursions to Frankfurt and Berlin.

The opportunity to participate will be extended to all non-freshmen students of German with strong preference given to those who will have completed two years of German by the departure date and have maintained a "B" average.

Kris Kallmeyer is responsible for the planning of this field trip. Barbara Ahlersmeyer is the principal.
