Approval of Minutes – January 12, 2004

2003 Transfer of Appropriations Dr. Robinson presented the following recommendation concerning the 2003 Transfer of Appropriations:

RECOMMENDATION: It is recommended that the 2003 General Fund, Racial Balance Fund, Preschool Fund, and Capital Projects Fund budgeted appropriations be revised as indicated on the attached listing.

RELATED INFORMATION: At the Board meeting on December 8, 2003, the administration was granted authority to transfer and adjust appropriations as deemed necessary prior to the close of business for December. The administration is now requesting that the Board ratify the necessary transfers and adjustments of appropriations.

At the beginning of each year, the school corporation receives a budget order from the State Board of Tax Commissioners that sets the appropriations for each major spending classification. During the course of administering the budget, expenditures are charged to designated expenditure accounts as recommended by the State Board of Accounts. At the close of each year, it has been customary to recommend transfers of appropriations between major programs. Authority for the Board to transfer appropriations is contained in Indiana Code 6-1.1-18-6.

Transferring appropriations allows the administration to adjust appropriations in response to unanticipated needs and/or changing priorities while staying within the constraints of the overall budget.

A motion was made by Jon J. Olinger, seconded by Geoff Paddock, that the recommendation concerning the 2003 Transfer of Appropriations be approved. Roll Call: Ayes, unanimous; nays, none.

Vendor Selection for 401(a) and VEBA Dr. Robinson presented the following recommendation concerning the Vendor Selection for 401(a) and VEBA:

RECOMMENDATION: It is recommended that the Board approve AIG VALIC as the vendor to receive the retirement severance buyout amounts for eligible non-teacher employees. It is also recommended that the Board authorize AIG VALIC to be an approved 403(b) Tax-Deferred annuity carrier for non-teacher employees.

RELATED INFORMATION: The board approved a \$40,000,000 bond issue at the December 8, 2003 board meeting that allows FWCS to comply with the provision of Public Law 199. The law requires school districts to actuarially fund their retirement severance benefit obligations and provided the ability to bond this obligation. Bond proceeds will be deposited into employee 401(a) and/or VEBA accounts as allowed by IRS provisions.

Requests for proposals were sent to thirteen vendors with seven responding. With the assistance of our consultant, Educational Services Company, we selected three vendors to provide additional information in a presentation. AIG VALIC provides excellent experience in enrolling and managing this type of accounts and will have the largest ongoing permanent staff in Fort Wayne to provide future service. They also provided competitive fees and multiple fund choices.

A motion was made by Kurt A. Walborn, seconded by Jon J. Olinger, that the recommendation concerning the Vendor Selection for 401(a) and VEBA be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Allen County Regional Network:

Allen County Regional Network

RECOMMENDATION: It is recommended that the Board approve Fort Wayne Community Schools entering into a 3-year contract with the Indiana Telecommunications Network (ITN) for intra-county data communication and additional broadband Internet services.

RELATED INFORMATION: For the past three years, the Invent Tomorrow consortium, representing the public Allen County school systems, the Catholic schools, the Allen County Public Libraries, the City of Fort Wayne, and Indiana/Purdue at Fort Wayne (IPFW), has developed requirements and solicited requests for proposals (RFP) for developing a broadband network linking all the representatives for data communication and Internet services. The state of Indiana's Telecommunications Network commission successfully proposed building a network that would provide 100 megabit bandwidth for data communications between the represented entities and 90 megabit aggregated Internet service. The monthly cost for this service is \$3,500; however, after Universal Service Fund discounts and State grants, the monthly cost is reduced to \$500 for the first two years and \$1,225 for the third year. There will be a one-time installation cost of \$2,200. All charges will be paid with Capital Project Fund monies.

This network will allow opportunities for shared professional development, advanced placement classes, and other distance learning opportunities for both FWCS students and staff. The additional Internet service will position FWCS to take full advantage of their own broadband network with Comcast by allowing more Internet traffic.

This recommendation supports Strategy X: Community Linkages.

A motion was made by Geoff Paddock, seconded by Kurt A. Walborn, that the recommendation concerning the Allen County Regional Network be approved. Roll Call: Ayes, unanimous; nays, none.

Comcast Broadband

Dr. Robinson presented the following recommendation concerning the Comcast Broadband:

RECOMMENDATION: It is recommended that the Board accept an addendum to the contract with Comcast Cablevision of Fort Wayne - Limited Partnership for broadband Internet and data communication services.

RELATED INFORMATION: On February 10, 2003, the Board approved a contract with Comcast to build a fiber optic network linking 31 FWCS schools to the Grile Administration Center for the purposes of Internet and data communications. The 31 schools initially chosen are the schools that receive a 90% Universal Service Fund (USF) discount. This addendum will connect the remaining schools and administrative buildings with fiber optics.

The Comcast network will continue to provide all schools a 1 gigabit connection for \$375 per month per building. The initial one-time construction cost for the remaining buildings is \$395,000. Both the monthly and one-time charges will be subject to our corporation-wide USF discount of 72%. The initial \$395,000 will be paid in full with Common School Fund monies. All monthly reoccurring charges will be paid with Capital Project Fund monies.

This recommendation supports Strategic Plan IX: Technology to Transform Learning and Operations.

A motion was made by Jon J. Olinger, seconded by Kurt A. Walborn, that the recommendation concerning the Comcast Broadband be approved. Roll Call: Ayes, unanimous; nays, none.

RELATED INFORMATION: On Thursday, January 22, 2004, Fort Wayne Community Schools and Fort Wayne Nurses' Association reached a tentative agreement on a three-year contract. The 2000-2003 agreement expired on December 31, 2003. The most significant changes for the 2004-2006 contract are as follows:
