In addition to individualizing academic work to suit diverse learning styles, this second-grade teacher can be found organizing the Book Room, engaging colleagues in creating an inventory of the room, and tutoring third graders to help them prepare for the ISTEP+ exam. 2002 Transfer  
of  
Appropriations

Dr. Fowler-Finn presented the following recommendation concerning the 2002 Transfer of Appropriations:

**RECOMMENDATION:** It is recommended that the 2002 General Fund, Racial Balance Fund, Debt Service Fund, and Preschool Fund budgeted appropriations be revised.

**RELATED INFORMATION:** At the Board meeting on December 9, 2002, the administration was granted authority to transfer and adjust appropriations as deemed necessary prior to the close of business for December. The administration is now requesting that the Board ratify the necessary transfers and adjustments of appropriations.

At the beginning of each year, the school corporation receives a budget order from the State Board of Tax Commissioners that sets the appropriations for each major spending classification. During the course of administering the budget, expenditures are charged to designated expenditure accounts as recommended by the State Board of Accounts. At the close of each year, it has been customary to recommend transfers of appropriations between major programs. Authority for the Board to transfer appropriations is contained in Indiana Code 6-1.1-18-6.

Transferring appropriations allows the administration to adjust appropriations in response to unanticipated needs and/or changing priorities while staying within the constraints of the overall budget.

**RELATED INFORMATION:** One of the tasks of each Board member is to recommend an appointment to the FWCS Scholarship Committee. The FWCS Scholarship was established by the Fort Wayne Community Schools Board of Trustees on September 24, 1984. Each spring since 1987, scholarships have been awarded to FWCS students. Gifts range from \$500 to \$1,500, most of which may be renewed for three years as long as the student is in good standing at a four-year college or university.

There are seven members of the scholarship committee and one permanent chairman, Judge William Lee. Each is appointed by a Board member and has a term which coincides with the term of that Board member. Members of the Scholarship Committee, assisted by FWCS staff, administer the awarding of these scholarships. They review all applications, interview candidates, and make final recommendations.

Grant

Dr. Fowler-Finn presented the following recommendation concerning the Stewart B. McKinney Homeless Assistance Grant:

**RECOMMENDATION:** It is recommended that the Board approve the application for and acceptance of a grant for funds through the McKinney - Vento Act Indiana Department of Education. These funds will be used to support the Fort Wayne Community Schools Homeless Assistance Program.

**RELATED INFORMATION:** Federal funding through the McKinney-Vento Act is one component of a program which would enable Fort Wayne Community Schools to provide assistance to students residing in shelters to continue their education. During the 2001-2002 school year approximately 349 students were assisted through the program from 11 shelters and facilities in the community.

The funds are distributed as grants by the Indiana Department of Education for local education agencies to establish educational programs which promote the identification, enrollment, attendance, and success of homeless children and youth in school and preschool. The request of \$30,000 will be used to provide tutorial, remediation, instructional materials and supplies, and other related services to Fort Wayne Community Schools homeless children and their families.

This competitive grant was prepared by Jerry White, director of Student Services. It addresses advancement intended and outlined in Strategy I, Personally Appropriate Education, and Strategy VI, Meaningful Relationships with Families.

**RELATED INFORMATION:** The objective of this grant request is to purchase a SMART Board and concept-mapping software that would provide the students with an interactive simulation using the Indiana Academic Standards in language arts, social studies, and math. The contacts for this competitive grant are Irwin teachers, Portia Coe and Kim Grant.
