Cooperation of the Fort Wayne-Allen County Department of Health, Parkview Health and FWCS Nurses **RECOMMENDATION**: It is recommended that the Board recognize the Fort Wayne-Allen County Department of Health and Parkview Health, their leadership and staff and the FWCS nursing staff, for working to ensure a quick and calm response to a recent bacterial meningitis case at St. Joseph Central Elementary School.

RELATED INFORMATION: In December 2015, The Fort Wayne-Allen County Department of Health and Parkview Health acted quickly in getting needed, prophylactic antibiotics to the St. Joseph Central Elementary School community after a case of bacterial meningitis was discovered. Through their quick actions and collaboration with the State Department of Health and Centers for Disease Control and Prevention the two groups helped stave off the potential spread of the meningitis, as well as a possible city-wide panic to the situation.

The Parkview pharmacy team, led by Director Chris Jellison, organized a strategy to provide the medication to more than 400 students and about 100 adults. Carmen Moore of Community Nursing mobilized her team to work with FWCS nurses in an effort to get accurate weight measurements of students needed to insure proper dosage and administration of the medication.

Year End Appropriations Adjustments Dr. Robinson presented the following recommendation concerning the Year End Appropriations Adjustments:

RECOMMENDATION: It is recommended that the Board authorize the necessary transfers to cancel any existing negative balances at the end of 2015. It is also recommended that the Board rescind the resolution approved on December 14, 2015 to reduce the 2015 Capital Projects Fund budget.

RELATED INFORMATION: The first part of the recommendation is made because there are certain appropriations that will have negative balances while others will have positive balances at the end of 2015. Negative appropriation balances cannot exist at the end of a budget year, so transfers between appropriations are necessary.

The second part of the recommendation is made because the December adjustment would have negatively impacted the 2016 allowed levy in the Capital Projects Fund. The adjustment will be made during the 2017 budget process instead.
