**RELATED INFORMATION**: This bid is for a supply of copy paper to be placed in the warehouse. The largest portion of the bid is for 9680 cases of 8.5" x 11" white paper. All schools and central administrative units are served by this supply.

Utilizing our Internet bidding system, 83 prospective bidders were notified of the bid for Xerographic Paper. A list is on file in the purchasing department. Invitations to Bid were requested by thirteen prospective bidders with six responding with a bid.

The prices of the recommended bidder reflect an eight percent decrease when compared to the last bid opened in February 2003.

Main Network Switches for Schools Dr. Robinson presented the following recommendation concerning the Main Network Switches for Schools:

**RECOMMENDATION**: It is recommended that the Board approve purchasing CISCO 3550 Network Switches from IBM for the amount of \$99,854.56.

**RELATED INFORMATION**: This purchase will finish replacing the main network switch at the schools in Phase 1 of the Comcast Broadband Network. Due to the high bandwidth capabilities of the Comcast Network, the current switches need replaced since they cannot process the communication traffic at sufficient speeds. These switches serve as the main entry point and communication distribution device for our schools' local area networks (LAN). FWCS already possesses 15 of these switches and needs 16 more to complete Phase 1.

The switches will be purchased with Common School Fund (CSF) monies and was a part of the budget developed for these funds. According to Indiana law FWCS is not required to bid the switches because we are able to purchase through Indiana's Quantity Purchasing Agreement (QPA) with IBM.

This recommendation supports Strategic Plan IX: Technology to Transform Learning and Operations.

A motion was made by Geoff Paddock, seconded by Kurt A. Walborn, that the recommendation concerning the Main Network Switches for Schools be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Naming of the North Side Gymnasium:

Naming of the North Side Gymnasium

**RECOMMENDATION**: It is recommended that the Board approve naming the new gymnasium at North Side High School as the By Hey Arena.

**RELATED INFORMATION**: North Side staff and students are requesting the naming of the new gymnasium in honor of By Hey. By Hey was a basketball coach and teacher for FWCS for 30 years, 29 of those years were at North Side. Coach Hey had a very successful coaching career at North Side, with his teams having won ten sectional championships, one semi-state championship, and his 1965 team became State runner-up. His school career varsity record was 457-280.

Coach By Hey's career was given the highest honor in 1997 when he was elected to the Basketball Hall of Fame in Indiana. Because of his outstanding accomplishments, his dedication, and his loyalty to the students and the North Side community, it is most fitting to request that the new gymnasium at North Side High School be named By Hey Arena.

A motion was made by Jon J. Olinger, seconded by Geoff Paddock, that the recommendation concerning the Naming of the North Side Gymnasium be approved. Roll Call: Ayes, unanimous; nays, none.

Beth E. Jacobs Scholarship Donation Dr. Robinson presented the following recommendation concerning the Beth E. Jacobs Scholarship Donation:

**RECOMMENDATION**: It is recommended that the Board approve the acceptance of a \$2,000 gift from the estate of Beth E. Jacobs. The gift will create a scholarship fund for the benefit of North Side students.

**RELATED INFORMATION**: Mrs. Jacobs passed away on August 12, 2003 at the age of 79. She was a member of the North Side High School class of 1941. It was Mrs. Jacobs's preference that the gift be used to benefit students at North Side. The Fort Wayne Community Schools scholarship committee chaired by Judge William Lee will administer the scholarship.

Jim Emmerson, principal, is the contact person for this competitive grant. This program supports advancement intended and outlined in Strategy VII, Student-Centered Environment.
