2008 Summer Programs Dr. Lindquist presented the following recommendation concerning the 2008 Summer Programs :

RECOMMENDATION: It is recommended that the School Board approve the 2008 Summer Programs, including dates and fees.

RELATED INFORMATION: In addition to the summer programs provided through Anthis Career Center, special education, and grants, FWCS is adding a research-based summer reading program targeted to students reading below grade level at critical times during their educational programs. This new program is called Extended Learning because it extends the school year and builds upon reading instruction provided during the school year. Students in grades 2, 3, and 6 are being identified for participation through district reading assessments. This addition supports the district's focus on closing the achievement gap by ensuring that all students read at grade level.

Speakers

Mr. Gerald Arthur, principal of Lindley Elementary School spoke to Board members about the Spanish Immersion Program at Lindley. The school is considered to be a leader in the state for their efforts to increase the number of students from all backgrounds who are fluent and literate in two or more languages.

Mr. Brian Lytle, representing the Teamsters, spoke to the Board about a driver resigning because of not having medical insurance. Mr. Lytle also said that his bus drivers have reported issues concerning the use of Special Purpose Vehicles (SPV) by school personnel, including overloading the vehicle and curbside pick-up.

Comments

Jon J. Olinger commented on the Choice Fair that was held on Sunday, February 10, at Northrop High School. The event was well attended even with the cold winter weather.

Carol J. Coen commented on the district wide fund raiser that FWCS is holding for Riley Hospital for Children in Indianapolis. Many Fort Wayne children use the facility in Indianapolis. If we collect one dollar per student, the district would become a Riley Miracle Corporation.

Kevin Brown, Carol J. Coen and Stephen Corona shared experiences from their trip to Washington, D.C. for the National School Boards Association, Federal Relations Network Conference in early February. There was much conversation about the reauthorization of NCLB legislation. They were able to visit with the staff of Senators' Lugar and Souder and share specifics of Fort Wayne Community Schools concerns.

Mark GiaQuinta commented about the number of students who return to Fort Wayne Community Schools from the Imagine Charter School because we are able to provide the services they need. However, the money which comes from the State does not follow the student.
