National Ready Mixed Concrete Association National Essay Contest Winner **RECOMMENDATION**: It is recommended that the Board recognize the Anthis Career Center and North Side High School student who won the National Ready Mixed Concrete Association National Essay Contest.

RELATED INFORMATION: The National Ready Mixed Concrete Association offers an annual National High School Essay Contest for students between the ages of 16-18. The purpose of this contest is to increase awareness of the ready mixed concrete industry while looking to develop the next generation of industry leaders. The entries are judged by industry executives and college and university faculty members with concrete-related backgrounds based on content and writing ability. Anthis Career Center and North Side High School student Charles Jewell first won the Indiana state competition and was awarded a \$1,000 scholarship. His essay was then judged against other state winners, and he was named the national winner of this competition. He won an additional \$5,000 scholarship and a trip to the National Ready Mixed Concrete Association's Annual Convention in March in Las Vegas.
