Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Future City Competition **RECOMMENDATION**: It is recommended that the Board recognize the students from Blackhawk Middle School and Jefferson Middle School for the awards they won at the regional Future City Competitions in January.

**RELATED INFORMATION**: The Future City Competition is an educational program for middle school students sponsored by the National Engineer's Association. It combines an engineering challenge with a hands-on application to present the team's vision of a future city. The 2015-16 theme, "Waste Not, Want Not," asked students to design an innovative citywide solid waste management system for their future city that is safe, environmentally sound, and energy efficient.

This is Blackhawk's 15<sup>th</sup> year of participating in the competition. Blackhawk's 6<sup>th</sup> grade team *Stadt der Zukunft* took 3rd place in the state (regional) competition and received a National special award for the "Most Sustainable Food Production System."

Blackhawk's 7<sup>th</sup> grade team *Catopia* took 7th place in the state (regional) competition and received an award for "The Most Innovative Use of Aggregates."

In its first year of participation in the competition, the Jefferson Middle School team *Quinausovin* took fourth place in the state (regional) competition.

Easement and Rightof-Way at Lakeside Middle School Dr. Robinson presented the following recommendation concerning the Easement and Right-of-Way at Lakeside Middle School:

**RECOMMENDATION**: It is recommended that the Board approve the sale of an easement and right-of-way at Lakeside Middle School to Verizon Wireless. It is further recommended that the Superintendent or her designee be authorized to sign the appropriate documents and take necessary steps to complete this transfer and to grant Verizon Wireless the temporary license to enter the property for the purpose of installing, utilizing, maintaining, replacing and removing pipes, conduits and other necessary appurtenances for electric, telephone, fiber and other requisite utility service in and under the easement area.

**RELATED INFORMATION**: The purpose of the acquisition is to accommodate electric, telephone, fiber and other requisite utilities. The additional easement and right-of-way consists of a .26 acre parcel approximately 1,130 feet long and 10 feet wide. The easement is on the east end of the Lakeside Middle School site. Verizon Wireless will be running utilities to its shelter location within the easement area. Verizon Wireless has offered to pay \$3,000, which is above fair market value for the easement.

Property Resolution – Nuckols Park Dr. Robinson presented the following recommendation concerning the Property Resolution – Nuckols Park:

**RECOMMENDATION**: It is recommended the Board approve the transfer of a narrow strip of property to the City of Fort Wayne Board of Park Commissioners. Such conveyance needs to be approved by resolution by both parties.

**RELATED INFORMATION**: The City of Fort Wayne directed us to this situation involving Nuckols Park, a public park east of downtown, lying south of Maumee Avenue and north of East Jefferson Boulevard. The long, narrow parcel forms the east point of Nuckols Park where Maumee Avenue and East Jefferson intersect and contains a park sidewalk and landscaping. The subject parcel is not adjacent to any current FWCS facility, nor does it serve a useful purpose to FWCS. Given that park improvements are located on the parcel, it should be owned by the Park Board. The parcel consists of only 5,052,96 square feet (0.116 acres). The parcel is shown as Exhibit A of the resolution.

#### RESOLUTION OF THE BOARD OF SCHOOL TRUSTEES OF THE FORT WAYNE COMMUNITY SCHOOLS

The Board of School Trustees of the Fort Wayne Community Schools met in regular session on February 22, 2016, and approved this Resolution for the matters stated below:

RESOLVED, that Fort Wayne Community Schools ("FWCS") owns a certain tract of real estate described as:

The south fractional lots 1 through 6 North of Jefferson Boulevard, Samuel Hanna Plat B Addition.

The parcel is also identified under Allen County's parcel identification number system as: PIN 02-12-01-380-002.000-074. The subject parcel is depicted by the broken line on the attached Exhibit "A" (the "Parcel").

RESOLVED FURTHER, that the Parcel lies adjacent to the area known as Nuckols Park, a public park owned and maintained by the City of Fort Wayne Board of Park Commissioners ("Park Board").

RESOLVED FURTHER, that the Parcel is not adjacent to a public school site maintained by FWCS.

RESOLVED FURTHER, that FWCS has no use for the Parcel in terms of providing support to any of the FWCS schools or operations.

RESOLVED FURTHER, that the Parcel is now being used for public park purposes, as a part of Nuckols Park.

RESOLVED FURTHER, that FWCS and the Park Board have agreed that the Park Board should be in title to the Parcel, not FWCS, in order to establish clear title and ownership of Nuckols Park by the Park Board.

RESOLVED FURTHER, that FWCS shall convey title to the Parcel to the Park Board by Quitclaim Deed.

RESOLVED FURTHER, that the Park Board shall adopt a substantially identical resolution to this Resolution, accepting the conveyance of the Parcel.

A motion was made by Becky Hill, seconded by Julie Hollingsworth, that the recommendation concerning the Property Resolution – Nuckols Park be approved. Roll Call: Ayes, unanimous; nays, none.

Purchase of HP ProBook 650 G1 Laptops Dr. Robinson presented the following recommendation concerning the Purchase of HP ProBook 650 G1 Laptops:

**RECOMMENDATION**: It is recommended that the Board approve the purchase of 300 laptop computers from Hewlett Packard Direct of Omaha, NE for \$198,975. Additionally, preparation services will be purchased from ProSys of Norcross, GA for \$5,400.

**RELATED INFORMATION**: The purchase of these laptops will allow teachers to support instruction through the use of digital content. These laptops will replace existing teacher computers that are scheduled for replacement.

Pricing for this purchase is from Hewlett Packard's Quantity Purchase Agreement (QPA) with the State of Indiana. Indiana law does not require public bidding for purchases made from State QPA contracts.

Funding will come from the CSF (Common School Fund).

Technology Coordinator Valerie Biggs, will be available to answer questions.

A motion was made by Becky Hill, seconded by Julie Hollingsworth, that the recommendation concerning the Purchase of HP ProBook 650 G1 Laptops be approved. Roll Call: Ayes, unanimous; nays, none.

National Football League Grants Dr. Robinson presented the following recommendation concerning the National Football League Grants:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of \$5,000 grants from the National Football League Foundation for Snider and South Side High Schools.

**RELATED INFORMATION**: The NFL is recognizing schools that contributed to Super Bowl history and positively impacted the game of football. The *Super Bowl High School Honor Roll Initiative* is part of the nationwide kickoff to the Super Bowl 50 celebration.

High schools will receive a commemorative Wilson Golden Football for every player or head coach who graduated from their school and was on an active Super Bowl roster. The NFL Foundation will provide the schools with a new character education curriculum and the opportunity to apply for grants of up to \$5,000 to help support and grow their football programs.

South Side alumnus Bernard Pollard and Snider alumnus Rod Woodson both played in Super Bowl games and each school is eligible to apply for the grant. Grant money will be used to purchase items to support the football programs at South Side and Snider.

This noncompetitive grant supports District Goal II: Engage Parents and the Community.

Amendments and Restatement of Retirement Plans Documents Dr. Robinson presented the following recommendation concerning the Amendments and Restatement of Retirement Plans Documents:

**RECOMMENDATION**: It is recommended that the Board approve amendments to the Fort Wayne Community Schools 401(a) Plan Documents and Dr. Robinson's 403(b) Plan.

**RELATED INFORMATION**: Internal Revenue Service (IRS) regulations require retirement plan documents be updated periodically to incorporate law changes. Recent law changes incorporated in these amendments include:

- Pension Protection Act ("PPA")
- Final regulations under Internal Revenue Code Section 415
- Heroes Earnings Assistance and Relief Tax Act ("HEART")
- Worker, Retiree and Employer Recovery Act ("WRERA")
- Small Business Jobs Act ("JOBS")

To assist in the timely update of the Plan, VALIC and MetLife will each complete a restatement of our current documents on the VALIC and MetLife document which incorporates the law changes listed above. A restated prototype must be executed by April 30, 2016.

An amendment is needed for Dr. Robinson's 403(b) plan with VALIC for the purpose of complying with certain recent legislation. The amendment does not make any material design changes to the Plan, nor does the amendment create any new financial obligations of FWCS with regards to the Plan.

The Plan documents require approval by the employer's board of directors of any amendments; we, therefore, recommend Board approval of these amendments, as well as the attached Board resolution for future amendments.

#### RESOLUTION OF THE BOARD OF SCHOOL TRUSTEES OF THE FORT WAYNE COMMUNITY SCHOOLS

WHEREAS, the Board of Directors believes that formal Board approval should not be needed with respect to certain types of amendments to one or more of the retirement plans of FWCS, and

WHEREAS, the Board believes that certain types of amendments to one or more of the retirement plans of FWCS may be approved by the officers of FWCS, after consultation with legal counsel or other consultants.

NOW, THEREFORE, BE IT RESOLVED, that the officers of FWCS have the authority to approve and execute an amendment to one or more of the FWCS retirement plans, from time to time, without Board approval but after due consultation with the Plan's legal counsel and/or consultants, if the purpose of the amendment is (i) to adopt an amendment that is required by the IRS for the retirement plan to stay in compliance with various IRS requirements and/or (ii) to make a design change to the retirement plan where such design change does not result in a material change in the Plan's benefits where the cost of such change is borne by FWCS.

A motion was made by Jordan Lebamoff, seconded by Julie Hollingsworth, that the recommendation concerning the Amendments and Restatement of Retirement Plans Documents be approved. Roll Call: Ayes, unanimous; nays, none.

Ratification of Fort Wayne Classified Association and Fort Wayne Nurses Association Contract Dr. Robinson presented the following recommendation concerning the Ratification of Fort Wayne Classified Association and Fort Wayne Nurses Association Contract:

**RECOMMENDATION**: It is recommended that the Board ratify revisions to the collective bargaining agreement and approve a salary increase for active employees represented by Fort Wayne Classified Association and FWCS Nurses Association.

**RELATED INFORMATION**: Fort Wayne Classified Association and FWCS Nurses Association will receive

- A 1% salary increase for school years 2015-16 and 2016-17;
- Authorizing the Superintendent to determine stipends for school years 2014-15, 2015-16 and 2016-17; and
- Paternity/adoption day increase from 2 days to 5 days.
