**RELATED INFORMATION:** Each fall students from all over the state compete to be in the All-State Vocal Jazz Choir, with only 28 students being selected. This year two students from North Side High School were selected through an audition process of singing jazz selections and scat singing. The choir performed at the Indiana Music Educators Conference in Indianapolis in January with one North Side student featured as a soloist. **RECOMMENDATION:** It is recommended that the Board recognize South Side High School and Northrop High School students who were Portfolio Scholarship finalists and American Vision/American Voice Award nominees.

**RELATED INFORMATION:** The Scholastic Art and Writing Awards are given each year for outstanding achievements of young artists in visual arts and writing. This year 450 entries were chosen from 2,240 entries from 58 counties in northeast and central Indiana and western Ohio. Of these, 22 were named Portfolio Scholarship finalists, and 10 were American Vision/American Voice nominees. Portfolios of the Portfolio Scholarship finalists were forwarded to a national competition for scholarships ranging from \$1,000 to \$20,000. The American Vision/American Voice Award nominees were selected as the best of the Gold Key recipients and were forwarded to New York as nominees from the region. Each nominee received a cash award of \$50 from The News-Sentinel, and one nominee from the region will win \$100 at the national level.

Application

**RECOMMENDATION:** It is recommended that the Board approve the application for and acceptance of an advancement from the Indiana Common School Fund for educational technology equipment for 2009 in the amount of \$500,000.

**RELATED INFORMATION:** Advancements from the Common School Fund provide funds for school districts to purchase educational technology. The Fort Wayne Community Schools (FWCS) will use these moneys to help fund the FWCS technology plan previously submitted to the state. Technology funds are currently insufficient to fund all the technology needs of the school corporation.

Funds are provided as a loan and are awarded to school corporations on the basis of assessed value (AV) per pupil, with low AV per pupil school corporations receiving funds before high AV per pupil corporations. FWCS therefore cannot be assured of receiving the requested advancement.

Should the application be successful, funds will be budgeted in the Debt Service Fund to repay this loan beginning in the year 2010. Interest on the loan is expected to be no more than four percent and is likely to be as low as one percent.

Common School Fund advancements differ from School Technology Advancement Account (STAA) loans, which FWCS receives on an annual basis. Unlike CSF advancements, STAA advancements are given to all applying school corporations, regardless of their assessed value per pupil ranking.
