This competitive grant written by Carol Guse, supports advancement intended and outlined in the FWCS District Goals I: *Achieve and Maintain Academic Excellence* and Goal II: *Engage Parents and the Community*.

RESOLUTION EXPRESSING BOARD COMMITMENT TO VOLUNTARY REDUCTION OF MINORITY GROUP ISOLATION

WHEREAS, Fort Wayne Community Schools (FWCS), with roots dating back to 1857 and the largest school district in the state of Indiana, has as its moral purpose to educate all students to high standards;

WHEREAS, the core values of FWCS are:

- § Student achievement as the heart of our work.
- § Equity in educational opportunities.
- § The diversity and uniqueness of our district and community.
- § The accountability of school board, administration, employees, teaching professionals.
- S Open and honest communication with our community, parents and students.
- S Partnerships with business, governmental and community agencies.
- S Our community's support, sacrifice and contributions.
- § The ability to change and meet all challenges.
- § Facilities that are clean, safe, and well-maintained.

WHEREAS, the student population in FWCS is culturally, geographically, economically, racially and ethnically diverse and this diversity is a valuable resource for teaching students to live and thrive in a global community;

WHEREAS, beginning in 1986, FWCS created magnet schools as schools of choice to reduce minority group isolation in racially-unbalanced schools.

WHEREAS, in the same timeframe, the United States Congress created legislation and funded the Magnet Schools Assistance Program grant under the Elementary and Secondary Education Act, as a result of Congressional findings that:

- S Magnet schools are a significant part of the Nation's effort to reduce minority group isolation in our Nation's schools;
- § These efforts help ensure educational opportunities for all students; and
- § Magnet schools offer a wide range of distinctive programs that have served as models for school improvement efforts;

WHEREAS, FWCS magnet schools have been an effective tool in the management of school capacity, enhancing diversity, reducing minority group isolation and improving academic offerings and parental and student choices;

NOW, THEREFORE BE IT RESOLVED, Fort Wayne Community Schools continues its commitment to maximize student achievement for all students, mitigate the effects of socioeconomic stratification and reduce minority group isolation, by identifying and selecting five schools for inclusion in the 2013 Magnet Schools Assistance Program grant proposal: Harrison Hill Elementary School, Towles Intermediate School, Kekionga Middle School, South Side High School and Wayne High School.

BE IT FURTHER RESOLVED, that to achieve the goals of the MSAP grant, the Fort Wayne Community Schools' Board of School Trustees reaffirms its commitment to having district wide policies and procedures that reduce minority group isolation and authorizes and endorses the application to the United States Department of Education for a 2013 Magnet Schools Assistance Program grant to expand academic choices in Fort Wayne Community Schools.

A motion was made by Stephen Corona, seconded by Glenna Jehl, that the recommendation concerning the Magnet Schools Assistance Program Grant and resolution be approved. Roll Call: Ayes, unanimous; nays, none.

Resolution Concerning Additional Charter Schools Dr. Robinson presented the following Resolution Concerning Additional Charter Schools:

INFORMATION: The attached resolution opposes the granting of any charter absent a need for additional choices and demonstrated quality so that the educational needs of the children and families of Fort Wayne will be served.

RESOLUTION CONCERNING ADDITIONAL CHARTER SCHOOLS WITHIN FORT WAYNE COMMUNITY SCHOOLS

WHEREAS, Fort Wayne Community Schools (FWCS) takes seriously its moral purpose of educating all students to high standards; and

WHEREAS, FWCS has a demonstrated record of improving student achievement; and

WHEREAS, FWCS, with its culturally, geographically, economically, racially and ethnically diverse student population continues to demonstrate significant gains in state academic measurements for all populations; and

WHEREAS, FWCS has provided its parents with quality educational options for many years, and its parents have exercised their right to choose schools which best fit the needs of their children; and

WHEREAS, the experience with charter schools operating within FWCS has shown that children returning from charters to FWCS have been found to have fallen behind their peers who stayed in an FWCS school, requiring additional support; and

WHEREAS, the charters that have operated in Fort Wayne for sufficient time to be evaluated have failed to meet the quality standards maintained by FWCS while diverting tax dollars away from FWCS; and

WHEREAS, FWCS continues to believe in school choice but believes that the FWCS Board, Administration and Teaching Professionals are in the best position to offer those services; and

NOW, THEREFORE, BE IT RESOLVED that the FWCS Board of School Trustees opposes the granting of a charter to conduct a school on the campus of the former Taylor University property or elsewhere in the FWCS district because the educational needs of the children and families of Fort Wayne are best served by the quality choices offered by the district's schools and its high quality professional educators.

Comments

Board members commented that the resolution has no legal standing, but is a statement of the position of the Board on the topic of charter schools within the FWCS district. Glenna Jehl objected to the resolution because it is for all future charters within FWCS. She thinks competition is healthy and wants parents to have a choice. Mark GiaQuinta commented that public education is no place for competition or experimentation with the education of children. Lisa Olinger thinks it unproductive for the Board to adopt a resolution about something over which we have no control. Stephen Corona likes the resolution because it lets the community know where the Board stands on the topic. Julie Hollingsworth believes that public schools should take all students.

A motion was made by Stephen Corona, seconded by Jordan Lebamoff, that the Resolution Concerning Additional Charter Schools be approved. Roll Call: Ayes, Stephen Corona, Mark GiaQuinta, Becky Hill, Julie Hollingsworth, Jordan Lebamoff and Lisa Olinger; nays, Glenna Jehl.

Comments

Board member Stephen Corona shared information about "Public Schools Across America" regional action planning meeting which he attended at Plymouth Congregational Church on Saturday. The event was organized with the help of "Parents United for Responsible Education" to share concerns about attacks on public education and how to address them locally.

Board member Glenna Jehl found the PTA Founder's Day dinner most gratifying because of the parent involvement and thanked the PTA for the well run function.

Board members congratulated the South Side Girls Basketball team and coach for advancing to the state competition and wished them well in the final game on Saturday.

Board member Lisa Olinger commented about the Common Wage Committee hearing where the union wage was adopted as the common wage. She thinks FWCS needs to be more responsible / frugal with the public money it spends.

Board President Mark GiaQuinta commented that the common wage committee receives information from union and non-union representatives and determines the common wage from that information. He stated that the Board heard from a knowledgeable source during a work session that there may be little savings by using non-union wages over union wages. Mr. GiaQuinta also commented about the good attendance at the public hearing about the proposed Carpe Diem charter school.

Superintendent Robinson commented that ISTEP starts next week and encouraged parents to have students get sleep and stay calm.
