**RECOMMENDATION:** It is recommended that the Board recognize the Elmhurst High School girls basketball team for winning the Class 3A state title.

**RELATED INFORMATION:** The Elmhurst High School girls basketball team defeated Owen Valley by a score of 62-59 to win the Class 3A state championship at Lucas Oil Stadium in Indianapolis on Saturday, March 7, 2009. The Lady Trojans' team record for the season was 25-2. This was Elmhurst's first girls basketball state championship. Senior Lecretia Smith led all scorers with 23 points and 12 rebounds. Liza Clemons and Rosie Lewis both added 10 points for the Lady Trojans. The team also won the Summit Athletic Conference with a 9-0 record this year.

In addition, Lecretia Smith won the Patricia L. Roy Mental Attitude Award. This award is presented to a senior participant in each classification nominated by her principal and coach who has demonstrated excellence in mental attitude, scholarship, leadership and athletic ability. Lecretia plans to attend the University of Toledo next fall.

**RELATED INFORMATION:** One of the tasks of each Board member is to recommend an appointment to the FWCS Scholarship Committee. The FWCS Scholarship was established by the Fort Wayne Community Schools Board of Trustees on September 24, 1984. Each spring since 1987, scholarships have been awarded to FWCS students. Gifts range from \$500 to \$1,500, most of which may be renewed for three years as long as the student is in good standing at a four-year college or university.

There are seven members of the scholarship committee and one permanent chairman, Matt Henry. Each is appointed by a Board member and has a term which coincides with the term of that Board member. Members of the Scholarship Committee, assisted by FWCS staff, administer the awarding of these scholarships. They review all applications, interview candidates, and make final recommendations.

Project Lead  
the Way –  
Tech Prep  
Grant

**RECOMMENDATION:** It is recommended that the Board approve the application for and acceptance of a grant in the amount of \$20,000.00 from Tech Prep Grant-Project Lead the Way by Northrop High School. Funding comes from Federal Tech Prep Funds distributed by the Indiana Department of Workforce Development.

**RELATED INFORMATION:** Project Lead the Way will provide students the opportunity to pursue interest in multiple engineering and other high tech fields through exploration of career opportunities, internships, and hands on learning. This program will prompt students to earn Work Ethic Certification, and will better prepare them to select a field of engineering in which to earn a baccalaureate and other advanced degrees and certifications. It will meet the academic standards of the State of Indiana in math, career, and technical education. The course has been aligned with the prescribed standards in all three areas.

Project Lead the Way will provide students with a skill base to enter post secondary schools prepared to successfully complete collegiate programs in high tech or engineering. It will also be able to fully implement a much needed pre-engineering program that will meet the diverse needs of the students at Northrop High School. Raytheon, IPFW, and Ivy Tech are community partners.

This competitive grant was written by Northrop Principal Barbara Ahlersmeyer, and supports District Goal I: *Achieve and Maintain Academic Excellence*.
