PERF Eligibility Provision for Non-Union/Meet and Confer Employees Dr. Robinson presented the following recommendation concerning the PERF Eligibility Provision for Non-Union/Meet and Confer Employees:

RECOMMENDATION: It is recommended that the Board modify Public Employee Retirement Fund (PERF) eligibility of non-union employees to only employees who work a schedule of six (6) or more hours per day effective March 22, 2014.

RELATED INFORMATION: With this change, only FWCS non-union/meet and confer employees who regularly work a schedule of six (6) or more hours per day will be subject to the provisions of PERF. This aligns eligibility with that of our union groups.

Ratification of AFSCME Contract Representing FWCS Secretaries, Media Clerks, Assistants, Clerks, Interpreters, Groundskeepers, and Nutrition Service Employees

Dr. Robinson presented the following recommendation concerning the Ratification of AFSCME Contract Representing FWCS Secretaries, Media Clerks, Assistants, Clerks, Interpreters, Groundskeepers, and Nutrition Service Employees:

RECOMMENDATION: It is recommended that the Board ratify a two (2) year contract agreement between Fort Wayne Community Schools and AFSCME representing FWCS Secretaries, Media Clerks, Assistants, Clerks, Interpreters, Groundskeepers, and Nutrition Service Employees.

RELATED INFORMATION: On Monday, February 24, 2014, employees represented by AFSCME ratified a tentative two (2) year agreement.

The changes are as follows:

- Two (2) year agreement (July 1, 2013 – June 30, 2015).
- Secretaries, Media Clerks, School Assistants, Bus Assistants, Special Education Assistants, Clerks, and Nutrition Services employees will receive a two percent (2%) base wage increase plus one dollar (\$1.00) per hour increase for fiscal year 2013-2014, and a two (2%) percent base wage increase for fiscal year 2014-2015.
- Groundskeepers and Hearing and Visual Impaired Interpreters will receive a two percent (2%) base wage increase for fiscal year 2013-2014, and a two percent (2%) base wage increase for fiscal year 2014-2015.
- Effective March 22, 2014, only AFSCME employees who regularly work a schedule of six (6) or more hours per day will be subject to the provisions of PERF.
- Health Insurance:
Calendar year 2014 – 82% Board Subsidy of Core Plan
Calendar year 2015 – 80% Board Subsidy of Core Plan
- 401 (a) employer Match – The retirement match was eliminated from the contract.

These devices will be utilized as mobile learning labs to support instructional and assessment needs of students and teachers.

Training for use of these devices will be accomplished with the assistance of building coaches, technology coordinators and teachers who participated in the 2013-14 iPad Integration Grants.
