**RECOMMENDATION:** It was recommended that the Board recognize students from Geyer Middle School who placed first in the Middle School Bridge Building Contest February 16<sup>th</sup> at Science Central.

**RELATED INFORMATION:** The group of eighth-graders from Geyer beat out 15 other schools to claim the top prize in the annual contest sponsored by Science Central and the 2002 Engineer's Week Committee. Students had to use 200 Popsicle sticks and wood glue to build a bridge that would not break. The bridge had to be at least 24 inches long, no more than 6 inches wide and 12 inches tall. Scores were based on bridge weight, the load that the bridge could hold and deflection. Geyer placed second in the competition last year.

**RECOMMENDATION:** It was recommended that the Board recognize eighth-graders from Shawnee and Jefferson middle schools for placing 1<sup>st</sup> and 3<sup>rd</sup> respectively at Northeast Indiana Regional Future City Competition in January at Indiana University-Purdue University at Fort Wayne.

**RELATED INFORMATION:** Shawnee and Jefferson middle schools were among 13 schools to compete in the annual competition which challenges students to create a city of the future. Students wrote a city abstract and designed a three-dimensional scale model using recycled materials. An engineer was assigned to each team to serve as a mentor for the project. Shawnee's 1<sup>st</sup> place finish earned them a trip to Washington, D.C. for the national finals on February 19.

**RECOMMENDATION:** It was recommended that the Board recognize Parkview Hospital and Parkview Hospital Foundation for their generous contributions to the district.

**RELATED INFORMATION:** Parkview Hospital has been providing nursing services to Fort Wayne Community Schools since 1997 when they adopted Lakeside Middle School and its three elementary feeder schools. Since that time, Parkview has continued to increase their support by adopting additional schools and increasing overall nursing services with Fort Wayne Community Schools. Through their Adopt-a-School partnership with the district, Fort Wayne Community Schools Health Services can ensure that students who are in need of health services see a dedicated, health professional at their school.

Since January 1997, Parkview has committed \$1,495,298 to nursing services for Fort Wayne Community Schools. By adding 3 more nurses this coming August, the 2002 budget will expand to \$686,000 annually.

We recognized Parkview Hospital and Parkview Hospital Foundation for their commitment to improving the health and well-being of children and staff throughout the Fort Wayne Community Schools community. In attendance were Dr. Frank Byrne, Executive Vice President/President of Parkview Health Foundations, Ken Menefee, Senior Vice President of Parkview Foundation, Eileen Brackett, Senior Vice President of Patient Care, and Kathleen Wiggs-Stayner, Director of Community Nursing/Outreach Services for Parkview Hospital, who accepted the plaque. Dr. Frank Byrne spoke on behalf of Parkview Health Foundations and Parkview Hospital accepting the recognition and thanking Fort Wayne Community Schools for the opportunity to serve them.

Dr. Fowler-Finn presented the following recommendation concerning the Parkview School Nurse Program:

**RECOMMENDATION:** It was recommended that the Board approve expanded services from Parkview Hospital to provide additional school nurses for Fort Wayne Community Schools students.

**RELATED INFORMATION:** Beginning in January 1997, Parkview Hospital began providing school nurses and a social worker to their neighborhood school, Lakeside Middle School, and the feeder elementary schools, Bloomingdale, Brentwood and Forest Park.

This program was expanded in August 1997 to include Geyer Middle School, and Abbett, Fairfield, Harrison Hill, and South Wayne elementary schools. This program has provided increased access to nursing care for students at schools involved directly in this program as well as schools served by Fort Wayne Community Schools nurses.

Since January 1997, Parkview's Mission and Community Outreach program has committed \$1,495,298 in nursing services to Fort Wayne Community Schools, with an additional \$438,000 budgeted for 2002. The health benefit for students has been well documented over the past five years. Therefore, Parkview is willing to significantly expand their commitment to children's health by adding Kekionga Middle School, and Adams, Scott, Study, and Washington elementary schools to this program.

Parkview will hire three additional school nurses to begin in August, expanding the 2002 budget to \$686,000 annually.

This supports advancement intended and outlined in the Fort Wayne Community Schools Strategic Plan, Strategy III Safe and Caring Environment and Strategy X, Community Linkages.

Each tape will give specific suggestions on how to support their children's first reading efforts. Presently, Forest Park & Irwin Elementary are in the process of creating the videos. The approval of this grant will provide additional funds to purchase the materials needed to reproduce the videos for all Fort Wayne Community Schools elementary schools. Toni Kring, the principal at Forest Park, is the contact person for this grant.
