RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a 2019-20 Digital Learning Grant from the Indiana Department of Education in the amount of \$49,949.50.

RELATED INFORMATION: This competitive grant will provide funds to take digital learning in FWCS to the next level. FWCS hopes to strengthen our middle school STEM/STEAM/CTE programs by providing the foundational skills middle school students need to be successful in these programs.

FWCS middle school students will have greater access to high-quality and equitable learning experiences that are specifically designed to increase digital literacy skills. These requested funds for 2019-20 will be used in our eleven middle schools:

- To purchase materials and lessons to be embedded into the 6-8 grade science curriculum that
 will be developed and written this summer. Each middle school will receive two 3D printers,
 MySTEMkits.com science, math, and coding curriculum, access to TinkerCad.com,
 VidCode.com, and a system of supports to ensure successful and equitable implementation.
- To support FWCS teachers through implementation of hands-on learning activities that support student mastery of the Science and Engineering Process Standards, Indiana Academic Standards, and ISTE Standards.

He told Mr. Corona that our efforts paid off lobbying against the referendum bill. Mr. Corona wants parents and community members to know that involvement and participation can make a difference.

Board Member Maria Norman attended the Indiana State Teachers Association rally on Saturday. It was exciting to see so many teachers at the Statehouse, all wearing red, talking to legislators about pay for education in general in the State of Indiana. Many FWCS schools were represented. Last week Ms. Norman attended a National School Board Association webinar on school safety and found it very informative. Lastly, Maria Norman attended the graduation ceremony of nearly 200 Continuing Education students. She found their stories to be very heartwarming.

Board President Julie Hollingsworth spoke of a recent letter to the editor that spoke of the teacher shortage and pay issues in the State of Indiana and urged legislators to get something done. Ms. Hollingsworth also attended the Continuing Education graduation. As always it was a really wonderful night, seeing people who persevered and reached their goals. Lastly, Ms. Hollingsworth mentioned a recent article that gave actual statistics on virtual education. In 2017-18 60% of those students earned zero credits yet the school got 100% funding for each student.
