**RECOMMENDATION:** It is recommended that the Board recognize Larry Elliott, at Kekionga Middle School, for his contributions to the students, staff and faculty of Fort Wayne Community Schools.

**RELATED INFORMATION:** The Staff Spotlight program is the district's method of recognizing employees for outstanding work and commitment to excellence.

We honored Larry Elliott, an FWCS employee for 27 years. Larry started his FWCS career at South Side as a night custodian, and later moved to Elmhurst. He is currently the custodial engineer at Kekionga. Larry's hard work has helped Kekionga earn several clean school awards through the years. His daily responsibilities include keeping classrooms, the media center, and cafeteria spotless. He can also be seen helping out with the students in the hallways.

In spring 2005, Kekionga started a renovation project and Larry took on the responsibility of overseeing all the renovations. Music Educators National Conference Grant – Haley Elementary School

Dr. Robinson presented the following recommendation concerning the Music Educators National Conference Grant – Haley Elementary School:

**RECOMMENDATION:** It is recommended that the Board approve application for and acceptance of a grant award from the National Association for Music Education in the amount of \$1500 for Haley Elementary School.

**RELATED INFORMATION:** The Haley Elementary School music program has been selected to receive special recognition as a Model Music Education Program by the Music Educators National Conference (MENC). The MENC Model Music Education Program is a newly established award program acknowledging twelve outstanding music programs from across the nation that demonstrate distinctive aspects and successes based on The National Standards for Music Education.

The Haley music program’s unique characteristics as a Model Music Education Program include the integration of state-of-the-art music and educational technologies, the innovation of various related arts and integrated curriculum projects, and the utilization of technology-driven assessment tools. Haley music supports the school’s improvement plan by facilitating language arts, social studies, math, and science related music curriculum lessons, projects, and activities and utilizing authentic student/teacher created assessments.

In addition to the grant, Haley will be featured in an MENC publication highlighting the program. Grant writer Wendy Bloom, Haley music teacher, will participate in a panel discussion featuring the schools winning the model award at the Biennial National Music Educators Conference in April in Salt Lake City.

The Haley music department will utilize the grant award funds to upgrade music composition and multimedia software in the Haley music technology lab and to purchase additional African instruments for the Haley drum circle ensemble.

This program supports advancement intended and outlined in Strategy 1: *We will ensure high levels of learning for all students.*
