Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

Scholastic Art Awards National Winners

RECOMMENDATION: It is recommended that the Board recognize the Shawnee Middle School and Snider High School students who were national winners in the Scholastic Art Awards.

Dr. Robinson presented the following recommendation concerning Project SEED:

Project SEED

RECOMMENDATION: It is recommended that the Board approve a continued partnership with Project SEED for the following dates and amounts:

2012-13: \$179,500 2013-14: \$199,500 2014-15: \$219,000

RELATED INFORMATION: Founded in 1963, Project SEED is a nationally recognized program whose goal is to improve student motivation and confidence while preparing students for success in advanced math classes.

Project SEED will provide:

- A staff of mathematicians, scientists, and engineers specially trained to teach advanced mathematics in elementary and middle classrooms;
- Three years of classroom-based professional development strategies that promote students involvement and achievement;
- Intensive training for 25 teachers in elementary and middle classrooms and district-wide training for up to 600 teachers.

This program is funded through the Title I and Title II grants and coordinated by Adam Normand, Math Curriculum Coordinator. It addresses advancement intended and outlined in Goal I: *Achieve and Maintain Academic Excellence*.

Dr. Robinson presented the following recommendation concerning the Refunding of the General Obligation Pension Bonds of 2004:

Refunding of the General Obligation Pension Bonds of 2004

RECOMMENDATION: It is recommended that the Board approve a Supplemental Bond Resolution for the refunding of the General Obligation Pension Bonds of 2004.

RELATED INFORMATION: Bonds were issued in 2004 in the amount of \$40 million for the purpose of providing funds to pay for the existing unfunded retirement or severance liabilities of the district. The current interest rate environment creates a savings opportunity through the refinancing of the outstanding bonds. The refunding issue will be made through the Indiana Bond Bank. It is estimated that our debt service payments will be reduced by about \$3.6 million from 7/5/13 to 1/5/22. This reduces pension bond neutrality requirements through those years and will provide additional funding for the Capital Projects Fund, Transportation Fund or Bus Replacement Fund.

The Supplemental Bond Resolution authorizes: (i) the waiver or modification of call rights under the General Obligation Pension Bonds of 2004 (Taxable); and (ii) the execution and delivery of certain documents, including the Amended General Obligation Pension Bonds of 2004 (Taxable) and the Qualified Entity Purchase Agreement.
