MATH schools for placing at the state level in the MATH academic competition.

Competition

RELATED INFORMATION: The MATH academic competition, formerly known as Math Bowl, is based on the National Council of Teachers of Mathematics Curriculum and Evaluation Standards. In the competition, there are four rounds consisting of seven multiple-choice questions each. Teams composed of at least 12 members answer the story-type questions that must be worked in 30 seconds to one minute. Students may participate in only one round. The team from Haley elementary placed 16th out of 80 schools in class three, and the team from Irwin placed 13th out of 105 schools in class four at the state level.

Dr. Robinson presented the following recommendation concerning the Textbook Adoption 2008-2014 and Approval of Textbook Rental Fees 2008-2009:

RECOMMENDATION: It is recommended that the Board adopt new elementary, middle, and high school language arts, world language, and English Language Learner textbooks and related materials, and approve textbook rental rates for the school years 2008-2009 through 2013-2014 and student fees for 2008-2009.

RELATED INFORMATION: The Indiana State Board of Education adopts textbooks and related materials for use on a statewide basis according to a legally prescribed six-year cycle. Local committees review texts and identify those that best meet the needs of the students in that particular district. This is the year designated for adoption of texts and materials in language arts, world language, and English Language Learner.

In late summer of 2007, teams of FWCS teachers and parents, as well as administrators, began reviewing instructional materials. Many teachers piloted materials for alignment to district initiatives. Additional teachers and parents reviewed materials for alignment to state and local standards. The committees' recommendations of textbooks and related materials for the time period of 2008-2014, the costs of textbooks and related materials, and the projected elementary 2008-2009 fees are attached. Texts may be viewed at the FWCS public review site located at 1511 Catalpa St.

Families unable to pay student fees may apply for financial assistance. Students approved for free lunch are also eligible for free textbooks. The State of Indiana reimburses the FWCS Textbook Rental Fund for a portion of the textbook rental charges for qualified students, and the remainder is made up from the General Fund. Approximately 19,665 students have qualified for financial assistance as of March 11, 2008.

Kindergarten
Grant

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the 2008-2009 Full-Day Kindergarten Grant.

RELATED INFORMATION: The purpose of this grant is to provide full-day programs in all schools to improve the academic and social development of children in kindergarten.

The grant opportunity is open to all public school corporations in Indiana. The funds available for the 2008-2009 school year total \$58,500,000. If all public school corporations chose to participate, the minimum grant award would be equal to \$721 per full-day kindergarten student or about \$1.8 million for FWCS.
