Approval of Minutes – March 25, 2002 A motion was made by Bettye J. Poignard, seconded by Jon J. Olinger, that the minutes of the regular meeting of the Board of School Trustees held March 25, 2002, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Thomas Fowler-Finn, superintendent, presented the following information and recommendations concerning awards and recognitions:

National Merit Scholars **RECOMMENDATION**: It is recommended that the Board recognize students for being National Merit Scholars.

RELATED INFORMATION: Students from several Fort Wayne Community Schools high schools were recently recognized in National Merit Scholar competition. Four students were named National Merit Commended students. Two were recognized as National Merit Semifinalists. These students scored in the top five percent on the qualifying test. Ten Fort Wayne Community Schools students were named National Merit Finalists, scoring in the top half of one percent on the national exam. The recognition qualifies them for National Merit Scholarships. Two students were named semifinalists in the National Achievement Scholarship Program, which recognizes the country's top-scoring African-American students.

Each year, the College Entrance Examination Board recognizes exceptional students from the more than one million students who take the Preliminary SAT/National Merit Scholarship Qualifying Test in their junior year. In addition to PSAT scores, judges evaluate the students' high school academic record, community and school service, extracurricular activities and statement of goals. These students represent the highest academic potential in the country.

IPFW Great Men and Women Diversity Award **RECOMMENDATION:** It is recommended that the Board recognize Jefferson Middle School guidance counselor David Thomas for being honored at Indiana University - Purdue University of Fort Wayne's Multicultural Services annual "Great Men and Women: They Made a Difference" diversity breakfast in February.

RELATED INFORMATION: Mr. Thomas was one of five Fort Wayne residents honored for their work in the community. Among Mr. Thomas' many community projects is the Boys to Men program, which he first sponsored in 1995 at Lakeside Middle School, and continues today at Jefferson Middle School. The program focuses on the cultural, social and emotional development of male youth in middle school.

RELATED INFORMATION: The Staff Spotlight program is the district's method of recognizing employees for outstanding work and commitment to excellence. Tonight we honor Gordon Pixley, fifth grade teacher at Holland Elementary School who has been instrumental in getting the entire Holland staff involved in the Accelerated Reading program. A video highlighting his accomplishments was shown.

This program addresses advancement intended and outlined in Strategy V, Ensuring Staff Effectiveness; and Strategy VIII, Communicating that Fort Wayne Community Schools is an Excellent School System.

Elmhurst SAT Preparation Class Successes

Vouchers

Textbook Adoption 2002-2008 and Approval of Textbook Rental Fees 2002-2008 It's a fact – students who are enrolled in classes that prepare them for high stakes college entrance exams score higher than those who take the test "cold." At Elmhurst High School, their SAT Preparation Class is spelling big successes for students. Math instructor Phil Habegger spoke about the class and, with help from student, Laura Bonano, took you through one of the strategies students learn to boost their SAT score. Principal David Schnelker introduced another exciting Elmhurst success – their web site.

Dr. Fowler-Finn presented the vouchers for the period ending March 27, 2002 and April 10, 2002, with the recommendation the vouchers be approved. A motion was made by Carl A. Johnson, seconded by Bettye J. Poignard, that the vouchers appearing in the listing numbered 02-07 and 02-08 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Dr. Fowler-Finn presented the following recommendation concerning the Textbook Adoption 2002-2008 and Approval of Textbook Rental Fees 2002-2008:

RECOMMENDATION: It is recommended that the Board adopt the new elementary, middle, and high school language arts, foreign language, and English as a Second Language textbooks and related materials for the school years 2002-2003 through 2007-2008, and approve the accompanying textbook rental rates for grades PreK – 12 for the school years 2002-2003 through 2007-2008.

RELATED INFORMATION: The Indiana State Board of Education adopts textbooks and related materials for use on a statewide basis according to a legally prescribed six-year cycle. Local committees review texts and identify those that best meet the needs of the students in that particular district. This is the year designated for adoption of texts and materials in language arts, foreign language, and English as a Second Language.

In late summer of 2001, teams of Fort Wayne Community Schools teachers and parents, as well as administrators, began reviewing instructional materials. Many teachers piloted materials for alignment to district initiatives. Additional teachers and parents reviewed materials for alignment to state and local standards. The committees' recommendations of textbooks and related materials for the time period of 2002-2008, the costs of textbooks and related materials, and the projected elementary 2002-2003 fees are attached. Texts may be viewed at the Fort Wayne Community Schools public review site located at 1511 Catalpa St.

Families unable to pay student fees may apply for financial assistance. Students approved for free lunch are also eligible for free textbooks. The State of Indiana reimburses the Fort Wayne Community Schools Textbook Rental Fund for a portion of the textbook rental charges for qualified students, and the remainder is made up from the General Fund. Approximately 14,600 students have qualified for financial assistance as of April 1, 2002.

A motion was made by Carol J. Coen, seconded by Donald J. Schaab, that the recommendation concerning the Textbook Adoption 2002-2008 and Approval of Textbook Rental Fees 2002-2008, be approved. Roll Call: Ayes, unanimous; nays, none.

Textbook Waivers Dr. Fowler-Finn presented the following recommendation concerning the Textbook Waivers:

RECOMMENDATION: It is recommended that the Board approve submission of waivers to the Indiana Board of Education for the use of off-category instructional materials in French, Latin and Spanish for the adoption period of 2002-2008.

RELATED INFORMATION: The state Official Adoption List designates textbooks for specific grade levels and high school courses. In reviewing the state list, the Fort Wayne Community Schools high school foreign language textbook adoption committee recommended the use of Latin and Spanish Level One texts for both first and second year of Latin and Spanish. They also recommended that the French Level Two text be used for both second and third year French.

The texts identified in this waiver request are on the state list and provide sufficient coverage of standards to service both levels of courses. The state foreign language consultant has indicated support for this waiver request.

A motion was made by Bettye J. Poignard, seconded by Jon J. Olinger, that the recommendation concerning the Textbook Waivers, be approved. Roll Call: Ayes, unanimous; nays, none.

Non-Standard Course Waivers

Dr. Fowler-Finn presented the following recommendation concerning the Non-Standard Course Waivers:

RECOMMENDATION: It is recommended that the Board approve the submission of Non-Standard Course Waivers to the Indiana Board of Education for approval to offer middle school speech, FOCUS, and English as a Second Language classes.

RELATED INFORMATION: The DOE has published a document entitled *Course and Program Descriptions for Indiana Schools* that identifies what courses and programs can be offered in accredited schools in Indiana. The list does not include courses for middle school speech, middle school FOCUS (Basic Skills Development), or middle school English as a Second Language. In order to provide a personalized education program for students at middle school grade levels, the district is seeking state approval to offer these courses.

Curriculum Services prepares the waiver request and coordinates the approval process with P.L. 221 school planning activities.

A motion was made by Jon J. Olinger, seconded by Carl A. Johnson, that the recommendation concerning the Non-Standard Course Waivers, be approved. Roll Call: Ayes, unanimous; nays, none.

Close-out of Capital Projects Dr. Fowler-Finn presented the following recommendation concerning the Close-out of Capital Projects:

RECOMMENDATION: It is recommended that certain 2000 and 2001 Capital Projects Fund (CPF) programs be closed. The balances will be used to fund future capital projects. It is further recommended that the Board approve the resolution to reduce the list of CPF programs.

RELATED INFORMATION: CPF project appropriations expire either when they are spent or when the Board takes action to close the project. A project needs to be closed when the purpose for the appropriation has been achieved.

Unspent appropriations in projects that are completed and closed revert to the fund balance where they become available to be reappropriated.

Amendment to the 2002 Capital Projects Plan Dr. Fowler-Finn presented the following recommendation concerning the Amendment to the 2002 Capital Projects Plan:

RECOMMENDATION: It is recommended that the 2002 Capital Projects Plan be amended to include the adjustments identified on the list and that the Board hold a hearing and adopt the resolution to modify the 2002 Capital Projects Plan.

RELATED INFORMATION: The State of Indiana requires the Board to hold a hearing and pass a resolution authorizing any changes in the Capital Projects Fund Plan. Needed funding will come from reassigning revenue for the following proposed changes:

Lincoln and Holland Building Temperature Controls - Temperature controls that operate the heating and cooling systems throughout the building have failed. Currently, the building is experiencing severe fluctuations in temperature due to control failure.

Roofs – The roofing project has been reduced. Projects at Bunche, Glenwood Park, Lindley, and Miami have been deleted for this season. The project at Weisser Park has been decreased, and those funds will be applied towards a roofing project at Northwood.

RELATED INFORMATION: Earlier in this meeting, the Board of School Trustees amended the 2002-2004 Capital Projects Plan. This project is included in the amendment.

Facilities administrators selected architects for this project based on the individual strengths of each of the firms. Indiana law requires that projects over \$100,000 make use of a registered architect or professional engineer for developing plans and specifications. Project architects and engineers need to be appointed now to allow sufficient time for planning and bidding of projects to ensure completion by September 15, 2002.

RELATED INFORMATION: Due to state revenue reductions for the year 2002, several major construction projects were cancelled including the General Building Systems (GBS) I projects. The package was bid prior to learning the state revenue reduction plan. The replacement of bleachers at Elmhurst is identified on the School Sports Facilities line of the CPF, and was appropriately bid in the same package as GBS. Since the GBS I bid was not accepted, and since the bleacher replacement is required due to safety issues, another method of advancing the project is required. Awarding a change order to the 2002 Traffic and Safety/Site will allow the project to move forward.

Renaming of Northrop High School Varsity Baseball Diamond Dr. Fowler-Finn presented the following recommendation concerning the Renaming of Northrop High School Varsity Baseball Diamond:

RECOMMENDATION: It is recommended that the Board approve the renaming of the varsity baseball diamond at Northrop High School the "Chris Stavreti Field".

RELATED INFORMATION: Chris Stavreti retired from Fort Wayne Community Schools in 1997 after 26 years of teaching Social Studies and coaching baseball at Northrop High School. A person of vision and drive, Chris built the Bruin's tradition and facility from the ground up. Chris' teams were the first in Fort Wayne Community Schools to play on school owned facilities with electric scoreboards, grass infields and manicured playing surfaces.

As a member of the Indiana High School Baseball Hall of Fame since 1990, Coach Stavreti developed the Northrop Bruin's baseball organization into a highly respected program. The team's accomplishments during the time of Coach Stavreti's tenure include 526 wins, one state championship title, three semi-state championships, seven regional, twelve sectional and nine conference championships. Staff, students and parents agree that renaming the varsity baseball diamond will honor and show appreciation to the man who made the Northrop Bruin's baseball program the success it is today.

A motion was made by Jon J. Olinger, seconded by Bettye J. Poignard, that the recommendation concerning the Renaming of Northrop High School Varsity Baseball Diamond, be approved. Roll Call: Ayes, unanimous; nays, none.

Ratification of Fort Wayne Community Schools Nurses Association Electronic Data Systems Technology Grant Dr. Fowler-Finn presented the following recommendation concerning the Electronic Data Systems Technology Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Electronic Data Systems Technology grant in the amount of \$1,548.00 for Irwin Elementary School.

RELATED INFORMATION: The objective of this non-competitive grant is to purchase a Smart Board Interactive Whiteboard to provide an effective way for students to share on-line data and information.

The current project, "Tip-Toe through the Tulips," involves the planting of a local tulip garden by the students who then collect and share on-line data about the emerging and blooming bulbs they plant. In exchange, the students receive data from the planters of the more than 190 gardens across the continent and around the world. By examining the data provided, the students will follow the wave of spring and measure its pace as it moves northward. The contact person for this grant is Christine Michael.

This program supports advancement intended and outlined in Strategy IX, Technology to Transform Learning and Operations.
