Making a
Difference –
Building
Blocks Grant

Dr. Robinson presented the following recommendation concerning the Making a Difference – Building Blocks Grant:

RECOMMENDATION: It is recommended that the Board approve the Making a Difference Building Blocks Grant from the Indiana Department of Education in the amount of \$15,000.

RELATED INFORMATION: The 2012 - 2013 IDOE Making a Difference Building Blocks Grant funds will focus on the area of High Ability student support. This grant is limited to work related to systemic change with one category being professional development specifically for teachers of high ability students.

The grant funds will be used to focus on the area of High Ability student services for students who are Pre-AP, with a priority at the middle school level. The primary goal of the proposal is to solidify and enhance the programming and instruction offered to our students identified as high ability in the areas of Language Arts and Mathematics in the Pre-AP grades, with priority given to middle school teachers. Trainers/instructors from the College Board will be used to train a cadre of Pre-AP teachers in the types of instructional techniques that will help FWCS meet the goals of the grant and district goals for the academic achievement of our able students.

Kathy Gordon, High Ability Specialist, Academic Services will write and manage the grant.

This program supports FWCS district Goal I: Achieve and Maintain Academic Excellence.

FWCS Board Districts Reapportionment Dr. Robinson presented the following recommendation concerning the FWCS Board Districts Reapportionment:

RECOMMENDATION: It is recommended that the Board adopt the proposed changes to FWCS Board districts.

RELATED INFORMATION: Indiana Code provides that Board districts be reapportioned when population changes make Board districts unequal in population. Data from the 2010 census indicates the need to reapportion the Board's five electoral populations. The attached Resolution was discussed at the Board meeting on March 26. The list of the proposed changes along with a map has been posted on the FWCS website as well as a copy available in the Grile Administration Center lobby.

RESOLUTION OF THE BOARD OF SCHOOL TRUSTEES FORT WAYNE COMMUNITY SCHOOLS

Whereas, it is the responsibility of the governing body of an Indiana school corporation to develop a "plan" that establishes, among other things, the manner in which the governing body of a school corporation is constituted, including the number, qualifications, length of terms, and, method and time of selection;

Whereas, the Board of School Trustees of Fort Wayne Community Schools has previously adopted a governance "plan" that includes a seven (7) member governing body, with five (5) members elected from electoral districts where the member is elected solely by the voters of a single district and two (2) members elected at-large;

Whereas, Ind. Code § 20-23-8-8(a) (4) & (5) provide that such electoral districts "must be as near as practicable equal in population" and be "reapportioned and their boundaries changed, if necessary, by resolution of the governing body before the election next following the effective date of the subsequent decennial census to preserve the equality" and that any such reapportionment must comply with the

Constitutions of the State of Indiana and the United States, including the equal protection clauses of both constitutions;

Whereas, the most recent decennial census is the 2010 census and the next election for members from certain electoral districts will be in November, 2012 and the next election for the members from the remaining electoral districts will be in November, 2014;

Whereas, the data from the 2010 census indicates that the School Corporation's overall population is 215,437, with a "perfectly equal" district containing a population of 43,087;

Whereas, if unchanged, the Board's five (5) electoral populations will deviate by more than ten percent (10%), with the following populations:

Northrop High School – Emergency Project Dr. Robinson presented the following recommendation concerning the Northrop High School – Emergency Project:

RECOMMENDATION: It is recommended that the Board declare that an emergency exists at Northrop High School. The cost of the repair is undetermined at this time but will exceed the insurance deductible.

RELATED INFORMATION: Emergency funding is needed at Northrop High School to repair the wood gym floor due to water damage. The project can be completed while school is in session. It is anticipated that FWCS will only be responsible for a \$50,000 deductible, funded by the CPF emergency fund, and the balance will be paid by our insurer.

Miscellaneous Textbook Adoption 2012–2018 and Student Fees 2012-2013

Dr. Robinson presented the following recommendation concerning the Miscellaneous Textbook Adoption 2012–2018 and Student Fees 2012-2013

RECOMMENDATION: It is recommended that the Board of School Trustees adopt the proposed elementary, middle school and high school business, technology information, family and consumer sciences, physical education, art, and music textbooks for the school years 2012–2013 through 2017–2018 and approve the accompanying rental rates for the school year 2012–2013.

RELATED INFORMATION: The Indiana Board of Education adopts textbooks and related materials for use on a statewide basis according to the legally prescribed six-year cycle. Local committees review textbooks and identify those that best meet the needs of the students in that particular district.

Teams of FWCS teachers, parents, and administrators reviewed the instructional materials. Teachers and parents recommended the textbooks that meet the Common Core State Standards for adoption.

Families unable to pay student fees may apply for financial assistance. Students approved for free lunch are also eligible for free textbooks. The State of Indiana reimburses the Fort Wayne Community Schools Textbook Rental Fund for a portion of the textbook rental charges for qualified students, and the remainder is paid from the General Fund.

The FWCS textbook adoption process addresses district Goal I, *Achieve and Maintain Academic Excellence* through selecting high quality instructional materials for teachers to use in their classrooms. The adoption process also addresses Goal II, *Actively Engage Parents and the Community* by including them in the selection of adoption materials.

Comments

Board member Lisa Olinger asked about the availability of digital editions for the adopted textbooks. Math Curriculum Coordinator Adam Normand responded that FWCS would receive paper copies and digital copies of adopted textbooks.
