Roll Call

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, April 24, 2006, at 7:06 p.m. President Geoff Paddock called the meeting to order with the following members in attendance:

Approval of Minutes – March 27, 2006 A motion was made by Robert A. Armstrong, seconded by Stephen Corona, that the minutes of the regular meeting of the Board of School Trustees held March 27, 2006, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

National Scholastic Art Award

RECOMMENDATION: It is recommended that the Board recognize Jacob Murray, an Elmhurst student, for winning the National Scholastic Art Award.

RELATED INFORMATION: The 2006 Scholastic Art Award contest was held at the Fort Wayne Museum of Art with a display in the main gallery from January 29 through March 2, 2006. Jacob won two 1st place Gold Key awards. One for his computer art piece, "Graeth Namril," a mythological, mountain landscape at twilight. And, one for a drawing piece entitled, "Best Seat in the House." Jacob also received a 2nd place Silver Key for a computer art portrait entitled, "Teddy."

In total, 8 pieces of Jacob's art work were sent to New York for judging on February 20. Jacob was the only winner for the Northern Indiana Region and some 17 counties.

Academically, Jacob is 3rd in his class at Elmhurst. He has been awarded a 2-year full scholarship to attend Columbus College of Art and Design in Columbus, Ohio.

RECOMMENDATION: It is recommended that the Board recognize Jacob Klopfenstein, a Memorial Park Middle School student, for winning 3rd place in the Indiana State Geography Bee competition.

RELATED INFORMATION: The 2006 Indiana Geography Bee was held recently and Jacob Klopfenstein, an 8th grade Memorial Park student, placed in the top ten in this year's competition. Jacob finished 3rd in the state and scored the highest of all public and private school students from northeast Indiana. Jacob was only two points away from going to Washington, DC to participate in the National competition.

DECA State Competition

RECOMMENDATION: It is recommended that the Board recognize Taylor Sorg, a Wayne High School student, for earning tops honors at the Indiana Distributive Education Clubs of America (DECA) competition.

RELATED INFORMATION: DECA is a national organization that helps students develop skills and competence for marketing careers, build self-esteem, experience leadership, and practice community service.

This year Taylor Sorg competed in the Vehicle and Petroleum event of DECA. Taylor received first place in three areas: marketing concepts, professional development, and overall. Only one other student achieved that level of success at this year's state meet. Taylor now qualifies to go to the International Competition in Dallas, Texas at the end of April.

In addition to this achievement, Ivy Tech State College has awarded Taylor a \$1000 scholarship.

RELATED INFORMATION: This project consists of constructing parent pick-up lanes, parking lots, curbs, and concrete walks; replacing deteriorated asphalt and concrete pavement; overlaying three middle school tracks; improving drainage; and constructing a baseball facility at Long Road for Snider High School. This recommendation is mostly funded from the Capital Projects Fund. Alternates 6, 8, and 10 relate to the Snider baseball field and are being funded by Snider extracurricular funds. Project specifications require the work to be completed at the schools by August 7, 2006 and the Long Road facility by September 1, 2006.

Textbook Adoption 2006-2012 and Student Fees 2006-2007 Dr. Robinson presented the following recommendation concerning the Textbook Adoption 2006-2012 and Student Fees 2006-2007:

RECOMMENDATION: It is recommended that the Board adopt the proposed elementary, middle school, and high school business, technology information, family and consumer science, physical education, art, and music textbooks and materials for 2006-2012 and the proposed subject area fees for the school year 2006-2007.

RELATED INFORMATION: The Indiana State Board of Education adopts textbooks and related materials according to the legally prescribed six-year cycle. In November of 2005, committees of teachers and parents began reviewing texts and materials and identified those that best meet the needs of the students and address subject area standards. These adoption recommendations are standards-based, support state course descriptions, and align with the district models.

The committees' recommendations of textbooks and related materials for 2006-2012 are attached. Texts may be viewed at the state public review site located in the FWCS Media Center, 1511 Catalpa Street.

Families may apply for financial assistance. Students approved for free or reduced lunch are eligible for free textbooks. The State of Indiana reimburses for a portion of the textbook rental charges for qualified students, and the remainder is made with local property taxes. Approximately 16,900 students qualified for textbook assistance during the 2005-2006 school year.

This adoption addresses *Strategy 1: We will ensure high levels of learning for all students.*

A motion was made by Carol J. Coen, seconded by Robert A. Armstrong, that the recommendation concerning the Textbook Adoption 2006-2012 and Student Fees 2006-2007 be approved. Roll Call: Ayes, unanimous; nays, none.

Group Life Insurance

Dr. Robinson presented the following recommendation concerning the Group Life Insurance:

RECOMMENDATION: It is recommended that the Board renew BCS Life Insurance Company as the group life insurance carrier for a three-year term, effective May 1, 2006 through April 30, 2009.

RELATED INFORMATION: BCS Life Insurance has provided Fort Wayne Community Schools' group life and supplemental life coverage since May 1, 2004. They have offered to renew the FWCS plan at a rate of \$.205 per \$1,000.00 of coverage with a 3-year rate guarantee. This represents a savings of just under 10% from our current rate of \$.225.

Quotes were solicited from six (6) companies. One declined to quote. BCS provided the lowest quote.

A motion was made by Kweku Akan, seconded by Carol J. Coen, that the recommendation concerning the Group Life Insurance be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Salary Increase:

Salary Increase

RECOMMENDATION: It is recommended that the Board approve an additional one percent (1.0%) salary increase for current employees for the 2005-2006 contract year, including employee groups:

- Fort Wayne Education Association (FWEA) representing teachers
- Salary Schedules I, II and III
- Meet & Confer Groups (fiscal year)
- Non-union Groups (fiscal year)

It is recommended that the Board approve an additional one percent (1.0%) salary increase for current employees for the 2006 calendar year, including the following employee groups with settled contracts:

- AFSCME, Local 561 representing Custodians, Groundskeepers, Food Service Workers, Secretaries, Media Clerks, Assistants, and Clerks.
- Fort Wayne Classified Association
- Fort Wayne Nurses Association
- Meet & Confer Groups (calendar year)
- Non-Union Groups (calendar year)

It is recommended that the Board approve a one percent (1%) salary increase for current classified substitute employees effective May 1, 2006, excluding those whose salary schedules or union contracts make them ineligible for percentage increases.

RELATED INFORMATION: This increase is an addition to the 1.5% increase approved last fall. The district has a cash balance goal of a minimum of 5% of the budget. At the end of 2005 the cash balance was at about 11% of the budget. In 2003, FWCS cut \$11 million annually from the budget due to unstable economic conditions. Those cuts have resulted in savings of \$26 million since that time and made it possible to avoid a negative cash balance. In addition, positive changes in revenue make it possible to provide this increase. The increase is expected to cost about \$1.8 million annually.

A motion was made by Robert A. Armstrong, seconded by Carol J. Coen, that the recommendation concerning the Salary Increase be approved. Roll Call: Ayes, unanimous; nays, none.
