Occupational Medical, Drug Testing, Physicals and DOT Services

Dr. Robinson presented the following recommendation concerning the Occupational Medical, Drug Testing, Physicals and DOT Services:

RECOMMENDATION: It is recommended that the Board approve Business Health Services as the occupational medical services provider for a three-year period, effective May 1, 2007 through April 30, 2009.

RELATED INFORMATION: Business Health Services (BHS) provided by RediMed, the BHS Clinic and the Lutheran Health Network has been the provider for Fort Wayne Community Schools' occupational medical services since 1997.

Quotes were solicited from three (3) vendors, Business Health Services, Parkview Occupational Health Centers, and U.S. HealthWorks. Responses were received from all three that included fees for selected high volume services.

Business Health will provide employees with the best accessibility due to the number of locations and hours of operation available throughout Fort Wayne. Based upon the 2006 utilization levels, the fees quoted by Business Health are 1.2% and 7.2% lower than those provided by Parkview and U.S. HealthWorks, respectively. The estimated annual cost for the most utilized standard and physical therapy services will be \$146,200. In addition, Business Health has maintained a consistent level of quality service during the course of our professional relationship.

This agreement may be extended annually beyond the second year subject to the agreement of the vendor, provided there are no additional price increase adjustments or changes to the terms of the contract.

Handwriting Adoption 2007-2013 Student Fee Justification 2007-2008

Dr. Robinson presented the following recommendation concerning the Handwriting Adoption 2007-2013 and Student Fee Justification 2007-2008:

RECOMMENDATION: It is recommended that the Board adopt Zaner-Bloser handwriting instructional materials for the school years 2007-2008 through 2012-2013 and student fees for 2007-2008.

It is also recommended that the Board approve submission of a waiver request to the Indiana Department of Education for select schools to use alternative handwriting instructional materials created by the district in the place of the Zaner-Bloser materials.

RELATED INFORMATION: The Indiana State Board of Education adopts handwriting books and related materials for use on a statewide basis according to a legally prescribed six-year cycle. This year is designated for adoption of handwriting materials.

In February 2007, a team of FWCS teachers and parents began reviewing handwriting materials. The committee selected Zaner-Bloser handwriting student books and also recommended that FWCS provide schools the option of using alternative handwriting materials in place of the Zaner-Bloser materials. The state reimburses FWCS for a portion of the textbook costs for free/reduced lunch participants. The state will also reimburse FWCS for a portion of the cost of the alternative handwriting instructional materials if a waiver is approved by the local Board.

Schools wishing to use the alternative materials at one or more grade levels include Arlington, Brentwood, Bunche, Croninger, Fairfield, Forest Park, Glenwood Park, Haley, Harrison Hill, Indian Village, Lindley, Maplewood, Price, St. Joe Central, Scott, Shambaugh, South Wayne, Washington, Washington Center, Waynedale, Weisser Park, and Young. The projected student fees are on file in the superintendent's office for review.
