2005 North Side Traffic Improvements Dr. Robinson presented the following recommendation concerning the 2005 North Side Traffic Improvements:

RECOMMENDATION: It is recommended that the Board approve the appointment of SCO Engineering, LLC as the project engineer for the North Side Traffic Improvements Project. It is further recommended that the Board authorize the Superintendent to enter into a contract with the city of Fort Wayne for joint funding of this project.

RELATED INFORMATION: In an effort to improve traffic safety, FWCS and the city are collaborating on a project to improve Parnell Avenue near the new main entrance to North Side High School. A new traffic signal will be installed on Parnell Avenue at the new entrance to North Side High School. Parnell Avenue will be widened to accommodate new turn lanes into North Side. This new entrance will align with the entrance to North Side Park.

Fees for engineering, project management services, and construction of this project are included in the North Side Bond Fund. Indiana law requires that projects over \$100,000 make use of a registered architect or professional engineer for developing plans and specifications. The budget for this project is \$357,832, with \$154,000 from the city of Fort Wayne and \$203,832 from FWCS.

RELATED INFORMATION: Because of the size and complexity of the North Side Renovation and Addition Project, contract changes can be anticipated. Unforeseen conditions and the acceptance of alternates are normally the reason. Changes to the scope of work are approved only after FWCS personnel consult with the architect and construction manager. These change orders reflect additional work recommended on the project. Funds have been set aside from the bond to cover such occurrences.

Change in Purchasing Policy

Dr. Robinson presented the following recommendation concerning the Change in Purchasing Policy:

RECOMMENDATION: It is recommended that the Board approve an increase in the maximum purchase amount individuals may make without using the services of the Purchasing Department. The maximum purchase amount will be \$500.

RELATED INFORMATION: Board policy currently allows individuals to purchase goods and services up to \$150 without using the services of the Purchasing Department. Raising the purchase limit to \$500 will allow unit heads greater discretion and enable the Purchasing Department to focus more attention on high dollar purchases. Some purchases under \$500 will require a purchase order per Purchasing Department guidelines.

Science and Health Adoption and Kit Refurbishing Dr. Robinson presented the following recommendation concerning the Science and Health Adoption and Kit Refurbishing:

RECOMMENDATION: It is recommended that the Board adopt new science and health instructional materials for elementary, middle and high school use for 2005-2011 and approve the rental fees for those materials.

In addition, it is recommended that the Board authorize the administration to enter into a six-year contract for the refurbishing of elementary science kits for kindergarten through fifth grade with:

ETHOS Science, Elkhart, Indiana \$2,451,552

RELATED INFORMATION: The Indiana State Board of Education adopts instructional materials for use on a state-wide basis according to a legally prescribed six-year cycle. Local communities review texts and identify those that best meet the needs of the students of that particular district. This is the year designated for the adoption of instructional materials in science and health.

Teams of teachers and parents have been reviewing adoption samples since the beginning of the school year and have recommended the continued use of standards-based science kits for K through Grade 5 and the use of identified textbooks for secondary students. The committees' recommendation of elementary science kits for use in FWCS during the time period 2005-2006 through 2010-2011, the costs of the materials and the projected elementary fees for 2005-2006 is explained in the Textbook Adoption packet attached. Also in the packet is a summary of middle school and high school textbook rental fees projected for the 2005-2006 school year in the adoption areas. Materials may be viewed at the State Review Site located in the FWCS Warehouse at 1511 Catalpa Street.

Families unable to pay student fees may apply for financial assistance. Those approved for free or reduced lunch are also eligible for free textbooks.

As was done in the last science adoption, the elementary science kits are rotated from classroom to classroom throughout the district and contain both consumable and non-consumable materials to teach the state science standards and to link science to literacy and mathematics. The contract with ETHOS will provide for the refurbishment of the kits between school rotations, cleaning the kits, supplying teacher preparation materials, delivering animals and plants, and delivering and pickup up of kits based on the kit rotation schedule.

Three vendors, Delta, ECA, and ETHOS, submitted proposals for science kit refurbishment services. The proposal from Delta Education did not meet district requirements and was therefore eliminated from consideration. After evaluation by the Curriculum, Purchasing, Textbook Rental, and Business Departments, it was determined ETHOS submitted the lowest proposal that best meets the district's needs for refurbishment services.

Target Community Giving Grant – Franke Park Elementary School Dr. Robinson presented the following recommendation concerning the Target Community Giving Grant – Franke Park Elementary School:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Target Art in Education Grant from the Target Foundation in the amount of \$3,000 for Franke Park Elementary School.

RELATED INFORMATION: The objective of this grant request is to encourage students to write in response to literature. Students will have canvas bags with books, paper, pencils, writing prompts, etc. to do write-at-home activities. The contact person for this competitive grant is Kimberly Brown-Derck from Franke Park Elementary School.

This program supports advancement intended and outlined in Strategy I - We will ensure high levels of learning for all students.

A motion was made by Jon J. Olinger, seconded by Stephen Corona, that the recommendation concerning the Target Community Giving Grant – Franke Park Elementary School be approved. Roll Call: Ayes, unanimous; nays, none.

Adult and Continuing Education Federal Grants Dr. Robinson presented the following recommendation concerning the Adult and Continuing Education Federal Grants:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a Comprehensive Adult Education Program Grant, a Final Performance Grant, and an English Literacy/Civics Education Program Grant from the Indiana Department of Education, Division of Adult Education by FWCS Adult and Continuing Education.

RELATED INFORMATION: The Comprehensive Adult Education Program Grant monies are used to support an adult education program through the purchase of materials and supplies for student use, and to pay costs for clerical support, administrative and guidance functions, and costs related to assessment and registration. This funding enables FWCS to serve over 2500 adult learners annually who are working toward GED certificates, improving their basic academic skills, and/or English as a Second Language. The Fund Year 2006 Base award in the amount of \$225,327.00 has been set aside for Region 11, comprised of Allen, Whitley, and Huntington Counties. An additional grant in the amount of \$33,000.00 is competitive and, if awarded, will be used to enhance programming and civics education for our adult learners with limited English proficiency in coordination with Workforce Investment Agency partners, literacy programs, and district councils. Eligibility for the combined grants totaling \$258,327.00 is contingent on the maintenance of the current level of local effort at \$70,967.00 per year which pays for some secretarial, custodial, counseling, and administrative costs.

The funds from these grants, written by Dr. Bonnie Rogers, Coordinator of Continuing Education, will be used to support Strategy 1 of the FWCS Strategic Plan, "We will insure high levels of learning for all students."

A motion was made by Robert A. Armstrong, seconded by Carl A. Johnson, that the recommendation concerning the Adult and Continuing Education Federal Grants be approved. Roll Call: Ayes, unanimous; nays, none.

Project RightStart

Dr. Robinson presented the following recommendation concerning the Project RightStart:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the GE Insurance Solutions – Community Relations grant in the amount of \$243,801.85.

RELATED INFORMATION: Project RightStart will help support student achievement in students from poverty areas who are bused due to racial balance. This program will provide needed tutorial services, materials, instructional software, and technology service to students who are unable to attend full-day kindergarten. Five (5) elementary schools, Adams, Arlington, Brentwood, Northcrest, and St. Joe Central, have been targeted for this project over a three year time period.

This is a competitive grant that supports our Strategic Plan – we will ensure high levels of learning for all students.
