Indiana State Finalist in Wrestling

RECOMMENDATION: It is recommended that the Board recognize the North Side High student who was a state finalist in wrestling.

RELATED INFORMATION: North Side High School junior Ta'Quan Walker was a state finalist in wrestling this year. Ta'Quan competed in the 285 lb. weight class at the IHSAA wrestling state finals held February 18-19 at the Conseco Fieldhouse in Indianapolis. Ta'Quan's overall record this year was 26-5. He was an SAC Champion, a Sectional and Regional Champion and placed 3rd at semi-state. In April he will compete in the National Wrestling Championship in Illinois.

The Irwin team placed 8th in Class Four out of 130 schools at the state competition held on March 10 with a score of 23 out of 28 points. Prior to the state competition, over 7,000 students statewide competed in regional competitions to earn a spot at state.

RELATED INFORMATION: From year to year, the prices of meals served by FWCS are reviewed as part of the overall year-end evaluation of the Nutrition Service Department. When warranted, adjustments in meal prices are made. Factors contributing to the meal price recommendations include increased food and supply costs, fuel costs, and wage/benefit costs. The last increase was in 2008.

Improving Literacy through School Libraries Grant

RECOMMENDATION: It is recommended that the Board approve the Improving Literacy through School Libraries Program grant application for \$337,695 for a one year period.

RELATED INFORMATION: The purpose of the Improving Literacy through School Libraries Program grant is to improve student literacy skills and academic achievement by providing increased access to up-to-date library materials and promote a technologically advanced school library media center.

Funds will be used to purchase library books for all grade levels. The books will be at various Lexile levels and a variety of subject matter that would interest the students. Thirty-five mobile devices will be purchased to start a pilot program at Shawnee middle school media center. They will be used as a mobile lab during school hours and provide an after school lab for students who would need more research time.

This competitive grant supports the FWCS district Goal I: *Achieve and Maintain Academic Excellence*. The contact person is Cheryl Rinehart, Media Services Coordinator.

School Improvement Grant – SIG-ARRA **RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of the ARRA funded School Improvement Grant – SIG-ARRA for 2011 from the Indiana Department of Education in the amount of \$172,448 for Miami and Kekionga Middle Schools.

RELATED INFORMATION: Kekionga and Miami Middle Schools have been identified as in need of improvement according to Federal accountability requirements. Furthermore, the state of Indiana requires actions under its Differentiated Accountability Requirements for Comprehensive Schools to ensure that schools are supported in their improvement efforts. The SIG-ARRA grant provides for Miami and Kekionga to:

- have a Math Instructional Coach
- receive coaches' training sponsored by the IDOE
- receive Acuity training
- participate in the Institute for School Leadership sponsored by the IDOE
- be assigned a Distinguished Principal to act as a peer mentor to each principal; and to
- cover costs of transportation for Supplemental Education Services (SES), an after school tutoring program delivered by contracted providers

The grant addresses Goal I, *Achieve and Maintain Academic Excellence* and is managed by Tracy Bunting, Acting Title I Manager.
