2016-17 Adult Education English Literacy and Civics Education Continuation Grant Dr. Robinson presented the following recommendation concerning the 2016-17 Adult Education English Literacy and Civics Education Continuation Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Adult Education English Literacy and Civics Education Continuation Grant for 2016-17 in the amount of \$49,757 from the Office of the State of Indiana Department of Workforce Development.

RELATED INFORMATION: The purpose of the 2016-17 Adult Education English Literacy and Civics Education Continuation Grant is to provide adult English language instruction, integrating all four civics concepts: naturalization, civic engagement, United States history, and government. Funds from this grant will allow for the continuation of a range of services for the FWCS District/Allen County Continuing Education Program for ELL Adult Education programming. The funds in this year's grant are designated for personnel, professional development, and purchased services.

This non-competitive grant, which supports services for adult students seventeen years of age and older, is in the final continuation year before beginning the cycle again in 2017-18 (it was originally going to be a new cycle this year, but WIOA legislation delayed the new cycle until 2017-18). The grant is written by Manager of the Continuing Education Department Patrick Boles and supports FWCS District Goal 1: Achieve and Maintain Academic Excellence and Goal 2: Engage Parents and the Community.

2016-17 Adult Education Continuation Grant Dr. Robinson presented the following recommendation concerning the 2016-17 Adult Education Continuation Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Adult Education Continuation Grant for 2016-17 in the amount of \$962,500 from the Indiana Department of Workforce Development, Division of Adult, Career and Technical Education.

RELATED INFORMATION: The 2016-17 Adult Education Continuation Grant is State funding allocated annually to twelve regions of the State of Indiana. Funds from this grant will allow for the continuation of a range of services for the FWCS District/Allen County Continuing Education Program. The funds in this year's grant are designated for personnel, professional development, instructional materials, supplies, equipment and purchased services.

This non-competitive grant, which supports services for students sixteen years of age and older, is in the final continuation year before beginning the cycle again in 2017-18 (it was originally going to be a new cycle this year, but WIOA legislation delayed the new cycle until 2017-18). The grant is written by Manager of the Continuing Education Department Patrick Boles along with the Region 3 Adult Education Consortium and supports FWCS District Goal 1: *Achieve and Maintain Academic Excellence* and Goal 2: *Engage Parents and the Community*.

Purchase of Apple iPad Air 2s Dr. Robinson presented the following recommendation concerning the Purchase of Apple iPad Air 2s:

RECOMMENDATION: It is recommended that the Board approve the purchase of 1,080 Apple iPad Air 2s.

Apple Inc. Austin, Texas \$403,920

RELATED INFORMATION: Elementary teacher and administrator iPads are due to be replaced. Teachers use these devices for administering the DIBELS assessment and for classroom instruction using engaging applications that provide immediate feedback. These iPads will also allow teachers to support instruction through the use of digital content and the integration of educational apps to enhance instruction and to support differentiation of instruction. Administrators use the iPads for daily observations and evaluations. They are also used to perform various administrative tasks. This purchase will replace existing teacher and administrator iPads at all elementary schools.

Funding will come from the Common School Fund Loan.

Apple Inc. is the sole source provider for their products. Indiana Law does not require bidding for purchases made from sole source providers.

Get Nichols, Assistant Superintendent Elementary, is available to answer questions.

Comments

Board Members questioned what is done with the "old" iPads. Technology Director Jack Byrd and Area Tech Coordinator Matt Brandenberger shared that we sell back to a reseller at \$60-\$80 per device. The new iPads cost \$374 per device.

A motion was made by Julie Hollingsworth, seconded by Becky Hill, that the recommendation concerning the Purchase of Apple iPad Air 2s be approved. Roll Call: Ayes, unanimous; nays, none.

Waiver from Implementation of Protected Taxes

Dr. Robinson presented the following recommendation concerning the Waiver from Implementation of Protected Taxes:

RECOMMENDATION: It is recommended that the Board request from the Indiana Department of Local Government Finance a waiver from implementation of protected taxes for 2016.

RELATED INFORMATION: Since the circuit breaker was implemented in 2009, circuit breaker credits have been applied proportionately to all property tax supported funds. Under IC 6-1.1-20.6-9.8, amended in 2013, implementation of protected taxes provisions was to go into effect in 2014 in order to protect debt service funds. Circuit breaker credits attributable to those funds were to be applied to non-debt service funds.

2014 House Enrolled Act 1062 allowed school corporations with a circuit breaker loss of at least 10%, when compared to non-debt levy, to waive the implementation of protected taxes for two years. 2016 House Enrolled Act 1109 extended the waiver option through 2018.

Questions will be addressed by Chief Financial Officer Kathy Friend.

A motion was made by Julie Hollingsworth, seconded by Becky Hill, that the recommendation concerning the Waiver from Implementation of Protected Taxes be approved. Roll Call: Ayes, unanimous; nays, none.

Student Basic Accident Insurance and Athletic Insurance Dr. Robinson presented the following recommendation concerning the Student Basic Accident Insurance and Athletic Insurance:

RECOMMENDATION: It is recommended that the Board approve a one-year extension, with no increase, for student accident insurance through Specialty Risk Underwriters, Inc. at a cost of \$180,115 for the 2016-17 school year.

RELATED INFORMATION: The underwriter for the recommended insurance is United States Fire Insurance Company (AM Best Rated A). AG Administrators will be the third party administrator for the plan.

The premium for the basic sports and accident insurance for the 2016-17 school year will be \$175,140. This will provide a \$25,000 maximum medical benefit with a \$0 deductible for each student.

The premium for catastrophic coverage will be \$4,975 for the 2016-17 school year. The coverage with a maximum benefit of \$5,000,000 is for middle school athletes only. The IHSAA provides catastrophic coverage for high school athletes.

Optional policies will be available to parents to provide 24-hour coverage and/or extended dental coverage at the expense of the parents.

Questions will be addressed by Stefan Pittenger, Director of Fiscal Affairs.

A motion was made by Jordan Lebamoff, seconded by Julie Hollingsworth, that the recommendation concerning the Student Basic Accident Insurance and Athletic Insurance be approved. Roll Call: Ayes, unanimous; nays, none.

Comments

Board President Mark GiaQuinta noted that a work session will be posted with Learning Forward on May 10. Dates will also be set for the Policy Committee to meet.

Board Member Steve Corona reported that he attended the National School Boards Association annual conference April 9-11, in Boston. He found Tony Wagner, Expert in Residence at Harvard University's Innovation Lab to be a very inspiring speaker. Mr. Corona suggests Board Members read Mr. Wagner's book *Most Likely To Succeed: Preparing Our Kids for The Innovation Era*.

Board Member Becky Hill commented about the dedication and caring of our teachers which she saw in a Facebook comment posted by a parent of a special needs student.

Board Member Julie Hollingsworth commented about research she has read in which the teaching of arts and music in schools helps students be more successful in math. She is proud that FWCS has continued its dedication to teaching art and music. She also commented that she toured the new Construction Trades building and was impressed. They hope to get an HVAC program.

Board President Mark GiaQuinta thanked fellow attorneys in his office and members of the Allen County Bar Association for volunteering their time and giving financial support of the North Side High School We the People team. The team traveled to Washington, D.C. April 23-25, for national finals.
