2009 Physical Education Fitness Stations Installation Project Dr. Robinson presented the following recommendation concerning the 2009 Physical Education Fitness Stations Installation Project:

RELATED INFORMATION: New equipment will be utilized as a part of the curriculum for physical education fitness training and further utilized by area neighborhoods after school hours. Seven vendors submitted proposals for physical education structures at Arlington, Holland, Pleasant Center, St. Joseph Central, Shambaugh, Washington, and Washington Center Schools. Proposals were evaluated by facilities personnel and committees from each school. Funding for this project is from the Capital Project Fund. Installation will be completed by July 31, 2009.

Status of 2010 Budget Planning and Impact on District

Comments and Speaker Superintendent Wendy Robinson will give an update of the 2010 budget planning including the General Fund, Special Education Fund, Title I Funds, and Federal Stimulus Program.

Steve Brace, UniServ Director for Indiana State Teachers Association spoke to the Board about the lay-off being considered in the personnel report the Board will vote on tonight. Mr. Brace expressed concern about the impact this lay-off will have on student instruction, school building atmosphere and individual teachers' lives. Mr. Brace would like to see more administrators and other district groups lobby the legislators to help with the budget. President GiaQuinta asked that Chief Financial Officer Kathy Friend provide Mr. Brace with information about the number of administration jobs being affected.

Board members thanked Dr. Robinson, the administration team and FWEA for their hard work in determining the best way to deal with this difficult situation of the unknown future of the 2010 budget.

President GiaQuinta suggested that we contact corporate leaders to ask their assistance in working with legislators during this budget process and Board member Pamela Martin-Diaz asked about putting information on our website about how to contact your legislator.
