These materials were previously recommended and approved for use in the Foellinger Summer Voyage grant application which was approved in October.

Voyager is the sole source for purchasing their products. Indiana law does not require a bid for sole source purchases. This purchase is being funded through remediation grant money.

Student Basic Accident Insurance and Athletic Insurance, RFP #9482

Dr. Robinson presented the following recommendation concerning the Student Basic Accident Insurance and Athletic Insurance, RFP #9482:

RECOMMENDATION: It is recommended that the Board approve a two-year contract with Student Assurance Services, Inc. of Stillwater, Minnesota, to provide group medical coverage for all middle and high school athletes participating in interscholastic sports.

RELATED INFORMATION: Request for proposals were sent to six student insurance agencies. Responses were received from four. Student Assurance Services, our current agency, specializes in providing medical insurance to educational institutions including over 1,600 public school districts.

The premium is \$140,208 per year; however, if the loss ratio exceeds 70% for the 2006-2007 school year, the 2007-2008 premium will increase to \$153,508.

Premium costs for the athletic insurance for grades 6-12 will be as follows:

- 1. Middle School: \$20.00 per student. An increase of \$1.00 from last year.
- 2. High School: \$42.00 per student. An increase of \$1.00 from last year.

The athletic insurance will continue as a requirement for each student participating in athletics.

Families with two or more senior high children will receive a discount of \$10.00 per child. All student insurance is supplemental to other policies held by parents.

Premium costs for the basic student accident insurance will be as follows:

- 1. Optional School-Time Coverage \$10.00 per student.
- 2. Optional Full-Time Coverage \$59.00 per student.
- 3. Optional Extended Dental \$6.00 per student

McKinney-Vento Transportation Grant

Dr. Robinson presented the following recommendation concerning the McKinney-Vento Transportation Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the McKinney-Vento transportation grant that would provide transportation for homeless children and youth to their school of origin.

RELATED INFORMATION: Through the McKinney-Vento Homeless Assistance Act of 1987, as amended by the No Child Left Behind Act of 2001, federal funds are available to each state to support programs that meet the needs of homeless children and youth. The Indiana Department of Education has identified transportation funding as a critical need for the state's school corporations. As a result, grants will be made available to school corporations for the provision of transportation services to homeless children and youth to their schools of origin.

Grants will be available in the amount of \$10,000; up to eight corporations may receive this funding. First preference will be given to school corporations that do NOT receive other McKinney-Vento funding. Awards will be made based on the demonstrated needs of the school corporation and on a first-come, first-served basis for the period of April 1, 2006, to March 31, 2007.

This competitive grant written by Director of Transportation Lynn Hower supports FWCS Strategy #1: We will ensure high levels of learning for all students.
