K-12 Mathematics Adoption for 2016-2022 and Student Fees for 2016-2017 Dr. Robinson presented the following recommendation concerning the K-12 Mathematics Adoption for 2016-2022 and Student Fees for 2016-2017:

RECOMMENDATION: It is recommended that the Board adopt proposed materials and rental rates for 2016-2022 for use in grades K-12 Mathematics. It is also recommended that the Board approve K-5 student fees for school year 2016-2017.

RELATED INFORMATION: A Mathematics Textbook Adoption Committee was facilitated by the Curriculum Department. This committee included FWCS teachers from each school and parents who reviewed the instructional materials. Teachers and parents recommended the textbooks that met the standards and instructional needs of students in FWCS by piloting, previewing, and evaluating materials from publishers.

Families unable to pay student fees may apply for financial assistance. The State of Indiana reimburses the Fort Wayne Community Schools Textbook Rental Fund for a portion of the textbook rental charges for qualified students and the remainder is supplemented from the General Fund.

The FWCS textbook adoption process addresses district Goal I: *Achieve and Maintain Academic Excellence* and Goal II: *Actively Engage Parents and the Community*.

Questions will be answered by Natalie Brewer, Curriculum Director, Seth Parker and Michelle McWilliams, Curriculum Coordinators, and Sheryl Merchant, Textbook Rental Coordinator.

A copy of the materials and rental rates for 2016-2022 for use in grades K-12 Mathematics is on file in the Superintendent's Office.

A motion was made by Stephen Corona, seconded by Mark GiaQuinta, that the recommendation concerning the K-12 Mathematics Adoption for 2016-2022 and Student Fees for 2016-2017 be approved. Roll Call: Ayes, unanimous; nays, none.

Easement Right-of-Way at Towles Intermediate School and the Catalpa Complex Dr. Robinson presented the following recommendation concerning the Easement Right-of-Way at Towles Intermediate School and the Catalpa Complex:

RECOMMENDATION: It is recommended that the Board ratify the sale of two separate easements and right-of-ways to Indiana Michigan Power Company (I&M), an Indiana corporation and unit of American Electric Power. The purpose of the requisitions is to accommodate electric transmission, distribution and communication lines and appurtenant equipment and fixtures. It is further recommended that the superintendent or her designee be authorized to sign the appropriate documents and take necessary steps to complete these transfers and to grant the power company the temporary license to enter the properties for the purpose of conducting surveys and studies necessary for the upgrade of these power lines.

RELATED INFORMATION: I&M currently is in the process of upgrading their transmission network and both of these easements are needed for them to complete their Melita substation project.

The Towles easement and right-of-way consists of a parcel approximately 16,211 square feet. The easement is on the west end of the Towles Intermediate School site along South Hanna Street. It consists of the widening of an existing easement maintained by I&M. The power company will be replacing the electric transmission towers along this line. I&M has offered to pay a fair market value of \$35,000 per acre for this easement, which consists of 0.372 acres, or \$13,020.

The Catalpa complex easement consists of a parcel approximately 5,960 square feet. The easement is located near the west bank of the Junk Ditch at the northwestern end of the Catalpa complex. The power company will be adding a transmission tower within this easement to tie a new transmission line into an existing line already running through the Catalpa complex. I&M has offered to pay \$40,000 per acre for this easement, which consists of 0.137 acres, or \$5,480.

USA Lift Inc. is the sole source and exclusive distributor for all Stertil-KONI equipment and parts in the state of Indiana.

RELATED INFORMATION: The original design included separation of sanitary and storm water lines as well as underground storm water retention for just the area of cafeteria expansion. It is recommended that the scope be increased to improve these items for the entire campus. In addition, funds are needed due to poorer than anticipated soils and undocumented underground utility conditions.

Reasonable allowances and contingencies are included in base bids for most projects because of conditions or fees not specifically known at the time bids are taken. In the event a major change in project scope is needed, such as this one, a recommendation is made to the Board for approval prior to proceeding. This change will be funded out of the program contingency for the 2012 School Building Basic Renewal/Restoration and Safety Projects. The base bid contingency included in the contract will remain available for other issues that may arise during the construction.

Comments

President GiaQuinta questioned whether FWCS should pay for the cost of the poor soil as any tests should have indicated to the contractor the condition. He also suggested that the City could split the cost of separating the sewer and storm water lines.
