National Scholastic Art Award Winners Art Award Winners **RECOMMENDATION**: It is recommended that the Board recognize FWCS high school students who earned national awards in the Scholastic Art Competition.

**RELATED INFORMATION**: Two FWCS students received National Silver Key Awards from the Scholastic Art Competition. Both students won Gold Keys in the Northeast Indiana and Northwest Ohio Region awards. These works are then sent to New York for the national competition. The Silver Key awards represent less than 1/10 of 1% of all artwork submitted nationally.

Distributive Education Clubs of America (DECA) State Winner **RECOMMENDATION**: It is recommended that the Board recognize Maddie Harvey, a North Side High School student, for qualifying to attend the International Distributive Education Clubs of America (DECA) Career Development Conference by placing 2<sup>nd</sup> in the state DECA competition.

**RELATED INFORMATION**: DECA is a national organization that helps students develop skills and competence for marketing careers, build self-esteem, experience leadership, and practice community service. It allows students to showcase their business skills by competing in 26 different areas, such as Role Plays, research papers, quiz bowls and computer simulations.

This year Maddie Harvey competed in the Individual Role Play event of DECA. She had to take a 100 question test and then participate in two role plays. Individual role plays have ten minutes to prepare before going in front of two judges, when they convince the judge that they solved the situation better than the other contestants. Maddie placed second in the state competition, earning the honor of competing at the International Conference.

# Scholastic Platinum Performer

**RECOMMENDATION**: It is recommended that the Board recognize Northwood Middle School for being named a Platinum Performer by Scholastic for its incredible implementation of the *READ 180* program.

**RELATED INFORMATION**: The *READ 180* Platinum Performers program is designed to recognize outstanding sites that have demonstrated success with *READ 180*. These select schools are leaders in implementation that exhibit exceptional student performance and achieve extraordinary results.

Angie Ryan is a *READ 180* teacher who has received outstanding results from her students in this program and has served as a model classroom for districts throughout Northeast Indiana to visit. Angie is supported in her quality implementation by Principal Matt Schiebel.

#### Vouchers

Dr. Robinson presented the vouchers for the period ending May 12, 2008, with the recommendation the vouchers be approved. A motion was made by Carol J. Coen, seconded by Jon J. Laptop Computers for Special Education Teachers Dr. Robinson presented the following recommendation concerning the Laptop Computers for Special Education Teachers:

**RECOMMENDATION**: It is recommended that the Board approve the purchase of 300 laptop computers for Special Education Teachers from Bell Technologies of Indianapolis, IN for \$302,160.

**RELATED INFORMATION**: This purchase is for 300 laptop computers to be utilized by Special Education teachers. Quotations were obtained from Bell and Gateway each of which has an Indiana QPA (Quantity Purchasing Agreement) contract for computer purchases. Indiana law does not require public bidding for purchases made at or below State QPA pricing. Due to the quantity of laptops being purchased, FWCS was able to negotiate pricing 28% below QPA prices.

These computers will be purchased through a 48-month lease agreement with Covenant Financial at a 0% interest rate. The lease will consist of four annual payments of \$75,540 with a final payment of \$37,500 (\$125 per laptop). If FWCS decides to replace some or all of the laptops at lease end, the vendor will arrange to sell them at market value and apply the proceeds towards the final payment.

A motion was made by Jon J. Olinger, seconded by Kevin Brown, that the recommendation concerning the Laptop Computers for Special Education Teachers be approved. Roll Call: Ayes, unanimous; nays, none.

Harrison Hill Roof Emergency Project

Dr. Robinson presented the following recommendation concerning the Harrison Hill Roof Emergency Project:

**RECOMMENDATION**: It is recommended that the Board approve a construction project to resolve roofing issues at Harrison Hill School.

#### **Estimates:**

Professional Services \$30,000

It is further recommended that the Board declare that an emergency exists at Harrison Hill School and that \$520,000 from the emergency account in the Capital Projects Fund be allocated for the payment of items related to the repair of the Harrison Hill roof.

**RELATED INFORMATION**: Leaking issues on the roof at Harrison Hill School result in plaster damage inside the school. Various repair attempts have not stopped the leaks. Our roofing consultant is recommending the above work to correct the problem.

With the approval of this recommendation, Facilities will begin soliciting quotes from qualified contractors. Planning is under way so that the work can begin as soon as possible to alleviate further damage to the building.

A motion was made by Mitch Sheppard, seconded by Jon J. Olinger, that the recommendation concerning the Harrison Hill Roof Emergency Project be approved. Roll Call: Ayes, unanimous; nays, none.

Adult and Continuing Education Federal Grants Dr. Robinson presented the following recommendation concerning the Adult and Continuing Education Federal Grants:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of a Comprehensive Adult Education Program Grant, Final Performance Grant, English Literacy/Civics Grant, and Outreach Grant from the Indiana Department of Education, Division of Adult Education by FWCS Adult & Continuing Education.

**RELATED INFORMATION**: The Comprehensive Adult Education Program Grant monies are used to support adult education programs, paying for materials for student use, classroom assistants, clerical support, administrative and guidance functions, and costs related to assessment and registration. This funding enables FWCS to serve over 2500 adult learners annually who are working toward high school or GED diplomas, improving basic academic skills, and/or are English Language Learners. The Fund Year 2009 base award of \$225,327.00 has been set aside for Region 11, comprised of Allen, Whitley and Huntington Counties. An additional final performance grant in the amount of \$2,280.00 is based on program outcomes from Program Year 2007.

In addition to the Comprehensive and Performance Grant, Continuing Education would like to apply for an English Literacy/Civics Grant in the amount of \$35,000.00 and an Outreach Grant in the amount of \$28,000.00.

The \$35,000.00 EL/Civics grant will fund an additional English Literacy evening class to serve newly arriving immigrants. Additional civics education curriculum will also be integrated into our existing English literacy classes through the purchase of curriculum materials.

Funding from the \$28,000.00 Outreach grant will be used to hire a reading specialist to teach low-level learners at Allen County Juvenile Center. Nine hours per week of intensive individualized reading instruction will help incarcerated young adults improve their reading skills and their potential to benefit from further learning opportunities upon their release.

Eligibility for the combined grants is contingent on the maintenance of local effort at \$78,466.00 per year which pays for some secretarial, custodial, counseling, and administrative costs.

Dr. Bonnie Rogers, Coordinator of Continuing Education, is the contact person for these grants which support District Goal I: *Achieve and Maintain Academic Excellence*.

A motion was made by Mitch Sheppard, seconded by Stephen Corona, that the recommendation concerning the Adult and Continuing Education Federal Grants be approved. Roll Call: Ayes, unanimous; nays, none.

# Early Intervention Grants

Dr. Robinson presented the following recommendation concerning the Early Intervention Grants:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of Early Intervention Grants from the Indiana Department of Education in the amount of \$22,000.

**RELATED INFORMATION**: The Early Intervention Grants are being submitted to support early intervention programs for young children. The grants provide reimbursement for continued training of district Reading Recovery teachers as required for their certification. The grant period is for one year.

The grant application supports District Goal I: *Achieve and Maintain Academic Excellence* and District Goal II: *Engage Parents and the Community*.

A motion was made by Kevin Brown, seconded by Mitch Sheppard, that the recommendation concerning the Early Intervention Grants be approved. Roll Call: Ayes, unanimous; nays, none.

# GQE Remediation Grant

Dr. Robinson presented the following recommendation concerning the GQE Remediation Grant:

**RECOMMENDATION**: It is recommended that the Board approve the Indiana Department of Education's Graduation Qualifying Examination (GQE) Remediation Grant in the amount of \$216,652.60.

**RELATED INFORMATION**: The Department of Education will distribute funds to Fort Wayne Community Schools before June 30, 2008. The 2008 distribution was based on the 2007 test results. The funds will be available to remediate 10<sup>th</sup>, 11<sup>th</sup>, and 12<sup>th</sup> grade students who fall below state proficiency standards and for preventive remediation methods.

The GQE Remediation Grant is a non-competitive entitlement grant which promotes District Goal I: *Achieving and Maintaining Academic Excellence.*
