Retirement Severance Plan Documents Dr. Robinson presented the following recommendation concerning the Retirement Severance Plan Documents:

**RECOMMENDATION**: It is recommended that the Board authorize the Superintendent to execute all required documents in order to implement the retirement severance benefit plans.

**RELATED INFORMATION**: The buyout of retirement severance obligations requires that employee deposits be made to new accounts. AIG Valic, MetLife, ISTA and Rehn & Associates are companies who will receive those deposits. Fort Wayne Community Schools will enter into agreements with each of those companies.

A motion was made by Carl A. Johnson, seconded by Jon J. Olinger, that the recommendation concerning the Retirement Severance Plan Documents be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Extended Day Child Care Program Agreement:

Extended Day Child Care Program **RECOMMENDATION**: It is recommended that the Board approve a one (1) year extension of the relationship between Fort Wayne Community Schools and the YMCA of Greater Fort Wayne to serve as the provider for the Extended Day Child Care Program at selected elementary school sites.

**RELATED INFORMATION**: Indiana Code 20-5-2-1.5 requires each school corporation to offer on school grounds a school-age child care program that, at a minimum, is operated after the school day and is available to all of that corporation's students in preschool through grade 6. Board Policy 2262 also provides for FWCS to offer an Extended Day Child Care Program.

The after-school program will continue to operate at nine (9) elementary schools, including: Abbett, Glenwood Park, Haley, Indian Village, Maplewood, Northcrest, St. Joseph Central, Irwin and Franke Park. A before-school program will be available at five (5) sites: Glenwood Park, Indian Village,

Maplewood, Abbett and Franke Park. Since enrollment determines final site selections, it is possible that additional sites may be added after the fall school term begins. A half-day Extended Day Child Care Program will also be available at two (2) sites: Arlington, and Pleasant Center. There will be a price increase of \$1.00 per day for the first time in three years, making the after-school fee \$45 per week and the before-school fee \$35 per week. Financial assistance will be available on a sliding scale as determined by guidelines from the Division of Family and Children's Services for use by state funding agencies.

The YMCA has successfully conducted the Extended Day Child Care Program in FWCS for the past thirteen years. During the 2003-2004 school year approximately 600 children participated in the program.

This agreement is in support of the 2004 Strategic Plan, Strategy 4 - We will function as a center of learning in the community; FWCS partners with businesses and community agencies.

A motion was made by Carl A. Johnson, seconded by Kurt A. Walborn, that the recommendation concerning the Extended Day Child Care Program Agreement be approved. Roll Call: Ayes, unanimous; nays, none.

State Farm Insurance Donation – Northwood Middle School Dr. Robinson presented the following recommendation concerning the State Farm Insurance Donation – Northwood Middle School:

**RECOMMENDATION**: It is recommended that the Board approve the acceptance of a donation from State Farm Insurance in the amount of \$4000 for Northwood Middle School.

**RELATED INFORMATION**: State Farm Insurance Company created a fund to support schools' high achievement within their communities. This donation will provide additional support to Northwood's Continuous School Improvement Plan for tutorial and enrichment. Northwood will use the Student Success Process for in-school remediation and enrichment to address the needs of all students. Students who are struggling with comprehension will be given extra reading time. Students who are reading above grade level will receive enrichment literature activities. The contact person for this grant award is Linda Roman, principal, at Northwood Middle School.

This program supports advancement intended and outlined in Strategy VII, Student-Centered Environment.

A motion was made by Robert A. Armstrong, seconded by Carl A. Johnson, that the recommendation concerning the State Farm Insurance Donation – Northwood Middle School be approved. Roll Call: Ayes, unanimous; nays, none.

Full-Day Kindergarten Grant Dr. Robinson presented the following recommendation concerning the Full-Day Kindergarten Grant:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of the 2004-2005 Full-Day Kindergarten Grant.

**RELATED INFORMATION**: The purpose of this grant is to provide full-day programs to improve the academic and social development of children in kindergarten.

The grant opportunity is open to all public school corporations in Indiana. The funds available for the 2004-2005 school year total \$8,500,000, the same as the 2003-2004 allocation. If all public school corporations choose to participate, the minimum grant award would be equal to a school corporation's ADM for 2004-2005 multiplied by approximately \$8.50 – or about \$250,000 for FWCS. In 2002-2003 FWCS received \$454,580 for this program and in 2003-2004 FWCS received \$463,729.

A motion was made by Carl A. Johnson, seconded by Jon J. Olinger, that the recommendation concerning the Full-Day Kindergarten Grant be approved. Roll Call: Ayes, unanimous; nays, none.

#### Early Intervention

Dr. Robinson presented the following recommendation concerning the Early Intervention Grant:

**RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of Early Intervention Grants from the Department of Education in the amount of \$722,580.

**RELATED INFORMATION**: The Indiana Department of Education requested competitive grant applications to support early intervention programs for young children. A grant is being submitted by the district to provide reimbursement for training of two Reading Recovery Lead Teachers at Purdue University with the agreement that they will provide service to FWCS for three years following the training. The grant also provides reimbursement for continued training of district Reading Recovery teachers as required for their certification.

In a sub grant, twelve elementary schools (Arlington, Brentwood, Croninger, Forest Park, Harris, Harrison Hill, Holland, Indian Village, Pleasant Center, Price, Shambaugh, and Washington Center) have requested funds to extend kindergarten programs from a half day to a full day for identified students in greatest need of additional reading instruction.

The grant period is for one year and coordination of the grants rests with individual principals and Schauna Findlay.

A motion was made by Stephen Corona, seconded by Geoff Paddock, that the recommendation concerning the Early Intervention Grant be approved. Roll Call: Ayes, Carol J. Coen, Robert A. Armstrong, Stephen Corona, Carl A. Johnson, Jon J. Olinger, and Geoff Paddock; nays, Kurt A. Walborn.
