RECOMMENDATION: It is recommended that the Board approve the proposal for and acceptance of a grant for \$75,000 through the Indiana Department of Education McKinney-Vento Act. This request is for the first year of a three year grant. These funds will be used to support the Fort Wayne Community Schools (FWCS) Homeless Assistance Program.

RELATED INFORMATION: Federal funding through the McKinney-Vento Act is one component of a program which would enable Fort Wayne to provide assistance for homeless students that reside in the district.

During the 2015-16 school year, approximately 765 students were assisted through the program which includes 8 shelters and several hotels/motels in the community.

The funds are distributed as grants by the Indiana Department of Education for local education agencies to establish educational programs which promote the identification, enrollment, attendance, and success of homeless children and youth in school and preschool. The request of \$75,000 will be used to provide support, remediation, instructional materials and supplies, partial salary, and other related services to FWCS homeless children and their families.

This competitive grant was prepared by Wendy Hoering, Fort Wayne Community Schools' Homeless Liaison, and supports FWCS Goal I: *Achieve and Maintain Academic Excellence*.

Secured School Safety Grant for 2016-17 Dr. Robinson presented the following recommendation concerning the Secured School Safety Grant for 2016-17:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a grant for a School Resource Officer at Miami Middle School through the Indiana Department of Homeland Security FY17 Secured School Safety Grant in the amount of \$50,000.

RELATED INFORMATION: The Secured School Safety Grant was created in 2013 to make Hoosier schools safer. The program is a dedicated state grant fund that provides matching grants to school corporations, charter schools, or a coalition of school corporations and/or charter schools.

This competitive grant, written by Dottie Davis, Director of Security, and Deb Morrone, consultant, supports the FWCS Goal I: *Achieve and Maintain Academic Excellence through Safe and Supportive Schools*.

2016 Comprehensive School Safety Initiative (CSSI) Dr. Robinson presented the following recommendation concerning the 2016 Comprehensive School Safety Initiative (CSSI):

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of funding for a Short Term Study on School Safety through the U.S. Department of Justice, Office of Justice Programs, National Institute of Justice in the amount of \$200,000-\$700,000 for a 12-24-month period of study.

RELATED INFORMATION: The Comprehensive School Safety Initiative ("CSSI") funds research to produce practical knowledge that can improve the safety of schools and students. FWCS will partner with Ball State University and the Fort Wayne Police Department to study whether having law enforcement personnel certified in the Crisis Intervention Team Program will reduce arrest/criminal justice involvement and decrease future school safety violation incidents. The goal is to recognize and address mental health issues in the student population as a means to reduce school violence.

This competitive application written by Dottie Davis, Director of Security, and Deb Morrone, consultant, supports the FWCS Goal I: *Achieve and Maintain Academic Excellence through Safe and Supportive Schools*.

The bid is part of the scheduled replacement of the bus fleet. The trade-in buses will be disposed of by use of an online auction. Funding for these purchases will be from the 2015 Bus Replacement Fund.

Comments

Board Members expressed condolences to the staff and students at Miami Middle School and the family of Scott Hanni, a Miami media teacher who was killed in a bicycle accident last week.

Board Member Becky Hill attended the FWCS retirement dinner and commented on what a great evening it was with many great stories. Board Members wished the retirees well and thanked them for their service to FWCS.

Board Members thanked Betty Stein for her years of service as a teacher and volunteer with students and the Middle School Speech Contest. To celebrate Betty, the traveling trophy for the speech contest is being renamed the Betty Stein Award.

Board Member Becky Hill displayed the new North Side High School Logo to Board Members. The logo had been unveiled at school just prior to the Board meeting and she encouraged people to watch the local news this evening. Board Members congratulated the North Side students, staff, alumni and all those involved in the process to change the name and logo.

Board Member Julie Hollingsworth commented about meetings taking place in Fort Wayne hosted by the Friedman Foundation for Educational Choice. The foundation promotes its vision of "school choice" for all children and meets with legislators and local policy makers to advance that effort. This work is being done at the expense of lost funding for public schools because of the voucher programs. Charter and private schools have fewer regulations and accountability requirements.

Dr. Robinson has been appointed by State Superintendent of Schools Glenda Ritz to serve on the panel to review ISTEP and State assessments. The first meeting of this group will take place tomorrow, Tuesday, May 24 in Indianapolis. She will keep Board Members informed of the progress.

President Mark GiaQuinta shared that he took local realtors to visit Towles Intermediate School today and they were very impressed. Mark noted that many good things happen in all FWCS schools. Mr. GiaQuinta also shared with Board Members that he had been contacted by Niki Kelly of the Journal Gazette to comment on the Friedman Foundation's work. Mark told Ms. Kelly, as a private citizen of Indiana he thought the voucher program is a "despicable fraud and a scam." He wanted Board Members to know that the statements he made were as a private citizen, not a member of the Board.
