RECOMMENDATION: It is recommended that the Board recognize the North Side High School Conexus program and teacher Phillip Springer for receiving the Legacy School of the Year Award.

RELATED INFORMATION: Conexus Indiana is an initiative to capitalize on emergent opportunities in advanced manufacturing and logistics and is focused on issues like workforce development. Conexus Indiana's Advanced Manufacturing and Logistics (AML) Curriculum Development Program, Hire Technology, is a two-year program rolled out in coordination with the Indiana Department of Education and Ivy Tech Community College. The program facilitates student achievement by including contextualized math and science concepts to reinforce key academic STEM concepts while promoting the development of the applied problem-solving skills demanded by the AML industry members.

This award is given to the Hire Technology School that has demonstrated the most outstanding instructional model, industry engagement and student success. North Side High School was selected from schools across the state because of its strong commitment to helping students achieve successful careers in advanced manufacturing and logistics.

The request of \$75,000 will be used to provide support, remediation, instructional materials and supplies, and other related services to Fort Wayne Community Schools homeless children and their families.

This competitive grant was prepared by Judith A. Platz, Manager of Pupil Personnel and Kayata Earley, Fort Wayne Community Schools' Homeless Liaison, and supports FWCS Goal I: *Achieve and Maintain Academic Excellence*. Questions will be addressed by Judith A. Platz.

The power company will be replacing the electric transmission towers along this line. I & M has offered to pay a fair market value of \$10,000.00 per acre for the easement, which consists of 0.242 acres, or \$2,420 dollars. The power company has the ability to take necessary easements by eminent domain if required to do so.

Questions will be answered by Director of Facilities Darren Hess.

A motion was made by Glenna Jehl, seconded by Julie Hollingsworth, that the recommendation concerning the Easement Right-of-Way at Washington Center Elementary School be approved. Roll Call: Ayes, unanimous; nays, none.
