Report of 2010 Gifts, Grants, and Donations

Occupational Medical, Drug Testing, Physicals and DOT Services **RECOMMENDATION**: It is recommended that the Board approve Business Health Services as the occupational medical services provider for a two-year period, effective July 1, 2011 through June 30, 2013.

RELATED INFORMATION: Business Health Services (BHS), provided through the RediMed Clinic, the BHS Clinic, and the Lutheran Health Network, has been the source for Fort Wayne Community Schools' occupational medical services since 1997.

Quotes were solicited from both local vendors, Business Health Services and Parkview Occupational Health Centers. Responses included fees for selected high volume services.

Business Health has maintained a consistent level of quality service during the course of our professional relationship. The number of locations and hours of operation available throughout Fort Wayne have also offered employees excellent access to care. Based upon the 2010 utilization levels, the fees quoted by Business Health are 27.7% lower than those provided by Parkview. The estimated annual cost for the most utilized standard and physical therapy services will be \$74,780. In addition, Business Health has lowered a number of their fees from our previous agreement including an additional 40% discount on Non-Emergency Hospital Services.

This agreement may be extended annually beyond the second year subject to the agreement of the vendor provided there are no additional price increase adjustments or changes to the terms of the contract.

Medicaid Reimbursement **RECOMMENDATION**: It is recommended that the Board approve a one-year contract renewal with Go Solutions Group, Inc. to provide Fort Wayne Community Schools with Medicaid reimbursement services.

RELATED INFORMATION: Reimbursable services include speech/language therapy, occupational therapy, physical therapy, social work, nursing and individual psychological evaluations for eligible Special Education students. Go Solutions Group, Inc. of Lansing, Michigan has provided a web based program since 2004. Their fee is based on \$0.20 per IEP student and \$0.80 per claim, the same rate as the 2010 renewal. The funds recovered will help support current Special Education expenditures paid from the General Fund. In 2010, \$409,711.58 was collected net of their fee.

Student Basic Accident Insurance and Athletic Insurance **RECOMMENDATION**: It is recommended that the Board approve a two year agreement for student accident insurance through Special Markets Insurance Consultants, Inc. at a cost of \$160,949 for 2011-2012.

RELATED INFORMATION: The underwriter for the recommended insurance is Gerber Life Insurance Company (AM Best Rated A). Administrative Concepts, Inc. will be the third party administrator for the plan.

We received proposals from six agents specializing in student insurance. Special Markets Insurance Consultants, Inc. provided the lowest premium for the coverage we requested. The premium for the basic sports and accident insurance for the 2011-2012 school year will be \$158,000. That is a \$3,560 decrease from the year before. This will provide a \$25,000 maximum medical benefit with a \$0 deductible for each student. The maximum premium increase the Company may require for 2012-2013 is limited to 10%.

The premium for catastrophic coverage will be \$2,949 for the 2011-2012 school year which is a \$1,148 decrease from year before. The premium for catastrophic coverage is not guaranteed for 2012-2013. The coverage with a maximum benefit of \$7,500,000 is for middle school athletes only. The IHSAA provides catastrophic coverage for high school athletes.

Optional policies will be offered at registration time to provide 24-hour coverage and/or extended dental coverage at the expense of the parents.

Alternative Education 2011-2012 Renewal Grant / Administrator's Survey

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Alternative Education Grant from the Indiana Department of Education.

RELATED INFORMATION: Funding for the grant is based on the number of full-time equivalent (FTE) student enrolled in the following programs: Allen County Juvenile Center, Expectant Mothers Program at Anthis Career Center, L. C. Ward Education Center, and Youth Life Skills. The district received \$193,525.74.

Alternative Education is designed to meet the needs of at-risk students who are not succeeding in the traditional setting. Students are provided with a variety of options that can lead to graduation and are supported by services for the student and their immediate family that are essential to success.

Johnnie Grimes, Pyramid for SuccessTM Coordinator is responsible for this non-competitive grant which supports Goal I: *Achieve and Maintain Academic Excellence*.

Recommendation for Digital Copiers, RFP #100470

RECOMMENDATION: It is recommended that the Board approve a five-year contract for the period July 1, 2011 to June 30, 2016 with the vendor providing the lowest most responsible and responsive proposal for digital convenience and production copy machines on a cost-per-impression basis:

Fort Wayne, IN \$0.0079 per monochrome (convenience) \$0.0039 per color (convenience) \$0.0079 per monochrome (production) \$0.034 per color (production)

RELATED INFORMATION: The Request for Proposals (RFP) specified a sixty month lease contract on a cost-per-impression basis to replace 306 existing convenience digital copiers located throughout the district and 4 existing production copiers located in Printing Services. The contract includes equipment, maintenance, and all supplies except paper. The total cost is estimated at \$3,320,000 based on a contract volume of 350 million monochrome convenience impressions, 7.5 million color convenience impressions, 30 million monochrome production impressions and 750 thousand color production impressions.

The cost-per-impression for the convenience copiers reflects a 33% decrease when compared to the last RFP awarded in 2006. The cost-per-impression for the production copiers reflects an overall increase of 34% when compared to the last contract awarded in 2006. The net result is an annual savings of \$214,200.

RFP packages were mailed to 26 vendors with 8 responding. Indiana Carbon Company, Indianapolis, IN and Office Concepts, Inc, Fort Wayne, IN responded with "No Bid". Responses were received from the following vendors:

School Computer Purchase **RECOMMENDATION**: It is recommended that the Board approve purchasing 3,269 computers from Hewlett-Packard Direct for the amount of \$2,163,121.00. Additional purchases will be made from Bell Technologies of Indianapolis for \$270,705.89 for software and MCPc of Cincinnati for \$54,370 for imaging and tagging services.

RELATED INFORMATION: FWCS applied to the State of Indiana for the Common School Fund (CSF) loan grant both this past winter and spring. FWCS was awarded both grants for a total of \$3,900,000. As a part of both applications, \$3,546,500 was specified for replacing outdated computers for staff and students, and adding computers for on-line ISTEP testing. Because of the purchase volume, Hewlett-Packard was able to obtain pricing significantly below the General Services Administration (GSA) contract, saving FWCS more than \$440,000. Because of the significant savings, no bid is required.

Full Day Kindergarten Grant Dr. Robinson presented the following recommendation concerning the Full Day Kindergarten Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the 2011-2012 Full Day Kindergarten Grant.

RELATED INFORMATION: The purpose of this grant is to provide full day programs in all schools to improve the academic and social development of children in kindergarten.

The grant opportunity is open to all public school corporations in Indiana. The funds available for the 2011-2012 school year total \$81.9 million. If all public school corporations chose to participate, the minimum grant award would be equal to \$1066 per full day kindergarten student or about \$2.6 million for FWCS.

A motion was made by John Peirce, seconded by Julie Hollingsworth, that the recommendation concerning the Full Day Kindergarten Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Student Rights and Responsibilities Behavior Code 2011-12 Dr. Robinson presented the following recommendation concerning the Student Rights and Responsibilities Behavior Code 2011-12:

RECOMMENDATION: It is recommended that the Board approve the 2011-2012 Student Rights and Responsibilities Behavior Code.

RELATED INFORMATION: The Student Rights and Responsibilities Behavior Code, first created in 1996, was developed to assist schools in providing consistency and fairness in disciplinary matters. This year, changes were recommended by the Student Management and Resource Team (S.M.A.R.T.) review committee and approved by legal counsel.

The Student Rights and Responsibilities Behavior Code will be a section included in the Student Parent Handbook. It will be published and mailed to each FWCS family before August registration.

A motion was made by Stephen Corona, seconded by John Peirce that the recommendation concerning the Student Rights and Responsibilities Behavior Code 2011-12 be approved. Roll Call: Ayes, unanimous; nays, none.

End-of-Year Report

Superintendent Wendy Robinson provided the Board with an end-of-year report, including the recognition of principals and staff at LEAD schools.

Comments

Board member John Peirce commented that he visited schools this week and it was good to see the celebrations of successes and the evidence of students, parents and staff working together on student achievement.

Board member Stephen Corona congratulated Rolunda Suttle, a former Job Works employee, who was listed on the Personnel Report as an Assistant Principal at Snider.

Board member Julie Hollingsworth commented that she and Board member John Peirce visited the classroom of Social Studies Teacher Emily Oberlin at South Side to partake in activities.

Board member Becky Hill commented that she visited schools today, the last day of school, and was impressed that she found "business as usual."

Board President Mark GiaQuinta thanked teachers and leaders from Fort Wayne Education Association for the decision not to "protest" at the Board meeting this evening because it would have taken the spotlight away from student recognitions. Mr. GiaQuinta also commented about his appreciation of community leaders who have passed away and left a positive mark on the community.
