FWCS Custodial Services Agreement Dr. Robinson presented the following recommendation concerning the FWCS Custodial Services Agreement:

RECOMMENDATION: It is recommended that the Board authorize the Superintendent or her designee to sign an agreement with Sodexo to outsource custodial services.

RELATED INFORMATION: As part of ongoing efforts to reduce costs due to declining revenues, FWCS issued a Request for Proposals (RFP) for the outsourcing of custodial services and received 10 responses. Of those, five were interviewed and asked to submit best offers. A selection committee, after review, recommended contract negotiations with Sodexo primarily based upon their approach to employees, including wages and benefits. Contract negotiations resulted in the agreement we ask the Board to authorize tonight, and which contains the following terms:

- 1. Sodexo must comply both with the contract and the RFP;
- 2. The contract is for three years, with the first year secured with a performance bond and the last two years subject to cancellation upon 60 days notice;
- 3. Sodexo will clean all buildings to standards as established in the RFP.
- 4. Current FWCS employees losing jobs as a result will have the right to interview with Sodexo, and, if hired, will maintain seniority and accrued sick time, as well as health insurance coverage without a gap between FWCS' insurance and Sodexo.
- 5. Sodexo will become responsible for all custodial employee performance, training and supervision, and will conduct required pre-employment screening on all new employees at any FWCS facility.
- 6. FWCS will pay Sodexo \$7,193,974 per year during the agreement. Hourly rates are also stated if FWCS requests additional work beyond the contract requirements.

Contract Report

Chief Financial Officer Kathy Friend shared a report on the Custodial Services Contract.

Speakers

Ms. Michelle Tribolet, representing American Federation of State, County, and Municipal Employees (AFSCME) spoke to the Board about the custodial outsourcing issue. She and other custodians do much more than clean buildings and if services are outsourced, she thinks that FWCS will not get the dedication from custodians we currently have.

Ms. Angie Hayden Sutton representing Save Our School spoke to the Board in disagreement with outsourcing custodial services. Save Our School stands in solidarity with AFSCME.

A motion was made by Stephen Corona, seconded by Mitch Sheppard, that the recommendation concerning the FWCS Custodial Services Agreement be approved. Comments

Several Board members commented that the decision they made on the custodial outsourcing was difficult but necessary considering the budget cuts that FWCS faces this year and projected cuts in the following years. They expressed regret that FWCS employees would lose jobs.

Mitch Sheppard asked about the release of ISTEP results. Superintendent Robinson informed Board members that the Indiana Department of Education plans to release scores on Wednesday, June 16, 2010. Until that time the information is embargoed.

Kevin Brown thanked the members of AFSCME for their dedication to FWCS. Mr. Brown encouraged parents to enroll their children in the Lifetime Sports Academy. This is a free program offered by the Fort Wayne Parks and Recreation Department at McMillen Park from June 14 through July 30.

Becky Hill expressed appreciation to Michelle Tribolet for attending meetings and representing the people of AFSCME. Ms. Hill encouraged custodial workers to apply for the jobs with Sodexo. We have good people now and they will continue to be good employees under new management. Becky commented that it was a highlight to attend the Adult English Language Learners' certificate ceremony at Anthis on June 8, as well as the Snider graduation on Saturday, June 12.

Pamela Martin-Diaz encouraged students to go to the library and read.

John Peirce said that he was proud of teachers and administrators and thanked them for a good year. Mr. Peirce is disappointed that FWCS can't afford to have summer school to keep students engaged and prevent slipping of knowledge gained.

Mitch Sheppard congratulated Blackhawk Middle School Teacher Justin Edwards for being named on *The Journal Gazette's* teacher honor roll.

Board member Stephen Corona congratulated Franke Park Elementary School Teacher Jarod Leasure for being named on *The Journal Gazette's* teacher honor roll.

Mark GiaQuinta reviewed major accomplishments and challenges faced by the district this school year. FWCS continues to improve academic achievement for all students and close the achievement gap. Mr. GiaQuinta apologizes for the pain caused by decisions made, but can't apologize for the decisions because they were made to achieve the goals of the Board. Mr. GiaQuinta thanked Dr. Robinson and staff for the work done this year and for the strength to make difficult decisions.

Superintendent Wendy Robinson thanked the Board for its work toward the district goals. She reported that after attending a meeting with other district superintendents, State Superintendent Tony Bennett, and legislators, it is likely that the cuts to education budgets will continue next year.
