Vouchers

Dr. Robinson presented the following recommendation concerning the Amendment to the 2007 Capital Projects Fund Plan:

Amendment to the 2007 Capital Projects Fund Plan

RECOMMENDATION: It is recommended that the 2007 Capital Projects Fund Plan be amended to include the adjustments identified on the attached list and that the Board hold a hearing and adopt the attached resolution to modify the 2007 Capital Projects Fund Plan.

RELATED INFORMATION: The State of Indiana requires the Board to hold a hearing and pass a resolution authorizing any changes in the Capital Projects Fund Plan. Needed funding will come from reassigning revenue for the following proposed changes:

Franke Park – The mechanical system at Franke Park School is failing and this project will replace the steam boiler with hot water type. All existing unit ventilators will be replaced with more efficient units and the mechanical piping will be replaced. A new chiller will be installed to provide cooling and the window wall system will be replaced with a more energy efficient system. The original budget was not sufficient due to increases in building material costs.

Roofs – The Tectum roof deck panels on Northrop High School are failing and need replacing. The Tectum panels help support the roofing system above. This project will start the replacement of these panels that were part of the original construction of the building.

School Programmatic Needs – Reduced because projects can be delayed another year. Projects selected by schools which can be held were identified and cancelled for this year.

Site – Projects are reduced for work that can be delayed for another year. Projects were planned and then cancelled as they were identified that they could be held for another year.

Fixed and Mobile Equipment – School equipment needs is a large part of this line but each year the budget includes a small amount for unassigned equipment, in the event that revenues are above or below projections. By reducing the unassigned budget, the funds are available for other projects.

HEARING: As published in the local newspapers on June 15 and June 22, 2007, this meeting is the official hearing for the modification of the 2007 Capital Projects Fund Plan. No one spoke.

It is further recommended that items listed on page two be withdrawn from the bid because of menu changes, the receipt of government commodities, or the absence of an acceptable bid.

RELATED INFORMATION: This bid is for 506 food items to be used in the school lunch program at the Food Service Center and the 11 cooking kitchens from July 23, 2007 through July 18, 2008. The bid includes such items as fruits and vegetables, meat, and staples such as flour, sugar, and salt. The specifications for this bid indicated that FWCS reserves the right to award bids such that no fewer than ten (10) items are supplied by any one vendor.

A comparison of prices by item is on file in the Purchasing Department and may be reviewed upon request. Overall, the prices of the recommended bidders reflect a less than one percent increase when compared to the last bid opened in October 2006.

Bids were mailed to twelve prospective bidders with seven responding. The bid of Nardone Brothers Baking Company, Wilkes-Barre, PA did not meet legal requirements. Interflex, Wyomissing, PA responded with "No Bid." Lance Products, Incorporated, Charlotte, NC, also responded but is not recommended.

This agreement is in support of Strategy 1: We will ensure high levels of learning for all students, and Strategy 2: We will provide a positive culture for students and staff.

Student Rights and Responsibilities and Behavior Code

This year, changes were recommended by the S.M.A.R.T. Review committee, comprised of principals, assistant principals, teachers, and students. These changes have also been reviewed and approved by legal counsel. This booklet reflects those changes.

Fort Wayne Community Schools Board of School Trustees RESOLUTION OF SUPPORT FOR No Child Left Behind Improvements Act of 2007, H.R. 648 June 25, 2007

WHEREAS, on January 8, 2002, President Bush signed into law the No Child Left Behind (NCLB) Act of 2001, which applies to all school districts and schools within states that accept federal Title I dollars; and

WHEREAS, the Fort Wayne Community Schools Board of School Trustees supports the goals of NCLB of raising student achievement; closing the achievement gap; and ensuring that each child has a highly qualified teacher; and

WHEREAS, the Fort Wayne Community Schools Board of School Trustees continues to welcome the accountability for improving student and school performance; and

WHEREAS, the Fort Wayne Community Schools Board of School Trustees has had five years of operational experience in implementing NCLB; and

WHEREAS, the Fort Wayne Community Schools Board of School Trustees has identified improvements that could be made to NCLB that would eliminate barriers to full implementation of the federal law; and

WHEREAS, the National School Boards Association (NSBA) developed draft legislation based on input from local school boards across the nation that would address the concerns of local school boards, and improve the implementation of NCLB; and

WHEREAS, in April 2006 the NSBA Delegate Assembly re-affirmed its support of federal legislation that is consistent with the NSBA draft legislation, and

WHEREAS, in January 2007 Representative Don Young (R-AK) re-introduced legislation, the No Child Left Behind Improvements Act of 2007, H.R. 648, that is consistent with the NSBA draft legislation; now therefore, be it

RESOLVED, that the Fort Wayne Community Schools Board of School Trustees urges U.S. Representative Mark Souder to fully support H.R. 648 by becoming a co-sponsor of the bill, and be it further

RESOLVED, That the Fort Wayne Community Schools Board of School Trustees seeks the support of local community and civic leaders and appropriate members of the Indiana State Legislature in encouraging U.S. Representative Mark Souder to become a co-sponsor of H.R. 648, and be it finally

RESOLVED, that copies of this resolution be sent to members of the Indiana U.S. congressional delegation, the Governor, the members of Indiana's state legislature, local public governing officials, and the Superintendent of Public Instruction.

Adult and Continuing Education Federal Grants Dr. Robinson presented the following recommendation concerning the Adult and Continuing Education Federal Grants:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a Comprehensive Adult Education Program Grant and a Final Performance Grant from the Indiana Department of Education, Division of Adult Education by FWCS Adult and Continuing Education.

RELATED INFORMATION: The Comprehensive Adult Education Program Grant monies are used to support an adult education program through the purchase of materials and supplies for student use, and to pay costs for clerical support, administrative and guidance functions, and costs related to assessment and registration. This funding enables FWCS to serve over 2500 adult learners annually who are working toward high school or GED diplomas, improving basic academic skills, and/or learning English as a New Language. The Fund Year 2008 Base award in the amount of \$225,327.00 has been set aside for Region 11, comprised of Allen, Whitley, and Huntington Counties. An additional final performance grant in the amount of \$7,184.58 is based on program outcomes from FY 2007. Eligibility for the combined grants totaling \$232,512.00 is contingent on the maintenance of local effort at \$78,466.00 per year which pays for some secretarial, custodial, counseling, and administrative costs.

Dr. Bonnie Rogers, Coordinator of Continuing Education, is the contact person for these grants which address Strategy 1: We will ensure high levels of learning for all students and Strategy 4: We will function as a center of learning in the community.

A motion was made by Kevin Brown, seconded by Carol J. Coen, that the recommendation concerning the Adult and Continuing Education Federal Grants be approved. Roll Call: Ayes, unanimous; nays, none.

Title I Basic and Neglected Grant Dr. Robinson presented the following recommendation concerning the Title I Basic and Neglected Grant:

RECOMMENDATION: It is recommended that the Board approve the administration's acceptance of the Title I Basic and Neglected Grant fiscal year 2008 in the amount of \$12,096,493.06 from the Indiana Department of Education.

RELATED INFORMATION: Title I is a federally funded program designed to enable schools with high concentrations of low-income students to provide opportunities for children to acquire the knowledge and skills in the state content areas and to meet the state performance standards for all children.

Eligibility for Title I services is based on criteria related to family income. FWCS determines target areas on the basis of numbers of students receiving free and reduced lunch. For FWCS, Title I services are delivered in the following thirteen schools: Abbett, Adams, Bloomingdale, Fairfield, Maplewood, Nebraska, Northcrest, South Wayne, Scott, Study, Washington, Kekionga, and Miami.

Students living in the target areas who attend non-public schools are provided instruction through a resource teacher, an instructional assistant or a service provider. Twenty-one non-public schools also participate in the fiscal year 2008 grant. In addition, two institutions for neglected children, Spencer House and Crossroad, will receive services. Services to homeless FWCS students also fall within the Title I grant.

The grant supports advancements intended and outlined in the FWCS Strategic Plan, Strategy 1: We will ensure high levels of learning for all students; Strategy 2: We will provide a positive culture for students and staff; and Strategy 3: We will function as a professional learning community. The grant is managed by Carol Kettler, Title I Manager.

A motion was made by Jon J. Olinger, seconded by Mitch Sheppard, that the recommendation concerning the Title I Basic and Neglected Grant be approved. Roll Call: Ayes, unanimous; nays, none.

Title I Delinquent Grant Dr. Robinson presented the following recommendation concerning the Title I Delinquent Grant:

RECOMMENDATION: It is recommended that the Board approve the administration's application for and acceptance of the Title I Delinquent Grant for fiscal year 2008 in the amount of \$175,389.96 from the Indiana Department of Education.

RELATED INFORMATION: Allen County Juvenile Center receives funds through the Title I Delinquent Grant to support instruction and transitional services for clients. Instruction is designed to sustain academic growth during residency and to close the achievement gap. Both credit course work and/or tutorial services are available.

The grant addresses advancements intended and outlined in the FWCS Strategic Plan, Strategy 1: We will ensure high levels of learning for all students; Strategy 2: We will provide a positive culture for students and staff; and Strategy 3: We will function as a professional learning community. The grant is managed by Carol Kettler, Title I Manager
