Vouchers

Dr. Robinson presented the vouchers for the periods ending June 15 and June 29, 2005, with the recommendation the vouchers be approved. A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the vouchers appearing in the listings numbered 05-11 and 05-12 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Application for Common School Fund Loan Dr. Robinson presented the following recommendation concerning the Application for Common School Fund Loan:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of an advancement from the Indiana Common School Fund for educational technology equipment for 2005 in the amount of \$1,950,000.

RELATED INFORMATION: Advancements from the Common School Fund provide funds for school districts to purchase educational technology. The Fort Wayne Community Schools (FWCS) will use these moneys to help fund the FWCS technology plan previously submitted to the state. Technology funds are currently insufficient to fund all the technology needs of the school corporation.

Funds are provided as a loan and are awarded to school corporations on the basis of assessed value (AV) per pupil, with low AV per pupil school corporations receiving funds before high AV per pupil corporations. FWCS therefore cannot be assured of receiving the requested advancement.

Should the application be successful, funds will be budgeted in the Debt Service Fund to repay this loan beginning in the year 2006. Interest on the loan is expected to be no more than four percent and is likely to be as low as one percent.

Common School Fund advancements differ from School Technology Advancement Account (STAA) loans, which FWCS receives on an annual basis. Unlike CSF advancements, STAA advancements are given to all applying school corporations, regardless of their assessed value per pupil ranking.

A motion was made by Jon J. Olinger, seconded by Kurt A. Walborn, that the recommendation concerning the Application for Common School Fund Loan be approved. Roll Call: Ayes, unanimous; nays, none.

Salary Increase for FWEA Dr. Robinson presented the following recommendation concerning the Salary Increase for FWEA:

RECOMMENDATION: It is recommended that the Board approve a one and one-half percent (1.5%) salary increase for the 2005/2006 contract year for Fort Wayne Education Association (FWEA) representing teachers.

RELATED INFORMATION: On September 27, 2004, the Board ratified a three-year agreement between Fort Wayne Community Schools (FWCS) and FWEA. This contract included provisions for a salary increase to be determined by an agreed upon formula or 1.5%, whichever was greater. After completion of the formula calculations, it has been determined that 1.5% is the greater amount.

A motion was made by Robert A. Armstrong, seconded by Geoff Paddock, that the recommendation concerning the Salary Increase for FWEA be approved. Roll Call: Ayes, unanimous; nays, none.

Prices for School Meal Programs for 2005-2006 Dr. Robinson presented the following recommendation concerning the Prices for School Meal Programs for 2005-2006:

RECOMMENDATION: It is recommended that the Board approve the following meal prices effective for the 2005-2006 school year. These prices reflect no change in breakfast or lunch prices for children, and a twenty-five cent increase in breakfast price, and a forty-cent increase in lunch price for adults.

RELATED INFORMATION: From year to year, the prices of meals served by FWCS are reviewed as part of the overall year-end evaluation of the Food and Nutrition Services Department. When warranted, adjustments in meal prices are made. Annual increases in federal reimbursement allow student prices to remain unchanged. Since no reimbursement is received for adult meals, a price increase is necessary.

This agreement is in support of Strategy 1: Ensuring high levels of learning for all students; and Strategy 2: Providing a positive culture for students and staff.

A motion was made by Robert A. Armstrong, seconded by Jon J. Olinger, that the recommendation concerning the Prices for School Meal Programs for 2005-2006 be approved. Roll Call: Ayes, unanimous; nays, none.

School Nutrition Programs for 2005-2006

Dr. Robinson presented the following recommendation concerning the School Nutrition Programs for 2005-2006:

RECOMMENDATION: It is recommended that the Board approve the renewal of Fort Wayne Community Schools application with the Indiana Department of Education to continue the School Nutrition Programs for 2005-2006.

RELATED INFORMATION: Each year school districts throughout Indiana are required to renew their membership in the School Nutrition Programs. By virtue of this application with the State of Indiana, authority is given to Fort Wayne Community Schools to participate in the National School Nutrition Programs of National School Lunch/Food Distribution, School Breakfast, Summer Food Service, and Child and Adult Care Food Program. Responsibilities of Fort Wayne Community Schools and the Indiana Department of Education, Division of School and Community Nutrition Programs are outlined in the contract which remains on file in the Food and Nutrition Services office.

This agreement is in support of Strategy 1: Ensuring high levels of learning for all students; and Strategy 2: Providing a positive culture for students and staff.

A motion was made by Carl A. Johnson, seconded by Jon J. Olinger, that the recommendation concerning the School Nutrition Programs for 2005-2006 be approved. Roll Call: Ayes, unanimous; nays, none.

Bid Recommendation for Food, P/B #9225

Dr. Robinson presented the following recommendation concerning the Bid Recommendation for Food, P/B #9225:

It is further recommended that items listed below be withdrawn from the bid because of menu changes, the receipt of government commodities, or the absence of an acceptable bid.

RELATED INFORMATION: This bid is for 517 food items to be used in the school lunch program at the Food Service Center and the 11 cooking kitchens from July 25, 2005 through January 6, 2006. The bid includes such items as fruits and vegetables, meat, and staples such as flour, sugar, and salt. The specifications for this bid indicated that FWCS reserves the right to award bids such that no fewer than ten (10) items are supplied by any one vendor.

A comparison of prices by item is on file in the Purchasing Department and may be reviewed upon request.

Bids were mailed to fourteen prospective bidders with nine responding. Of these nine, Nardone Brothers Baking Company, Wilkes-Barre, PA and 21st Century Foods, Ltd., San Antonio, TX did not meet legal requirements. Interflex, Wyomissing, PA and LA Foods, Canoga Park, CA responded with "No Bid."

Overall, the prices of the recommended bidders reflect less than one percent increase when compared to the last bid opened in October 2004.

Bid Recommendation for Digital Video Recorders for School Buses, P/B #9265 Dr. Robinson presented the following recommendation concerning the Bid Recommendation for Digital Video Recorders for School Buses, P/B #9265:

RECOMMENDATION: It is recommended that an award be made to the lowest bidder meeting specifications and quality standards.

Midwest Transit Equipment of Indiana, Incorporated

RELATED INFORMATION: This bid is for the purchase of 28 Digital Video Recorders (DVRs) which will be used to record activities on school buses. When a situation with a student occurs, FWCS can remove the DVR hard drive and playback the data with viewing software that will be installed on designated FWCS computers. Currently, VHS recorders are installed in approximately 85% of our bus fleet. The DVRs are replacing VHS technology which is being discontinued by manufacturers. DVRs will be phased in to replace VHS technology as new buses are purchased or as additional funding becomes available.

Invitations to Bid were mailed to nine prospective bidders with three responding. Seon Design, Incorporated did not meet bid specifications.

Dr. Robinson presented the following recommendation concerning the Computer Replacement:

RECOMMENDATION: It is recommended that the Board approve purchasing computer equipment to replace obsolete computers from:

RELATED INFORMATION: These computers are a part of the 4-year replacement cycle for computers at the Grile Administrative Center, Anthis Career Center, Maintenance and Operations, Warehouse, and Food Service Center locations. This purchase includes desktop computers with LCD monitors/speakers, LCD monitors/speakers for laptop computers, laptop computers, and tablet laptop computers.

Since the computers are being purchase below the State of Indiana's Quality Purchase Agreement (QPA) price, no bid was required.

The computers will be purchased with Technology Capital Project Funds (CPF).

A motion was made by Robert A. Armstrong, seconded by Kurt A. Walborn, that the recommendation concerning the Computer Replacement be approved. Roll Call: Ayes, unanimous; nays, none.

North Side Audio/Visual Control System Dr. Robinson presented the following recommendation concerning the North Side Audio/Visual Control System:

RECOMMENDATION: It is recommended that the Board approve contracting with Markey's Audio Visual of Fort Wayne, IN for \$97,328 to install and configure the classroom audio/visual systems at North Side High School.

RELATED INFORMATION: On September 27, 2004, the Board approved purchasing the audio/visual control system (AVCS) from Markey's. The AVCS is a wall-mounted system which attaches the classroom DVD, VCR, teacher computer, and document camera to one LCD projector. The teacher can select which device is to be shown by the projector and control the playback function for the DVD and VCR.

When the AVCS was bid, installation was not included in the bid requirements as different configurations would need to be evaluated after the equipment arrived to find the best set-up that complies with construction code. Since Markey's was the provider of the AVCS system, both FWCS and Markey's were involved in the configuration set-up.

A public bid is not required for this contract since it is for services

A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the recommendation concerning the North Side Audio/Visual Control System be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Destiny Media Server:

Destiny Media Server

RECOMMENDATION: It is recommended that the Board approve the purchase of Follett Software Company's Destiny Library Manager software as the library management system for each school's media center.

Follett Software Mc Henry, IL \$181,184.14

RELATED INFORMATION: The collections in the FWCS Media Centers are currently catalogued and monitored by Follett software. Destiny is a web-based software program that upgrades the current system to utilize existing barcodes and provide a search function to connect to Indiana Academic Standards. Destiny is also the only software that integrates the ability to rate each book by Lexile reading level, a function that will enable both teachers and students to locate books that are beneficial for the student.

According to Indiana law, FWCS is not required to bid for the purchase of the software upgrade because compatibility is a substantial consideration in the purchase, and only one source meets the requirements of the district. Follett Software is the single source provider for Destiny Library Manager software.

A motion was made by Robert A. Armstrong, seconded by Geoff Paddock, that the recommendation concerning the Destiny Media Server be approved. Roll Call: Ayes, unanimous; nays, none.

Student Rights and Responsibilities and Behavior Code Booklet Dr. Robinson presented the following recommendation concerning the Student Rights and Responsibilities and Behavior Code Booklet:

RECOMMENDATION: It is recommended that the Board approve the 2005-2006 Student Rights and Responsibilities and Behavior Code booklet.

RELATED INFORMATION: This document, first created in 1996, was developed to assist schools in providing consistency and fairness in disciplinary matters. This year, changes were recommended by the Student Management And Resource Team (S.M.A.R.T.) review committee, comprised of principals, assistant principals, teachers, and students. These changes have also been reviewed and approved by legal counsel. This booklet reflects those changes.

A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the recommendation concerning the Student Rights and Responsibilities and Behavior Code Booklet be approved. Roll Call: Ayes, unanimous; nays, none.

Target Art in Education Grant – Bunche Elementary

Dr. Robinson presented the following recommendation concerning the Target Art in Education Grant – Bunche Elementary:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Target Art in Education Grant from the Target Foundation in the amount of \$3,000.00 for Bunche Elementary School.

RELATED INFORMATION: The objective of the grant would be to support the study of Africa that Bunche will be doing for the 2005-2006 school year. The funding would be used for assemblies, literature, family events, and an artist in residence. The study would begin to build cultural proficiency for a culture that is connected to over 25% of our school population.

This program supports advancement intended and outlined in Strategy I: We will ensure high levels of learning for all students; and Strategy II: We will provide a positive culture for students and staff.

A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the recommendation concerning the Target Art in Education Grant – Bunche Elementary be approved. Roll Call: Ayes, unanimous; nays, none.

2005 Remediation Grant Dr. Robinson presented the following recommendation concerning the 2005 Remediation Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a grant from the Indiana Department of Education for student remediation services in the amount of \$509, 355.

RELATED INFORMATION: The 1997 General Assembly made additional funds available to school corporations to remediate students who fall below state proficiency standards and for preventive remediation methods.

FWCS believes students will be best served if remediation is offered in a variety of formats and timeframes. The district is requesting \$339,570 for remediation programs to be implemented in calendar year 2005. An additional \$169,785 will be provided by the district in matching funds.

<u>Elementary School Alternative</u> - Price (grades 1 & 2) and Shambaugh (grades 3 – 5) will serve 15 to 30 high-risk students at a time. These students are from throughout the district and receive specialized educational services. They may remain in the program for up to two grading periods and receive ongoing evaluation and any needed social services. Intensive parental involvement is also a feature of this program.

<u>FWCS/Probation Department Study Table</u> - Provides three hours of supervised and tutored study time each week to juvenile offenders currently enrolled in FWCS. Additional factors used to select students for the program will include ISTEP+ scores and a history of unsatisfactory grades. Study Table helps students improve their study habits and complete homework assignments.

<u>Middle School Remediation and Prevention</u> - Students who have a grade point average below a C and/or are deficient in credits toward graduation and/or have low ISTEP+ scores will be assigned to the FOCUS program. These students will be assigned to a two hour block of classroom time each day that will focus on tutoring assistance, support for homework completion, and study/organizational skills.

Youth Life Skills Program (YLS) - Guides young adults toward achieving their GED or high school diploma.

<u>FWCS/Parks and Recreation Saturday School</u> - Saturday morning classes provide three hours of instruction and supervised study time in the areas of math and language arts which are taught by FWCS teachers and staff members of the Weisser Park Center. Students are selected using their ISTEP+ scores, history of unsatisfactory grades, as well as other indicators.

<u>Summer School</u> (Jumpstart and GQE Summer Remediation) - Current 2nd through 9th graders, who will take the ISTEP+ in the fall of 2005, will take part in a two week program session in August (August 1 - 12). They will focus on concentrated subject matter that students need in order to meet state performance standards.

This non-competitive grant written by Greg Slyford, Manager of Academic Support, supports advancements intended and outlined in the FWCS Strategic Plan, Strategy 1: We will ensue high levels of learning for all students; and Strategy 2: We will provide a positive Culture for students and staff.

RELATED INFORMATION: Title I is a federally funded program designed to enable schools with high concentrations of low-income students to provide opportunities for children to acquire the knowledge and skills in the state content areas and to meet the state performance standards for all children.

Eligibility for Title I services is based on criteria related to family income. FWCS determines target areas on the basis of numbers of students receiving free and reduced lunch. For FWCS, Title I services are delivered in the following ten schools: Abbett, Adams, Bloomingdale, Geyer, Fairfield, Nebraska, South Wayne, Scott, Study and Washington. Students living in the target areas who attend non-public schools are provided instruction through a resource teacher, an instructional assistant or a service provider. Nineteen non-public schools also participate in the fiscal year 2005 grant. In addition, two institutions for neglected children, Spencer House and Crossroad, will receive services. Services to homeless FWCS students also fall within the Title I grant.

Title I Basic and Neglected Grant The grant supports advancements intended and outlined in the FWCS Strategic Plan, Strategy 1: We will ensure high levels of learning for all students; Strategy 2: We will provide a positive Culture for students and staff; and Strategy 3: We will function as a professional learning community. The grant is managed by Carol Kettler, Title I Manager.

Title I Delinquent Grant Dr. Robinson presented the following recommendation concerning the Title I Delinquent Grant:

RECOMMENDATION: It is recommended that the Board approve the administration's application for and acceptance of the Title I Delinquent Grant for fiscal year 2006 in the amount of \$217,075 from the Indiana Department of Education.

RELATED INFORMATION: Allen County Juvenile Center receives funds through the Title I Delinquent Grant to support instruction, counseling, and transitional services for clients. Instruction is designed to sustain academic growth during residency and to close the achievement gap. Both credit course work and/or tutorial services are available.

The grant supports advancements intended and outlined in the FWCS Strategic Plan, Strategy 1: We will ensure high levels of learning for all students; Strategy 2: We will provide a positive Culture for students and staff; and Strategy 3: We will function as a professional learning community. The grant is managed by Carol Kettler, Title I Manager.

Alternative Education Grant for 2005-2006 Dr. Robinson presented the following recommendation concerning the Alternative Education Grant for 2005-2006:

RELATED INFORMATION: Funding for the grant is based on the number of full-time equivalent (FTE) students enrolled in the following programs: Allen County Juvenile Justice Center, Expectant Mothers Program at Anthis, L.C. Ward Education Center, Focus, and Youth Life Skills.

Last year the district received \$226,682.50 based on the FTE students in the previous mentioned programs. We have been advised by the Indiana Department of Education that alternative education funds continue under the 15 percent reduction imposed as part of the Governor's Deficit Management Plan. This reduction, combined with the large number of students participating in alternative education programs, caused our 2004 allocation to be \$550.00 per full-time equivalent student. We anticipate a similar situation this year.

Dr. Charles Green, director of Civic and Community Relations, is responsible for this non-competitive grant which supports Strategy 1: We will ensure high levels of learning for all students; and Strategy 2: We will provide a positive culture for students and staff.

Geyer Middle School Conversion Dr. Robinson presented the following recommendation concerning the Geyer Middle School Conversion:

RECOMMENDATION: It is recommended that the Board authorize the Superintendent to close Geyer as a traditional middle school and to convert the current Bunche and Geyer sites into Montessori magnet facilities that will provide instruction for grades pre-K through 8 effective with the 2006-2007 school year.

RELATED INFORMATION: Geyer Middle School receives Title I funding because of its high poverty rate and is subject to sanctions under No Child Left Behind. Although Geyer has made steady progress in raising student achievement, it has not made Adequate Yearly Progress for four years and is in year three of School Improvement. The district has already provided students the option to transfer to another school and has provided supplemental services to support student achievement. The recommendation to close the school as it is currently structured removes the Title I designation and allows the district to offer a more viable program in the south side area of the city.

The district currently operates a successful pre-K to grade 5 Montessori program at Bunche Elementary and a middle school Montessori program at Kekionga. The program has consistently had a waiting list and demonstrated high achievement. Moving the middle school program and portions of the elementary program to the former Geyer facility will allow the program to expand significantly. Planning and preparation will take place through the 2005-2006 school year and the full program using the Bunche and former Geyer sites will open for the 2006-2007 school year.

A motion was made by Jon J. Olinger, seconded by Stephen Corona, that the recommendation concerning the Geyer Middle School Conversion be approved. Roll Call: Ayes, unanimous; nays, none.
