Application for Common School Fund Loan Dr. Robinson presented the following recommendation concerning the Application for Common School Fund Loan:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of an advancement from the Indiana Common School Fund for educational technology equipment for 2006 in the amount of \$1,950,000.

RELATED INFORMATION: Advancements from the Common School Fund provide funds for school districts to purchase educational technology. The Fort Wayne Community Schools (FWCS) will use these moneys to help fund the FWCS technology plan previously submitted to the state. Technology funds are currently insufficient to fund all the technology needs of the school corporation.

Funds are provided as a loan and are awarded to school corporations on the basis of assessed value (AV) per pupil, with low AV per pupil school corporations receiving funds before high AV per pupil corporations. FWCS therefore cannot be assured of receiving the requested advancement.

Should the application be successful, funds will be budgeted in the Debt Service Fund to repay this loan beginning in the year 2008. Interest on the loan is expected to be no more than four percent and is likely to be as low as one percent.

Common School Fund advancements differ from School Technology Advancement Account (STAA) loans, which FWCS receives on an annual basis. Unlike CSF advancements, STAA advancements are given to all applying school corporations, regardless of their assessed value per pupil ranking.

RELATED INFORMATION: This bid is for the purchase of three used 2005 14-passenger Special Purpose Buses for the Anthis Career Education Construction Trades Department. The buses will replace three box trucks that are currently used to transport Construction Trades students to their job sites. Pending State legislation will make it illegal for a person to ride in the back of a vehicle not designed for passengers, thus negating the use of the box trucks. The buses are needed to ensure the safe transportation of FWCS students.

The Transportation Department assisted in reviewing the bid proposals to make certain the buses meet all State, Federal, and FWCS school bus requirements. All three buses are the same year, make, and model with approximately 12,000 miles on each of them. Funding for this purchase will be from the Anthis Career Education Center Capital Equipment Fund.

Olin B. and Desta Schwab Foundation Grants Dr. Robinson presented the following recommendation concerning the Olin B. and Desta Schwab Foundation Grants:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of grants in the amount of \$181,207.00 from the Olin B. and Desta Schwab Foundation for the 2006-07 school year.

RELATED INFORMATION: The Area 14 Vocational Education Office, located at the Anthis Career Center, administers career development programs for the benefit of all middle and high school students in Allen County, Columbia City, and Churubusco. Fort Wayne Community Schools will serve as the fiscal agent for this competitive grant, written by Area Vocational Coordinator Ron Flickenger.

The grants support career development activities for middle and high school students. Funds will pay for middle school students to explore career options and to identify their learning style preferences. Funds also enable high school students, including those at the Allen County Juvenile Facility, to participate in detailed career planning activities in their schools as part of their total educational program. Services for secondary students will be provided at the school sites, through the Allen County Public Library system, and in cooperation with Junior Achievement and the National Center for College Costs.

Adult and Continuing Education Federal Grants Dr. Robinson presented the following recommendation concerning the Adult and Continuing Education Federal Grants:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a Comprehensive Adult Education Program Grant and a Final Performance Grant from the Indiana Department of Education, Division of Adult Education by FWCS Adult and Continuing Education.

RELATED INFORMATION: The Comprehensive Adult Education Program Grant monies are used to support an adult education program through the purchase of materials and supplies for student use, and to pay costs for clerical support, administrative and guidance functions, and costs related to assessment and registration. This funding enables FWCS to serve over 2500 adult learners annually who are working toward GED certificates, improving their basic academic skills, and/or English as a Second Language. The Fund Year 2007 Base award in the amount of \$225,327.00 has been set aside for Region 11, comprised of Allen, Whitley, and Huntington Counties. An additional grant in the amount of \$3,210.00 is based on the outcomes for FY 2006. Eligibility for the combined grants totaling \$228,537.00 is contingent on the maintenance of the current level of local effort at \$70,967.00 per year which pays for some secretarial, custodial, counseling, and administrative costs.

James Davis, Manager of Continuing Education is the contact person for these grants. These grants address advancements intended and outlined in the FWCS Strategic Plan adopted by the Board of Trustees.
