Park Center Case Managers for Elementary Emotional Disabilities Program Mr. Cammack presented the following recommendation concerning Park Center Case Managers for Elementary Emotional Disabilities Program.

RECOMMENDATION: It is recommended that the Board approve the contract to provide case managers in our elementary programs for students with emotional disabilities for \$195,000.

RELATED INFORMATION: Since the inception of our elementary Emotional Disabilities (ED) Programs in the 2011-12 school year, we have been able to consistently increase the number of ED students remaining in their assigned schools. A review of the 2017-2018 data shows that 98% of the students remained in their buildings, a decrease from the previous school year by 1%. This contract with Park Center provides each of our ED elementary programs a case manager during the school day to support FWCS staff with students' behavioral needs.

The program's funding is being supported by Medicaid and Federal Grant 611 Part B and will be overseen by Nikki Sprunger, Director of Special Education.

This program supports District Goal I: Achieve and Maintain Academic Excellence
