Removal of items from Consent Agenda Members absent: none

Board member Kevin Brown requested that the following recommendations be removed from the consent agenda: Personnel Report and the Extracurricular Account Equipment Purchases for 2009.

Consent Agenda Chief Academic Officer Steve Cobb, sitting in for Superintendent Wendy Robinson, presented the following consent agenda items with recommendations for approval: Minutes from the regular Board meeting of June 28, 2010; vouchers for the periods ending July 12, 2010 and July 26, 2010; School Technology Advancement Account Application; Report of 2009 Gifts, Grants, and Donations; Bid Recommendation for Milk, P/B #BD100330; ASUS Netbooks, 2011 Board Meeting Schedule and 2010-2011 Carl D. Perkins Grant.

Minutes The minutes from the regular Board meeting of June 28, 2010, were distributed to Board members for review with a recommendation for approval.

Vouchers for the Periods Ending July 12, 2010 and July 26, 2010. **RECOMMENDATION:** It is recommended that the Board approve the vouchers for the periods ending July 12, 2010 and July 26, 2010.

RELATED INFORMATION: All vouchers paid by the Fort Wayne Community Schools appear on a voucher listing. The voucher listing for the first meeting of the month includes the payroll and fixed charges for the previous month.

The vouchers for the period ending July 12, 2010 have been paid based on the Board's prior authorization. The Board is now requested to ratify those vouchers. In addition, the vouchers for the period ending July 26, 2010 are before the Board for approval.

Detail of all invoices paid remains on file in the Business Office until audited by the State Board of Accounts. Following the audit, vouchers are placed in storage for not less than seven (7) years following payment.

School Technology Advancement Account Application **RECOMMENDATION:** It is recommended that the Board approve the application for and the receipt of an advancement from the School Technology Advancement Account in the amount of \$631,000 for the 2010-2011 school year.

RELATED INFORMATION: The School Technology Advancement Account provides funds annually for school systems to purchase computer technology for student instruction. The Fort Wayne Community Schools uses these moneys to fund learning and technology plans of schools.

The request of \$631,000 is based on a guideline provided by the state of \$500 for each 25 students. Funds are provided in the form of a loan with a very low interest rate. The last loan under this program had an interest rate of 1 percent. Funds would be budgeted in the Debt Service Fund to repay this loan beginning in 2012.

RECOMMENDATION: It is recommended that an award be made to the responsible and responsive bidder meeting specifications, quality standards and complete dairy service. The bid is awarded based on the seven categories of half-pint containers which include whole, 2% white, 1% white, skim, 1% chocolate, 1% strawberry and 1% vanilla.

Prairie Farms Dairy, Fort Wayne, IN \$1,074,506.33

RELATED INFORMATION: Half-pints of milk, estimated at 5 1/2 million annually, represent about 90% of total dairy purchases for 63 locations, including our schools and 13 private schools. Other dairy items such as yogurt, cottage cheese, and larger units of milk will also be provided and are in addition to the price above. The bid is for a one-year contract with the option to renew. During the year, the price fluctuates as allowed in the contract. The price change is based on the United States Department of Agriculture's monthly increase or decrease of the cost per hundred weight of Class I skim milk and Class I butterfat to FWCS suppliers.

Invitations to Bid were mailed to four prospective bidders with one providing a bid. Schenkel's All Star Dairy, Huntington, IN responded with "No Bid". Alfred L. Plew, Decatur, IN and Smith Dairy, Richmond, IN did not submit a bid.

The price per half-pint in this bid is approximately 13.8 percent lower when compared to the current contract pricing.

ASUS
Netbooks

RECOMMENDATION: It is recommended that the Board approve the purchase of 613 ASUS Netbooks in the amount of \$257,821.67.

RELATED INFORMATION: Netbooks will be used in the administration of the DIBELS assessment for all K-3 students. We are moving to the use of Netbooks as a replacement for the Palm Pilots, which are no longer being produced.

Funding for this purchase will be from Common School Funds, Title 1, and the Reading First Grant.

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Carl D. Perkins grant for \$852,831.00 for the 2010-2011 school year.

RELATED INFORMATION: This is the third year of a five year grant, of the new legislation for Career and Technical Education that is commonly called “Perkins IV”, but is formally known as the Carl D. Perkins Career and Technical Education Act of 2006 (Public Law 109-270).

The Area 14 Vocational Education Office, located at the Anthis Career Center, administers the Perkins Funds for the benefit of over 8,000 career and technical education students in Allen and eastern Whitley County (Churubusco & Columbia City). FWCS is the fiscal agent for these funds and there is no requirement to match the grant with local funds.
