3Rivers Sponsorship and Naming Agreement for the Union Venture Studio Dr. Daniel presented the following recommendation concerning the 3Rivers Sponsorship and Naming Agreement for the Union Venture Studio:

**RECOMMENDATION:** It was recommended that the Board approve the Sponsorship and Naming Agreement with Three Rivers Federal Credit Union (3Rivers).

**RELATED INFORMATION:** In preparation for the grand opening of the Amp Lab at Electric Works, FWCS began soliciting the sponsorship of local companies in exchange for exclusive naming rights to one of four educational studios. This Agreement represents the first time FWCS has offered naming rights to a commercial entity in the history of the District.

Under the terms of the Agreement, the Venture Lab will be named the 3Rivers Federal Credit Union Venture Studio for five years, in exchange for a financial sponsorship of \$625,000.

Philanthropy Director, Mitch Sheppard and Amp Lab's Riley Johnson were available to answer any questions.

Parkview Behavioral Health Case Workers for Elementary Behavior Support Classrooms Dr. Daniel presented the following recommendation concerning the Parkview Behavioral Health Case Workers for Elementary Behavior Support Classrooms:

**RECOMMENDATION:** It was recommended that the Board approve the contract with Parkview Behavioral Health for the 2022-23 school year to provide 12 behavioral case workers in our elementary behavioral support programs for \$180,000.

**RELATED INFORMATION:** The contract with Parkview Behavioral Health provides each of our elementary behavior support classrooms a case worker during the school day to support FWCS staff with students' behavioral needs in these 12 classrooms. The case workers support social emotional skills development and assist students with transitioning into the general education environment. This contract will support FWCS students and staff in all 12 of the behavior support classrooms during the school day.

The program's funding is being supported by Medicaid and Federal Grant 611 Part B and will be overseen by Dr. Nikki Sprunger, Assistant Superintendent of Diverse Learners.

Jennifer Berning, Compliance Specialist and Ben Hartman, Price Elementary Principal were available to answer questions.

A motion was made by Julie Hollingsworth, seconded by Jennifer Matthias, that the recommendation concerning the Parkview Behavioral Health Case Workers for Elementary Behavior Support Classrooms be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Daniel presented the following recommendation concerning the Adult Education Grant:

Adult Education Grant

**RECOMMENDATION:** It was recommended that the Board approve the Indiana Department of Workforce Development's 2022-23 Adult Education Grant in the amount of \$981,013.

**RELATED INFORMATION:** This grant fund is in third year of a competitive multi-grant that runs four program years from July 1, 2020 through June 30, 2024. These funds will be designated for personnel, professional development, instructional materials, supplies, equipment, purchased services, integrated educational and training, and the Workforce Education Initiative including workforce certification programming for local Allen County business and industry. The Adult Education Grant funds includes: \$727,003 for Adult Basic Education; \$243,610 for both Integrated Education and

Training Programs and Workforce Education Initiatives; \$6,900 for High School Equivalency testing, and \$3,500 for a Professional Development facilitator stipend.

The grant was written by retired Manager of Continuing Education Programs, Patrick Boles. The new manager, Lonnie Heck, was available to answer questions.

No Kid Hungry School Nutrition Grant Dr. Daniel presented the following recommendation concerning the No Kid Hungry School Nutrition Grant:

**RECOMMENDATION:** It was recommended that the Board approve the acceptance of the No Kid Hungry School Nutrition Grant from Share Our Strength in the amount of \$20,000 for the 2022-23 school year.

**RELATED INFORMATION:** The No Kid Hungry School Nutrition Grant provides funding to school districts to maximize child nutrition programs and other emergency food programs. The grant will be used to help purchase an industrial slicer that can section and slice up to 90 pieces of fruit or vegetable per minute. This will assist FWCS Nutrition Services in serving more fresh fruits and vegetables throughout our programs and to begin utilizing more local produce in our Farm to School program.

This competitive grant was written by Becky Larson, Director of Nutrition Services, and she was available to answer questions.

A motion was made by Jennifer Matthias, seconded by Maria Norman, that the recommendation concerning the No Kid Hungry School Nutrition Grant be approved. Roll Call: Ayes, unanimous; nays, none.

School Technology Advancement Account (STAA) Application Amendment Dr. Daniel presented the following recommendation concerning the School Technology Advancement Account (STAA) Application Amendment:

**RECOMMENDATION:** It was recommended that the Board approve an amendment to the application for and the receipt of advancement from the School Technology Advancement Account (STAA).

**RELATED INFORMATION:** The School Technology Advancement Account provides funds annually for school systems to purchase computer technology for student instruction. The Fort Wayne Community Schools uses these moneys to fund learning and technology plans of schools.

The Board approved an application for \$552,260 at the June 27 Board meeting. This was based on the February 1, 2022 enrollment. The STAA application instead requires the October 1, 2021 enrollment. This results in an increase of \$7,920 for an amended application for \$560,180.

The application also asks, if there are remaining STAA funds available, would we like to be considered for additional funds. We also seek up to an additional \$94,320 to purchase additional Chromebooks if funding is available.

Kathy Friend, Chief Financial Officer, was available to answer questions.

A motion was made by Maria Norman, seconded by Steve Corona, that the recommendation concerning the School Technology Advancement Account (STAA) Application Amendment be approved. Roll Call: Ayes, unanimous; nays, none.

#### Comments

Board Member Steve Corona spoke about his recent participation with IDOE's Dr. Katie Jenner and and Chris Lowery from Higher Education commission where they discussed the 21st Century Scholar program, which currently has a lot of red tape on who can benefit from this program. It his Mr. Corona's hope that there could be auto enrollment in the future. Member Corona also spoke about Latinos Count working with middle school students and earning trust with FWCS, which Shenita Bolton is assisting with as well. Planting the seed in elementary that college is an option, but there are multiple pathways. Mr. Corona also spoke about the significant announcement of the partnership with 3Rivers Federal Credit Union. It is a testimony that our Superintendent is doing what he said he would do by engaging the business community. In order to move Fort Wayne forward, we need to work with one another.

Board Member Julie Hollingsworth promoted the long-awaited Open House at Amp Lab on August 2. She is excited to see the 3Rivers Venture Studio. Member Hollingsworth spoke about Nikki Kelly's Capital Chronicle, which highlights things going on in Indiana, the recent article discussed the \$6 billion state surplus, and the lack of imagination in giving \$1 billion back to Hoosiers. Ms. Hollingworth encouraged some different thinking on how to spend the surplus: public school textbook fees be paid, another, expansion of PreK, or fully funding SpEd, ELL, maternal health, and childcare. She'd like to see the Senate come up with some ideas besides another refund.

Board Member Jennifer Matthias commented that it has been great seeing families out and about over the summer. Member Mathias thanked teachers who have been working throughout the summer by taking advantage of learning about new FWCS initiatives. She supports them.

Board Member Noah Smith, has communicated with Ball State's Michael Hicks, who comments on Twitter regarding fiscal affairs. Hick's has commented that "We are well below average and getting worse in Indiana by not funding education." Member Smith echoes Steve and Julie's comments. Proud of the 4% pay increase last year and this upcoming year, but we are still behind other states. Need to get in front of legislators to properly fund education.

Superintendent Dr. Mark Daniel commented that on August 8 all 4,000 employees will be gathering at the TinCaps for the Back to School Event. Dr. Yolanda Sealey-Ruiz will be speaking on Diversity,

Equity and Inclusion, along with GFW's John Urbahns. Staff have gone above and beyond this summer. We had over 500 elementary and SpEd teachers participated in Orton-Gillingham training and over 1,000 students were tutored. Dr. Daniel also thanked grounds keepers for the work they have done over the summer. The Superintendent looks forward to August 10 and the start of the school year.

Board President Anne Duff saw in this morning's Journal Gazette, that high school students can write an essay on the sense of belonging in a classroom, where you want a culture to succeed. The top three will earn cash prizes. President Duff also encouraged volunteering with Study Connection's one hour after school tutoring or Big Brothers Big Sisters Lunch Buddy program. Both are in desperate need for volunteers.
