Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

SkillsUSA National Leadership Recognition **RECOMMENDATION**: It is recommended that the Board recognize Anthis Career Center students who participated at the SkillsUSA National Leadership Conference.

RELATED INFORMATION: At the SkillsUSA National Leadership Conference, students compete in hands-on events challenging their expertise in occupations such as robotics, computer programming, precision machining, medical assisting and culinary arts. Contests are run with the help of industry, trade associations and labor organizations. Nine Anthis students were among the 5,400 individuals in 91 contests at the June 22-26 event in Kansas City, Missouri. The students attending the conference were among the top 2% skilled in the nation and had to work their way through a series of local, regional and state competitions to participate in the national conference. 2009 Dolly Parton Chasing Rainbows Award

RECOMMENDATION: It is recommended that the Board recognize the Snider High School teacher who won the 2009 Dolly Parton Chasing Rainbows Award.

RELATED INFORMATION: The National State Teachers of the Year (NSTOY) presented the first Chasing Rainbows Award to Dolly Parton in 2002 in recognition of her love of children and desire that all children across the country have books in their homes, become better readers and expand their imaginations. Since then, NSTOY has selected one teacher annually to receive the Chasing Rainbows Teacher of the Year Award. The award is given to a teacher who overcame obstacles to become an exemplary teacher. Snider High School science teacher Francis Mustapha, who won this year's award, was born in Medina, a small village in Sierra Leone, West Africa. His pursuit of education led him to the United States, where he studied biology at Indiana Wesleyan University and education at Indiana University. He has been with FWCS since 1983 and in his current position since 1996. He was the FWCS Teacher of the Year in 1994, when he went on to become a National Teacher of the Year finalist.

As the Chasing Rainbows recipient, Mr. Mustapha and his wife spent a weekend in Dollywood in Pigeon Forge, Tennessee and met Dolly Parton. A plaque with his name was added to a sculpture that stands in the showcase window of Dolly Parton's Chasing Rainbows Museum.

Removal of items from Consent Agenda Becky Hill asked that two agenda items be removed from the consent agenda: the Personnel Report and Project Lead the Way recommendation.

Consent Agenda Dr. Robinson presented the following items on the consent agenda with the recommendation for approval: Minutes of the regular Board meeting of June 22, 2009; vouchers covering the periods ending July 13, 2009 and July 27, 2009; Cash Management Services; Temporary Inter-fund Loan; 2010 Board Meeting Schedule; 2009-2010 Special Education Grants; and Adult and Continuing Education Federal Grants.

Approval of Minutes

The minutes from the regular Board meeting of June 22, 2009, were distributed to Board members for review.

Vouchers

RECOMMENDATION: It is recommended that the Board approve the vouchers for the periods ending July 13, 2009 and July 27, 2009.

RELATED INFORMATION: All vouchers paid by the Fort Wayne Community Schools appear on a voucher listing. The voucher listing for the first meeting of the month includes the payroll and fixed charges for the previous month.

The vouchers for the period ending July 13, 2009 have been paid based on the Board's prior authorization. The Board is now requested to ratify those vouchers. In addition, the vouchers for the period ending July 27, 2009 are before the Board for approval.

Detail of all invoices paid remains on file in the Business Office until audited by the State Board of Accounts. Following the audit, vouchers are placed in storage for not less than seven (7) years following payment.

Cash Management Services

RECOMMENDATION: It is recommended that the Board approve National City Bank as the cash management services provider to Fort Wayne Community Schools for the period October, 2009 to September, 2011.

RELATED INFORMATION: Under the provisions of I.C. 5-13-11, school corporations are permitted to enter into a written cash management agreement with a local bank for a two year period. Such an agreement allows bank employees to invest school corporation funds at mutually agreed upon rates. The agreement requires the bank to provide reconciliation services and all banking records as required by the State Board of Accounts. Any full service bank on the state's official depository list is eligible to submit a cash management system as long as the system meets or exceeds Fort Wayne Community Schools specifications.

Requests for proposals were mailed to fourteen banks with twelve responding. Bank of America submitted a "no bid." National City provided the best proposal when considering estimated interest earnings net of fees.

Temporary Inter-fund Loan **RECOMMENDATION**: It is recommended that the Board approve all inter-fund loans necessary to eliminate deficits in certain funds of the corporation as of June 30, 2009.

RELATED INFORMATION: Cash deficits in funds of the corporation are not allowed at the end of a fiscal year. Several funds have deficits due to a delay in the distribution of property taxes from Allen County. The General Fund deficit as of June 30 is due to normal timing differences between revenue and expenditures. State statute allows temporary transfers between funds if certain requirements are met. The treasurer will make all necessary transfers and report the loans to the Board.

2009-2010 Special Education Grants **RECOMMENDATION**: It is recommended that the Board approve the application for and acceptance of special education grants from the Indiana Department of Education for the school year 2009-2010.

RELATED INFORMATION: Individuals with Disabilities Education Act, IDEA 2004, requires that after the base payment allocations are provided, additional funding is awarded to each district based on public and private school enrollment within the local school jurisdiction and according to the number of children living in poverty (National School Lunch Act participants). Funds are used to support salaries and fringes of approximately 145 staff members. These non-competitive grants are in addition to the basic special education grant.

For FWCS, Part B of the special education grant amount for the 2009-2010 school year is \$8,256,503, an increase of \$431,228 from last year. The preschool special education grant is \$288,756, an increase of \$1,910.

The grant supports District Goal I: *Achieving and Maintaining Academic Excellence* and is managed by Theresa Oberley, Special Education Director.

Adult and Continuing

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of a Comprehensive Adult Education Program Grant, Final Performance Grant, and Incentive Grant from the Department of Education, Division of Adult Education by FWCS Adult and Continuing Education.

RELATED INFORMATION: The Comprehensive Adult Education Program Grant monies are used to support adult education programs, paying for materials for student use, classroom assistants, clerical support, administrative and guidance functions, and costs related to assessment and registration. This funding enables FWCS to serve over 2500 adult learners annually who are working toward high school or GED diplomas, improving basic academic skills, and/or are English Language Learners. The Fund Year 2010 base award of \$225,327.00 has been set aside for Region 11; comprised of Allen, Whitley and Huntington Counties. An additional final performance grant for \$1,852.00 is based on previously unpaid program outcomes from PY 2009.

Eligibility for the combined grants is contingent on the maintenance of local effort at \$78,478.00 per year, which pays in part secretarial, custodial, counseling, and administrative costs.

Dr. Bonnie Rogers, Manager of Continuing Education, is the contact person for these grants that address advancements intended and outlined in FWCS District Goal I: *Achieve and Maintain Academic Excellence*.

Project Lead the Way – Biomedical Sciences – Snider High School Dr. Robinson presented the following recommendation concerning the Project Lead the Way – Biomedical Sciences – Snider High School:

RECOMMENDATION: It is recommended that the Board approve Project Lead the Way Biomedical Sciences program at Snider High School. Funding comes from the Perkins Grant and Smaller Learning Communities Grant.

RELATED INFORMATION: Project Lead the Way is a nationally recognized program that will provide students the opportunity to pursue interest in Biomedical Sciences through exploration of career opportunities, internships, and hands-on learning. This program will prompt students to earn dual credits at IPFW and Ivy Tech, and will better prepare them to select a career in the field of medical sciences or other advanced degrees and certifications. It will meet the academic standards of the State of Indiana in mathematics, science, technology education and English language arts. The course has been aligned with the prescribed standards in all four areas.

Project Lead the Way will provide students with a skill base that meets the diverse needs of students at Snider High School and the pre-medical sciences background needed to successfully complete collegiate programs in the medical sciences. Parkview Hospital, Lutheran Hospital, IPFW, and Ivy Tech are community partners.

This is a standard application process necessary to utilize the curriculum and training provided by Project Lead the Way and supports District Goal I: *Achieve and Maintain Academic Excellence*.
