Approval of
Minutes –

Dr. Robinson presented the following recommendation concerning the Scott Academy Underground Storage Tank Removal:

RECOMMENDATION: It is recommended that the Board approve a contract to provide professional environmental consultation and field services with respect to underground fuel oil storage tank removal at Scott Academy.

SES Environmental\$56,000

It is further recommended that the Board declare that an emergency exists at Scott Academy and that \$56,000 from the emergency account in the Capital Projects Fund be allocated for the payment of items related to the removal of the abandoned underground storage tank and repairs to the damaged storm sewer.

RELATED INFORMATION: It was recently discovered that the underground fuel oil storage tank at Scott Academy is showing evidence of leaking. The storm sewer that drains the pit area around the underground fuel oil storage tank has also partially failed. A blockage in the line has caused the contaminated tank water to rise to the surface and contaminate sections of the soil west of the playground. Therefore, we must remove the tank, repair the storm sewer line, remove the contaminated soil, and remediate the area. The closure assessment will be conducted in accordance with Indiana Department of Environmental Management (IDEM) underground storage tank (UST) guidelines.

Storm sewer repairs and the removal of the underground storage tank and contaminated soil and water has begun as mandated by IDEM to stop further storm sewer contamination.

This project uses the remaining balance of the 2008 CPF emergency allocation, originally set at \$600,000.
