School Technology Advancement Account Application

Dr. Robinson presented the following recommendation concerning the School Technology Advancement Account Application:

RECOMMENDATION: It is recommended that the Board approve the application for and the receipt of an advancement from the School Technology Advancement Account in the amount of \$631,000 for the 2005-2006 school year.

RELATED INFORMATION: The School Technology Advancement Account provides funds annually for school systems to purchase computer technology for student instruction. The Fort Wayne Community Schools uses these moneys to fund learning and technology plans of schools.

The request of \$631,000 is based on a guideline provided by the state of \$500 for each 25 students. Funds are provided in the form of a loan with a very low interest rate. The last loan under this program had an interest rate of 1 percent. Funds would be budgeted in the Debt Service Fund to repay this loan beginning in 2007

Dr. Robinson presented the following recommendation concerning the Snider High School – Field Trip to Cozumel, Playa Del Carmen/Calica:

RECOMMENDATION: It is recommended that the Board approve the field trip request for Snider High School's Jazz Choir to perform on a cruise ship during Spring Break, 2006.

RELATED INFORMATION: Approximately 20 students will perform on the main stage for guests of the Carnival cruise ship, Festival At Sea. Students will have the opportunity to see and experience the Mayan culture/history, and experience performing for a diverse audience. This trip will give students a behind-the-scenes glimpse of the life-style of performers aboard a cruise line and provide them a chance to meet and talk with other performers on the ship.

Perkins
Grant

Dr. Robinson presented the following recommendation concerning the Perkins Grant:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Carl D. Perkins grant in the amount of \$881,990.00 for the 2005-06 school year. This is the 7th installment of a five-year grant from the Federal Department of Education under the Carl D. Perkins Vocational and Technical Education Act of 1998.

RELATED INFORMATION: The Area 14 Vocational Education Office, located at the Anthis Career Center, administers the Perkins funds for the benefit of over 7,000 vocational education students in Allen County, Columbia City, and Churubusco. FWCS is the fiscal agent for these funds and there is no requirement to match the grant with local funds.

The funding supports programs, services, and activities under the follow categories:

- Adult Continuing Education (apprenticeship classes and Youth Life Skills)
- Counseling and guidance services for area vocational education students
- Basic occupational and academic skills for special needs students
- Employment and training services for special populations
- Expansion and improvement of existing career and technical education programs
- Integrating occupational and academic education
- Providing transitional services and occupational skills development for handicapped students
- Supporting professional development associated with vocational education

This non-competitive grant written by Ron Flickinger, Area Vocational Coordinator, supports advancement intended and outlined in the FWCS Strategic Plan.

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of the Title III: Language Instruction for Limited English Proficient and Immigrant Students for 2005-2006 in the amount of \$304,486.00 from the Division of Language Minority and Migrant Programs of the Indiana Department of Education.

RELATED INFORMATION: Funds from this grant will allow for the continuation of a range of services for the district's English as a Second Language (ESL) students including evaluation, instruction, interpretation, translation, coordination and monitoring. The Title III grant is allocated based on the number of limited English proficient (LEP) students in Fort Wayne Community Schools.

This non-competitive grant written by Greg Slyford, manager of Academic Support, supports advancement intended and outlined in the FWCS Strategic Plan, Strategy 1: *We will ensure high levels of learning for all students*, and Strategy 3: *We will function as a professional learning community*
