Roll Call

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, August 9, 2004, at 7:02 p.m. President Carol J. Coen called the meeting to order with the following members in attendance:

Approval of Minutes – July 26, 2004

A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the minutes of the regular meeting of the Board of School Trustees held July 26, 2004, be approved. Roll Call: Ayes, unanimous; nays, none.

Vouchers

Dr. Robinson, superintendent, presented the vouchers for the period ending July 28, 2004, with the recommendation the vouchers be approved. A motion was made by Stephen Corona, seconded by Jon J. Olinger, that the vouchers appearing in the listing numbered 04-14 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Fees:

Fees

RECOMMENDATION: It is recommended that the Board approve the following fees:

Non-sufficient funds (NSF) fee \$10 Collection fee \$15

RELATED INFORMATION: Currently NSF fees are charged by schools when a check is returned from the bank for insufficient funds. Fees have been determined by schools. This will allow us to have one consistent fee across the district.

We currently do not assess a fee when a textbook rental invoice is unpaid and goes to our collection agency. The agency charges us 30 percent for regular collections and 40 percent for legal collections. By setting a collection fee of \$15 we are trying to recover some of this cost and to encourage parents to pay before it gets to that process.

A motion was made by Geoff Paddock, seconded by Carl A. Johnson, that the recommendation concerning the Fees be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the School Switch Upgrades:

School Switch Upgrades

RECOMMENDATION: It is recommended that the Board approve purchasing 75 CISCO 2950 Network Switches from IBM for the amount of \$235,260.

RELATED INFORMATION: This purchase replaces the remaining 10mg shared hubs with 10/100mg switches and standardizes all FWCS network switches to CISCO equipment. Due to the high

bandwidth capabilities of the Comcast Network scheduled to be completed for all buildings this fall, the 10mg switches need replaced since they cannot process the communication traffic at sufficient speeds. The standardization will greatly improve our ability to deploy sophisticated network applications such as video streaming and video conferencing. These switches are the internal switches used in each school's Main Distribution Facility (MDF) and Intermediate Distribution Facilities (IDF).

The switches will be purchased with Common School Fund (CSF) monies and was a part of the budget developed for these funds. According to Indiana law, FWCS is not required to bid the switches because they are able to purchase through Indiana's Quantity Purchasing Agreement (QPA # CFTASZL) with IBM.

A motion was made by Carl A. Johnson, seconded by Jon J. Olinger, that the recommendation concerning the School Switch Upgrades be approved. Roll Call: Ayes, unanimous; nays, none.

Teamsters Agreement

Dr. Robinson presented the following recommendation concerning the Teamsters Agreement:

RECOMMENDATION: It is recommended that the Board ratify revisions to the collective bargaining agreement covering Work Year Provisions and Pre and Post Trip Inspections for Fort Wayne Community Schools Bus Drivers represented by Teamsters Local 414.

RELATED INFORMATION: Fort Wayne Community Schools and bus drivers represented by Teamsters Local 414 reached an agreement on Work Year Provisions and Pre and Post Trip inspections of the current 2003-2005 contract. A summary is as follows:
