Report on Board Member Becky Hill provided highlights of gifts to FWCS from the Fort Wayne Community. Charitable Target is a faithful community partner and contributor. She suggested signing up for the “Take Charge Contributions of Education” program at Target.com which gives a percentage of each purchase at Target to schools. Ms. Hill also commented about the Feed the Children organization that provides food for homeless children; the PTA, Parkview, Kroger, Sodexo, local churches and Raytheon to name a few. We thank these organizations for their commitment to the children of this community. Ms. Hill encouraged people to give to schools and wanted that giving to start with Board members. Board member Jordan Lebamoff offered a \$2,500 donation if Ms. Hill could find 10 people to match that contribution.

Dr. Robinson presented the following recommendation concerning the Park Center Case Managers for Elementary Emotional Disabilities Programs:

RECOMMENDATION: It is recommended that the Board approve the contract to provide case managers in our elementary programs for students with emotional disabilities for the amount of \$180,000.

RELATED INFORMATION: In school year 2011-12 the Park Center Program was developed and implemented to reduce the need to place students with emotional disabilities in programs outside of their school setting. The program also allows students with emotional disabilities to have more support in the least restrictive environments. The following elementary buildings have implemented the program for K-5 students with emotional disabilities: St. Joseph Central, South Wayne, Price, and Nebraska. Haley has implemented the program for grades 3-5. For the 2015-16 school year, we have expanded the program from eleven classrooms to twelve. Since school year 2011-12, the Park Center Program has reduced the need to access outside alternative placement for students with emotional disabilities by 89%. The case managers will have the following duties:

- Provide social skills group
- Keep accurate records of the daily services provided
- Observe students and assist teacher with the collection of data
- Assist with de-escalating behaviors and processes with students to return to the educational setting which allows the teacher to continue to provide instruction
- Assist in transitioning students from services in the special education setting to services in the general education setting.

The program's funding is being supported by Medicaid and Federal Grant 611 Part B.

The grant supports District Goal I: *Achieving and Maintaining Academic Excellence* and is managed by Ann Barnes-Smith.

Questions will be answered by the Director of Special Education, Ann Barnes-Smith.
