Change in Agenda

A motion was made by Mitch Sheppard, seconded by Jon J. Olinger, that the Board meeting agenda be changed to move item VII – Public Comments, after item IV – Awards and Recognition. Roll Call: Ayes, unanimous; nays, none.

Approval of Minutes – July 23, 2007 A motion was made by Kevin Brown, seconded by Jon J. Olinger, that the minutes of the regular meeting of the Board of School Trustees held July 23, 2007, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson, superintendent, presented the following information and recommendations concerning awards and recognitions:

SkillsUSA National Leadership Conference Winners

RECOMMENDATION: It is recommended that the Board recognize Anthis Career Center students who participated at the SkillsUSA National Leadership Conference.

RELATED INFORMATION: At the SkillsUSA National Leadership Conference, students compete in hands-on events challenging their expertise in occupations such as robotics, computer programming, precision machining, medical assisting and culinary arts. Contests are run with the help of industry, trade associations and labor organizations. Ten Anthis students were among 4,500 who participated in the event June 25-30 in Kansas City. The students attending the conference were among the top 2% skilled in the nation and had to work their way through a series of local, regional and state competitions.

ISSMA All-Music Award – Snider High School **RECOMMENDATION**: It is recommended that the Board recognize the band at Snider High School for receiving the Indiana State School Music Association All-Music Award for 2006-07.

RELATED INFORMATION: The Indiana State School Music Association (ISSMA) Award is designed to recognize well-rounded school music programs. To qualify for this award, schools must earn a gold rating at the District Marching Contest, qualify at least one soloist and one ensemble for the state Solo and Ensemble Contest, earn a gold rating at the ISSMA Jazz Contest and earn a gold rating at the ISSMA Organization Contest. The Snider High School Band was selected for the 2006-07 honor and will be presented with a special banner to display in recognition of their achievement.

Speakers

Mr. Dave Lambert from the Fort Wayne Peace Action Coalition spoke to the Board about his hope that the schools would not bring military recruiters into the buildings to recruit students. He would like schools to be sure that students and their families are aware of their right to "opt out" of having their student's name and contact information given to the military for recruitment.

Mr. Charles Garnetto spoke to the Board about recognizing the assets available to the district from the people supporting the blue side of the recent remonstrance against the building project.

Bus drivers Yvonne Myers, Robert Schlensker, and Jim Hansel spoke to the Board about their desire for the administration to bring the Teamsters contract to the Board for ratification. Brian Lytle and Walt Lytle, representing the Teamsters Local 414 also would like the contract they brought to their membership for ratification to be brought before the Board for approval.

Vouchers

Dr. Robinson presented the vouchers for the period ending August 1, 2007, with the recommendation the vouchers be approved. A motion was made by Kevin Brown, seconded by Carol J. Coen, that the vouchers appearing in the listing numbered 07-15 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Bid Recommendation for Milk, P/B #9660:

Bid Recommendation for Milk, P/B #9660

RECOMMENDATION: It is recommended that an award be made to the lowest responsible and responsive bidder meeting specifications, quality standards, and complete dairy service:

Prairie Farms Dairy, Fort Wayne, IN \$1,016,130.93

RELATED INFORMATION: About 90% of the bid is for approximately 5 1/2 million half-pints of milk to 65 locations annually, including our schools and thirteen private schools. The specifications also include other dairy items such as yogurt, cottage cheese, and larger units of milk. The bid is for a one-year contract with the option to extend. During the year, the price fluctuates as allowed in the contract. The price change is permitted based on the United States Department of Agriculture's monthly increase or decrease of the cost per hundred weight of Class I skim milk to FWCS suppliers.

Invitations to Bid were mailed to four prospective bidders with two providing a bid. Smith Dairy, Richmond, IN responded with "No Bid" and Alfred L. Plew, Incorporated, Decatur, IN did not respond.

The price per half-pint in this bid is approximately seventeen percent lower when compared to the current contract pricing.

A motion was made by Carol J. Coen, seconded by Jon J. Olinger, that the recommendation concerning the Bid Recommendation for Milk, P/B #9660 be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Robinson presented the following recommendation concerning the Student Accident Insurance:

Student Accident Insurance

RECOMMENDATION: It is recommended that the Board modify Board Policy 8760. The modification would require the Superintendent to obtain group student accident insurance at the expense of the district.

RELATED INFORMATION: Students participating in athletic programs in middle and senior high schools are currently required to pay Board approved rates for athletic insurance obtained by the district. The cost of the group policy is \$149,319 for 2007-2008.

In past years, parents were given the opportunity to buy supplementary student insurance through a private company approved by the Board. For an additional expense of \$13,053 in 2007-2008, the district acquired school-time coverage for all students. At registration, parents were given information on how to obtain full-time and extended dental coverage for non-school time coverage.

Board Policy 8760 (New language is in bold):

The School Board recognizes the need for insurance coverage for injuries to students caused by accidents occurring in the course of attendance at school and participation in the athletic programs of the schools. Therefore, at the beginning of each school year, the Board shall offer parents the opportunity to participate in group accident insurance at the expense of the parents. Therefore, the Superintendent shall obtain group student accident insurance at the expense of the district.

Purchase of such insurance shall be required as a condition of participation in athletic programs. The Superintendent shall recommend suitable and qualified insurance carriers and notify all parents of its availability.

Discussion

Board member Kevin Brown suggested that the policy wording be changed to add "extra curricular activities" because elementary schools do not have "athletic programs." Board policy states that any changes to the wording of Board policy needs to be in writing and reviewed by Board members 24-hours before a vote on the change. After discussion, Board members decided to approve this Board recommendation as presented and bring the change in the wording to the next Board meeting scheduled for August 27, 2007, for approval.

A motion was made by Kevin Brown, seconded by Pamela Martin-Diaz, that the recommendation concerning the Student Accident Insurance be approved. Roll Call: Ayes, Kevin Brown, Carol J. Coen, Pamela Martin-Diaz, Mitch Sheppard, Jon J. Olinger and Steve Corona; nays, Mark GiaQuinta.

Retro Pay for Bus Drivers Dr. Robinson presented the following recommendation concerning the Retro Pay for Bus Drivers:

RECOMMENDATION: It is recommended that the Board approve a one percent (1%) salary increase effective January 1, 2006, for bus drivers covered by the Master Contract with the Teamsters Local Union 414. This salary increase will be applicable only to current employees and does not apply to the 50 cent lift certification premium.

RELATED INFORMATION: This salary increase does not represent a final settlement of a new contract with the Teamsters. Contract negotiations are ongoing and will hopefully be complete in short order. The district wishes to give a portion of the expected salary increase now recognizing the length of time that drivers have endured since their contract expired in January of 2005.

A motion was made by Jon J. Olinger, seconded by Kevin Brown, that the recommendation concerning the Retro Pay for Bus Drivers be approved. Roll Call: Ayes, unanimous; nays, none.

Wal★Mart Good Work Grants – Northwood Middle School

Dr. Robinson presented the following recommendation concerning the Wal★Mart Good Work Grants – Northwood Middle School:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of five Wal★Mart Good Work grants from the Wal-Mart Foundation totaling in the amount of \$5,000 (\$1,000 per grant) for Northwood Middle School.

RELATED INFORMATION: The objective of these grant requests are to reward students for their attendance, discipline, and participation in the Northwood Middle School Writing Idol Program; to provide before and after school tutoring; to encourage and reward teachers for improving student achievement; and to provide for needy families with some assistance during the holiday season. The contact person for these non-competitive grants is Gayle Harris, administrative assistant, at Northwood Middle School.

This program supports advancement intended and outlined in Strategy 2 – We will provide a positive culture for students and staff

The National Football Foundation and College Hall of Fame, Inc., Academic Coach Grant – Wayne High School

Dr. Robinson presented the following recommendation concerning The National Football Foundation and College Hall of Fame, Inc., Academic Coach Grant – Wayne High School:

RECOMMENDATION: It is recommended that the Board approve the acceptance of a grant in the amount of \$16,000 from the National Football Foundation and College Hall of Fame, Inc., Academic Coach for Wayne High School.

RELATED INFORMATION: Wayne High School has been awarded an Academic Coach grant for the 2007-2008 academic year to be used to compensate Academic Coach(es) for duties associated with the "Play It Smart" Program. This program assists students academically as they prepare for their post-secondary intentions in a college, the military, or in employment.

Dustin Butcher, Academic Coach, is the writer of this competitive grant, and Joselyn Whitticker is the principal. This grant addresses advancement intended and outlined in Strategy 2: *We will provide a positive culture for students and staff.*

A motion was made by Jon J. Olinger, seconded by Mitch Sheppard, that the recommendation concerning The National Football Foundation and College Hall of Fame, Inc., Academic Coach Grant – Wayne High School be approved. Roll Call: Ayes, unanimous; nays, none.
