Park Center Case Managers for Elementary Emotional Disabilities

Program

Dr. Robinson presented the following recommendation concerning the Park Center Case Managers for Elementary Emotional Disabilities Program:

**RECOMMENDATION**: It is recommended that the Board approve the contract with Park Center to provide case managers in our elementary schools with programs for students with emotional disabilities at a cost of \$195,000.

**RELATED INFORMATION**: Since the inception of our elementary Emotional Disabilities (ED) Programs in the 2011-12 school year, we have been able to consistently increase the number of ED students remaining in their assigned schools. In the 2016-17 school year 99% of elementary ED students remained in their buildings, exceeding the previous school year by 2%. This contract with Park Center provides each of our ED elementary programs a case manager during the school day to support FWCS staff with students' behavioral needs.

The program's funding is being supported by Medicaid and Federal Grant 611 Part B and will be overseen by Nikki Sprunger, Director of Special Education.

This program supports District Goal I: Achieve and Maintain Academic Excellence

This non-competitive grant written by Emily Schwartz Keirns, ELL manager, supports advancement intended and outlined in FWCS District Goal I: *Achieve and Maintain Academic Excellence* and Goal II: *Engage Parents and the Community*.

#### Discovery Education Contract

Dr. Robinson presented the following recommendation concerning the Discovery Education Contract:

**RECOMMENDATION**: It is recommended that the Board approve a three-year contract with *Discovery Education* in the amount of \$266,000 for professional learning services and the development of STEM curriculum and framework for Irwin Math and Science Magnet School.

**RELATED INFORMATION**: *Discovery Education* will provide professional learning, educational resources and digital content related to Science, Technology, Engineering and Math (STEM). The three-year contract will include:

- Year 1: Visioning and building the foundations for STEM
- Year 2: Building a Foundation for Project-Based Learning
- Year 3: Transdisciplinary Teaching for vertical articulation among all grade levels and integrative instruction across content areas.

Irwin administrator and teachers will understand STEM education with regard to inquiry-driven and standards-based instruction. Job embedded coaching will engage teachers in creative and problem-solving lesson designs that will increase students' exposure to STEM careers. Students will learn through active participation in project-based learning that proposes solutions to real world problems and immersion in 21st Century Skills as outlined in the FWCS Vision for Learning. Parents will participate in Community Transformation Nights that will inform them about STEM education and careers.

This program supports FWCS District Goal 1: *Achieve and Maintain Academic Excellence* and Goal 2: *Engage Parents and the Community*.

# Cash Management Services

Dr. Robinson presented the following recommendation concerning the Cash Management Services:

**RECOMMENDATION**: It is recommended that the Board approve Lake City Bank as the cash management services provider to Fort Wayne Community Schools for the period September 2017 through August 2019.

**RELATED INFORMATION**: Under the provisions of I.C. 5-13-11, school corporations are permitted to enter into a written cash management agreement with a local bank for a two-year period. Such an agreement allows bank employees to invest school corporation funds at mutually agreed upon rates. The agreement requires the bank to provide reconciliation services and all banking records as required by the State Board of Accounts. Any full service bank on the state's official depository list is eligible to submit a cash management system as long as the system meets or exceeds Fort Wayne Community Schools' specifications.

Requests for proposals were mailed to 17 banks with eight responding. Salin Bank submitted a "no bid." Lake City Bank provided the best proposal when considering estimated interest earnings net of fees.

#### Disposal of Elmhurst

Dr. Robinson presented the following recommendation concerning the Disposal of Elmhurst

**RECOMMENDATION**: It is recommended that the Board authorize the sale of the former site of Elmhurst High School to Hanson Aggregates Midwest LLC for a purchase price of \$600,000.00.

**RELATED INFORMATION**: On February 13, 2017, this Board authorized the disposal of real estate consisting of the former Elmhurst School and surrounding property. At that meeting, the Board authorized the District to dispose of the real estate by broker, under IC 36-1-11-4(g). Subsequently, the property was listed for sale and offers were accepted through July 13, 2017. Having received and reviewed those offers, the District advises that the real estate be sold to the highest responsive offer, Hanson Aggregates Midwest LLC.

This Board Recommendation moves the process of disposing Elmhurst forward. Because this Board used the broker process to dispose of the real estate, details about the other offers received will be made publicly available after closing.

The grounds cover 23.07 acres and include 12.252 of vacant farmland to the west. Elmhurst has been vacant since it closed at the end of the 2009-10 academic school year due to consolidation and building-site conditions.

Dr. Robinson shared that we intend to educate and prepare students to watch the solar eclipse scheduled August 21, safely. Dr. Robinson commented that a local minister told her his church prayed for FWCS. She urged parents to help children understand that all people are valuable. Dr. Robinson said that we try to teach students to be good citizens and we ask parents help with that.

Board President Julie Hollingsworth commented on the need for all of us to talk with each other – we can't let hate divide us. We need to educate our children that it is wrong to treat people differently because of who they are, what they look like or who they love.
