RECOMMENDATION: It is recommended that the Board recognize Susan Brace for her service to the children of Indiana in her role as a member of the State Board of Education.

RELATED INFORMATION: Since 2000 when Gov. Frank O'Bannon appointed her to the State Board of Education, Jefferson Middle School teacher Susan Brace has been a strong voice for urban school districts. Her six years on the Board have been both challenging and exciting, she says. Chief among the duties the Board undertook during her tenure included drafting the state accountability criteria that became Public Law 221. Indiana was ahead of the nation in this legislation, but not long after it was adopted, the 10-member Board had to take on the daunting task of blending P.L. 221 to be compatible with the then new No Child Left Behind mandates. Mrs. Brace said she is proud to have been a member of the Board during these difficult, transitional times. Her professionalism, wisdom and student-centered focus will continue to have a positive influence on the children of this state.

Mrs. Brace was honored for her hard work and dedication to children in serving the last six years as a member of the State Board of Education.

School
Technology
Advancement
Account
Application

Dr. Robinson presented the following recommendation concerning the School Technology Advancement Account Application:

RECOMMENDATION: It is recommended that the Board approve the application for and the receipt of an advancement from the School Technology Advancement Account in the amount of \$632,000 for the 2006-2007 school year.

RELATED INFORMATION: The School Technology Advancement Account provides funds annually for school systems to purchase computer technology for student instruction. The Fort Wayne Community Schools uses these moneys to fund learning and technology plans of schools.

The request of \$632,000 is based on a guideline provided by the state of \$500 for each 25 students. Funds are provided in the form of a loan with a very low interest rate. The last loan under this program had an interest rate of 1 percent. Funds would be budgeted in the Debt Service Fund to repay this loan beginning in 2008

Dr. Robinson presented the following recommendation concerning the Bid Recommendation for Uniforms and Miscellaneous Items, P/B # 9625:

RECOMMENDATION: It is recommended that an award be made to the lowest responsible and responsive bidder meeting specifications:

RELATED INFORMATION: The bid is for a two-year contract, with an option to extend for a period not longer than the original contract term. The bid was performed under a cooperative purchasing agreement with the City of Fort Wayne. The bid is for rental garments for the custodians, mechanics, and other personnel for whom FWCS furnishes uniforms by contractual agreement. As an option for FWCS employees, the bid included polo style shirts as an alternative to the current traditional style shirts. The bid also includes walk-off mats, shop towels, and dust mops.

Invitations to Bid were mailed to five prospective bidders with two responding. The bids were reviewed in detail by the Maintenance & Operations Department and the Purchasing Department. The prices of the recommended bidder reflect a nineteen percent decrease when compared to the last bid opened in November 2002.

Based on an earlier survey, it is estimated that 150 employees will choose the polo shirt over the traditional shirt. The total bid cost could vary slightly based on final employee shirt selection.

RECOMMENDATION: It is recommended that the Board reappoint Kevin Roe to a three-year term on the Board of Directors of the Indiana Cooperative Library Services Authority.

RELATED INFORMATION: Fort Wayne Community Schools has had a representative on the Board of Indiana Cooperative Library Services Authority (INCOLSA) for several years. INCOLSA is a public nonprofit statewide cooperative library network that provides information and resource sharing among Indiana libraries of all types. Kevin Roe, Supervisor of Media Processing, is currently serving a term which expired June 30, 2006. The reappointment will be effective July 1, 2006 through June 30, 2009.

School
Wellness
Policy

Dr. Robinson presented the following recommendation concerning the School Wellness Policy:

RECOMMENDATION: It is recommended that the Board adopt the attached School Wellness Policy that addresses the requirements of federal and state laws.

RELATED INFORMATION: The United States Congress, in an effort to have schools play a key role in addressing the problem of childhood obesity, has passed a law requiring school districts that receive federal school meal funds to establish a local "Wellness Policy." Section 204 of the Child Nutrition and WIC Reauthorization Act of 2004, details the minimum requirements. These requirements include goals for nutrition education, physical activities and other school-based activities to promote student wellness. The requirements further address the USDA guidelines for reimbursable meals and include a plan for measuring the implementation of the wellness policy.

The Fort Wayne Community Schools Wellness Policy Committee includes representation from the foodservice staff, administration, the Board of School Trustees, and the public. The committee continues to meet to finalize guidelines for the implementation of the policy. The policy will be shared with administrators and school staff when complete.

2006-2007
Special
Education
Grants

Dr. Robinson presented the following recommendation concerning the 2006-2007 Special Education Grants:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of special education grants in the amount of \$8,355,837 from the Indiana Department of Education for the school year 2006-2007.

RELATED INFORMATION: These non-competitive grants offset a portion of the cost of special education services provided by Fort Wayne Community Schools. The reauthorized PL 108-446,

IDEIA, 2004 requires that after the base payment allocations are made, additional funding is awarded to each district based on public and private school enrollment within the FWCS jurisdiction and number of children living in poverty as defined by the National School Lunch Act.

For 2006-2007, FWCS receives a base payment amount of \$7,532,701.00 under PL 108-446, Part B. FWCS receives additional preschool special education funding in the amount of \$293,136.00 under PL108-446, section 619. These funds support salaries and fringes benefits of approximately one hundred fifty employees.

A Discretionary Grant from the Division of Exceptional Learners Discretionary Grant is awarded to Fort Wayne Community Schools in the amount of \$530,000.00. Funds are used to support salaries and fringe benefits for the K-2 Project in ten schools.

These funds are used in support of FWCS Strategy 1: *We will insure high levels of learning for all students.*
