RELATED INFORMATION: Anthem acts as a third party administrator (TPA) for the FWCS Group Health Plan providing our employees with access to broad-based PPO providers and network discounts. In addition, they manage claims processing services; all aspects of the provider network; perform utilization and medical management functions; enrollment support; and customer service for our employees. The renewal rate increases the district's fixed fees, which include administrative fees for medical, dental and vision as well as reinsurance premiums, by 10.2% or about \$237,000. Fixed fees are approximately 4.9% of the total expected cost of the health plan.
