Roll Call

The Board of School Trustees of the Fort Wayne Community Schools met in regular session in the Lester L. Grile Administrative Center on Monday, August 25, 2003, at 7:09 p.m. President Stephen Corona called the meeting to order with the following members in attendance:

Approval of Minutes – August 11, 2003

A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the minutes of the regular meeting of the Board of School Trustees held August 11, 2003, be approved. Roll Call: Ayes, unanimous; nays, none.

Dr. Wendy Robinson , superintendent, presented the following information and recommendations concerning awards and recognitions:

Pacesetter Award - Steve Brace

RECOMMENDATION: It is recommended that the Board recognize Steve Brace, president of the Fort Wayne Education Association, for receiving the prestigious Pacesetter Award from the Indiana State Teachers Association in July.

RELATED INFORMATION: Steve Brace received the Pacesetter Award at a luncheon during the annual ISTA Summer Leadership Conference. The award recognizes outstanding examples of courage, commitment, innovation or dedication in advancing the status of education in Indiana. Award winners are nominated by members of the United Education Profession and local associations affiliated with the National Education Association.

As this year's winner, Mr. Brace received an exclusive pin, a trophy and will be recognized in association publications.

Mr. Brace has been an FWCS teacher for 34 years. He was elected FWEA president in 1998.

First Day of School

Fort Wayne Community Schools welcomed back more than 32,000 students on Monday, August 18, 2003, to begin another successful school year. A video was shown highlighting some of the memorable moments of the first day of school.

Vouchers

Dr. Robinson presented the vouchers for the period ending August 11, 2003, with the recommendation the vouchers be approved. A motion was made by Jon J. Olinger, seconded by Robert A. Armstrong, that the vouchers appearing in the listing numbered 03-16 be approved without exception. Roll Call: Ayes, unanimous; nays, none.

Public Hearing on the 2004 Budgets and Capital Projects Plan Dr. Robinson presented the following recommendation concerning the Public Hearing on the 2004 Budgets and Capital Projects Plan:

A public budget presentation was made at the August 11, 2003, regular Board of School Trustees meeting. All seven tax-rated funds and proposed budgets were discussed, and estimated tax rates were reviewed. The budgets were advertised on August 12 and August 19, 2003. The hearing on the seven tax-rated fund budgets is scheduled for this evening's meeting of the Board of School Trustees.

The intent of the hearing is to allow Board members the opportunity to receive community input and to consider the Capital Projects Plan. Board members will be asked to vote on the budgets and the Capital Projects Plan on September 8, 2003. Kathy Friend, chief financial officer, was available to answer questions.

This was the appropriate time for members of the public to address the Board regarding the year 2004 budgets and the Capital Projects Plan.

Guest

The hearing was held and one person spoke, Barbara Sain, on behalf of air conditioning in the schools.

Public Hearing on the 2004-2013 School Bus Replacement Plan Dr. Robinson presented the following recommendation concerning the Public Hearing on the 2004-2013 School Bus Replacement Plan:

According to Indiana Code 21-2-11.5-3.1, effective July 1, 1995, the school corporation must conduct a public hearing on a ten-year bus replacement plan before the governing body may collect property taxes for the school transportation fund's school bus replacement account. The Bus Replacement Plan was advertised on August 12 and August 19, 2003. The hearing on the Bus Replacement Plan is scheduled for this evening's meeting of the Board of School Trustees. Board members will be asked to vote on the plan on September 8, 2003.

The intent of this hearing is to allow Board members the opportunity to receive community input and to consider the Bus Replacement Plan. This was the appropriate time for members of the public to address the Board regarding the Bus Replacement Plan.

The hearing was held and there were no comments from the public.

Application for Common School Fund Loan Dr. Robinson presented the following recommendation concerning the Application for Common School Fund Loan:

RECOMMENDATION: It is recommended that the Board approve the application for and acceptance of an advancement from the Indiana Common School Fund for educational technology equipment for 2003 in the amount of \$1,950,000.

RELATED INFORMATION: Advancements from the Common School Fund provide funds for school districts to purchase educational technology. The Fort Wayne Community Schools (FWCS) will use these moneys to help fund the FWCS technology plan previously submitted to the state. Technology funds are currently insufficient to fund all the technology needs of the school corporation.

Funds are provided as a loan and are awarded to school corporations on the basis of assessed value (AV) per pupil, with low AV per pupil school corporations receiving funds before high AV per pupil corporations. FWCS therefore cannot be assured of receiving the requested advancement.

Should the application be successful, funds will be budgeted in the Debt Service Fund to repay this loan beginning in the year 2005. Interest on the loan is expected to be no more than four percent and is likely to be as low as one percent.

Common School Fund advancements differ from School Technology Advancement Account (STAA) loans, which FWCS receives on an annual basis. Unlike CSF advancements, STAA advancements are given to all applying school corporations, regardless of their assessed value per pupil ranking.

A motion was made by Carol J. Coen, seconded by Geoff Paddock, that the recommendation concerning the Application for Common School Fund Loan be approved. Roll Call: Ayes, unanimous; nays, none.

Pre-Tax Voluntary Employee Contributions to ISTR/PERF Dr. Robinson presented the following recommendation concerning the Pre-Tax Voluntary Employee Contributions to ISTR/PERF:

RECOMMENDATION: It is recommended that the Board approve the resolutions permitting employee participation in a voluntary pre-tax contribution to an individual annuity account at Indiana State Teachers' Retirement Fund (ISTRF) or Public Employees Retirement Fund (PERF).

RELATED INFORMATION: Since 2001, eligible Fort Wayne Community Schools' employees have had the opportunity to contribute <u>post</u>-tax dollars to their individual annuity retirement accounts at ISTRF or PERF. Beginning in September 2003, qualifying members will be able to make <u>pre</u>-tax contributions to these accounts based upon a recent IRS ruling.

Before such pre-tax contributions can begin, employers must adopt a standard resolution permitting employee participation in this option. The resolutions, based upon IRS requirements, have been provided by ISTRF and PERF.

These voluntary contributions will be available in addition to the mandatory 3% contributed to an individual account by FWCS on the employee's behalf.

A motion was made by Jon J. Olinger, seconded by Kurt A. Walborn, that the recommendation concerning the Pre-Tax Voluntary Employee Contributions to ISTR/PERF be approved. Roll Call: Ayes, unanimous; nays, none.

Renewal of Insurance Policies Dr. Robinson presented the following recommendation concerning the Renewal of Insurance Policies:

RECOMMENDATION: It is recommended that insurance coverage for property, commercial general liability, inland marine, foreign package, business automobile, commercial umbrella liability, law enforcement professional liability, school leaders errors and omissions, and boiler and machinery be awarded through our agent Acordia Insurance to five underwriting carriers at a cost of \$1,520,970.

RELATED INFORMATION: FWCS and other commercial insurance buyers have experienced skyrocketing insurance premiums during the last four years. FWCS premiums have more than tripled since 1999 and deductibles have increased as well. Although the hard market continues, this renewal finally indicates a break in the trend for FWCS. Premiums decreased 14% overall. The commercial package and business automobile coverage will remain with the Indiana Insurance Company. Indiana Insurance insures 86 percent of the school corporations in Indiana and provides the best alternative among a limited number of carriers. They not only offer programs which afford the necessary coverage to address the exposures of a public school corporation, but provide the claims administration and risk management services to support their customers.

A motion was made by Robert A. Armstrong, seconded by Carol J. Coen, that the recommendation concerning the Renewal of Insurance Policies be approved. Roll Call: Ayes, unanimous; nays, none.

RELATED INFORMATION: Wood Youth Center and the Juvenile Residential Facility receive funds through the Title I Delinquent Grant to support instruction, counseling, and transitional services for clients. Instruction is designed to sustain academic growth during residency and to close the achievement gap. Both credit course work and/or tutorial services are available.
