Renewal of Insurance Policies Dr. Robinson presented the following recommendation concerning the Renewal of Insurance Policies:

RECOMMENDATION: It is recommended that insurance coverage for property, commercial general liability, inland marine, business automobile, commercial umbrella liability, law enforcement professional liability, school leaders errors and omissions, and boiler and machinery be awarded through USI Insurance Services to two underwriting carriers for a premium of \$1,114,009.

RELATED INFORMATION: The Boiler Explosion/Equipment Breakdown policy will be underwritten by The Cincinnati Insurance Company. Wright Risk Management will remain our insurance company for all other policies and Markel Insurance Company will be the underwriter. Total premiums increased \$44,305 or about 4% with this renewal effective September 1, 2018.

Short and Long-Term Disability Renewal Dr. Robinson presented the following recommendation concerning the Short and Long-Term Disability Renewal:

RECOMMENDATION: It is recommended that the Board approve Cigna's proposed renewal offer for the February 1, 2019 renewal, which would extend the rates currently in force on the Short-Term Disability ("STD") and Long-Term Disability ("LTD") plans through January 31, 2020.

RELATED INFORMATION: Cigna's current in-force rates became effective February 1, 2017 and were initially guaranteed for two years, until the February 1, 2019 renewal. The STD rate is \$0.178 per \$10 of weekly benefit for the STD plan. The LTD plan rates are \$0.09 per \$100 of covered payroll, and the district-sponsored LTD rate is \$0.265 per \$100 of covered payroll covering teachers, administrators, and supervisory employees. Hylant has negotiated a one-year rate extension with CIGNA, holding the current in-force rates through January 31, 2020.

Cigna is a leading global health services company with a strong presence in the disability market. They are A rated with A.M. Best. Cigna has been Fort Wayne Community Schools' STD and LTD carrier since February 2013.

This agreement may be extended beyond January 31, 2020, subject to the agreement of the vendor, provided there are no additional price increase adjustments or changes to the terms of the contract.

This supports FWCS District Goal III: Operate Effectively with Integrity and Fiscal Responsibility.

2018-19 Special Education Grants

Dr. Robinson presented the following recommendation concerning the 2018-19 Special Education Grants:

RECOMMENDATION: It is recommended that the Board approve the acceptance of Special Education Grants from the Indiana Department of Education for the 2018-19 school year.

RELATED INFORMATION: The Individuals with Disabilities Education Act, IDEA 2004, requires that after the base payment allocations are provided, additional funding is awarded to each district based on public and private school enrollments within the local school jurisdiction and according to the number of children living in poverty (National School Lunch Act participants). Funds are used to support salaries and fringe benefits for approximately 126 staff members. These non-competitive grants are in addition to the Special Education Foundation payment.

For FWCS, the Part B Special Education Grant amount for the 2018-19 school year is \$8,766,085.00, an increase of \$269,808.00 from last year. The Preschool Special Education Grant is \$303,071.00, an increase of \$9,737.00 from last year.

These grants are managed by Dr. Nikki Sprunger, Director of Special Education and are in support of District Goal I: *Achieve and Maintain Academic Excellence*.

Formative Assessment Grant Dr. Robinson presented the following recommendation concerning the Formative Assessment Grant:
